Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Benchmark Bank Employees 401(k) Plan and Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Benchmark Bank Employees 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document in effect for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Benchmark Bank (“the Company”) except for those employees covered by a collective bargaining agreement. Eligible employees may enter the Plan on the first day of employment. The Plan was adopted effective March 12, 1991 and was restated effective January 1, 2017. The Plan was most recently amended effective June 1, 2019 to adopt an automatic salary deferral provision. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by a Plan Administrator and overseen by the Company’s 401(k) Committee that reports to the Board of Directors.

Contributions

Participants may contribute up to the maximum of their pretax annual compensation allowed by law, subject to certain maximum limitations imposed by the Internal Revenue Code (“the Code”), as defined in the Plan. Participants may elect to make Pre-Tax 401(k) deferrals or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants who are eligible to make salary deferral contributions under the Plan and have attained age 50 before the close of the plan year may make catch-up contributions in accordance with, and subject to the maximum limitation imposed by the Code.

The Company may make a discretionary employer matching contribution to the Plan as determined annually by its Board of Directors. Participants must be: (1) employed on the last day of the year and have completed 1,000 hours of service during the year; or (2) deceased, retired, or suffered disability during such year to be eligible to receive discretionary employer matching contributions. During 2024, the Company made an employer matching contribution of up to a maximum of 4% of each participant’s eligible compensation for each dollar contributed by a participant. During 2024, employer matching contribution net of forfeitures was \$747,845.

The Plan includes an automatic salary deferral feature whereby the Company automatically withholds 2% of a participant’s compensation each payroll period and contributes the amount to the Plan as a Pre-Tax 401(k) deferral. A participant may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer any amount in accordance with the deferral procedures of the Plan. The election will generally remain in effect until a participant’s salary deferrals are automatically suspended under the terms of the Plan or a participant modifies or terminates the election.

Vesting

Participants are always 100% vested in their salary deferrals and rollover contributions plus earnings or losses thereon. Vesting in the Company contributions portion of accounts plus actual earnings or losses thereon is based on years of vesting service according to the following vesting schedule:

Less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 years or more	100%

In the event of disability, early retirement, or death, the participant will become fully vested.

Forfeited Accounts

Forfeited non-vested account balances may be used to pay Plan expenses, employer matching contribution, or non-elective contributions. During 2024 and 2023, total additions to forfeited non-vested accounts was \$64,209 and \$63,503, respectively. During 2024 and 2023, the Plan used \$60,780 and \$63,455, respectively, in forfeitures to reduce employer matching contribution. At December 31, 2024 and 2023, the Plan's forfeited non-vested accounts balances totaled \$3,986 and \$557, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contribution; (b) Plan earnings; and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options

Participants may direct the investment of their contributions and the allocation of Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants. The Plan's Qualified Default Investment Alternative ("QDIA") for those participants, including beneficiaries, who have not provided investment directions is one of the Commerce Street Peak Advisors Core Model portfolio funds.

Payments of Benefits

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of rollovers, lump sum payments, or in-service withdrawal. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited. To comply with certain requirements of the SECURE Act and IRS regulations, the Plan requires participants to take their first required minimum distribution (RMDs) in the year they reach age 73.

A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) payment of medical expenses; (2) down payment for the purchase of a principal residence; (3) payment of tuition for post-secondary education; (4) to prevent eviction, from, or foreclosure on a primary residence; (5) burial or funeral expenses for a deceased parent, spouse, child, or dependent; and (6) expenses for repair of damage to principal residence that would qualify as deductible casualty losses. To comply with certain requirements of the SECURE Act and IRS regulations, the Plan relaxed the substantiation rule, and the six-month elective deferrals suspension rule for hardship distributions.

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, Plan expenses may be paid out of the Plan, unless paid by the Company.

2. Summary of Significant Accounting Policies

Date of Management's Review

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through July 30, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for discussion of fair value measurements.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net appreciation in the fair value of investments consists of the realized gains and losses on investments bought and sold as well as held during the year and unrealized appreciation (depreciation) of investments. The net change in unrealized appreciation (depreciation) in the fair value of investments is determined by the change in fair value from the beginning of the year to the end of the year or change in fair value from date of the purchase to the end of the year.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividend income is accrued and recorded on the ex-dividend date.

Payments of Benefit

Benefits are recorded when paid.

3. Information Certified by Trustee

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Ascensus, LLC, the contract administrator of the Plan as agent of Ascensus Trust Company, the trustee of the Plan.

4. Fair Value Measurements

ASC Topic 820, *Fair Value Measurements and Disclosures* establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three broad levels of the fair value hierarchy are as follows:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1).
- Level 3 inputs consist of unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs are not available. All Plan assets for the periods presented required the use of Level 1 inputs. There were no changes in the valuation methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Money market funds - The money market fund is valued using pricing models maximizing the use of observable inputs for similar securities. Although a money market fund seeks to preserve the value of \$1 of investment at \$1 per share (unit), it is possible to lose money by investing in such a fund.

Mutual funds - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are actively traded.

The Company's 401(k) Committee determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

5. Related Party and Party-in-Interest Transactions

Certain plan investments are shares or units of money market funds and mutual funds managed by Ascensus Trust Company (ATC) as agent for Ascensus, LLC, the Plan Trustee as defined by the Plan. Newport Group, Inc as agent for Ascensus, LLC is the record keeper of the Plan. Therefore, ATC, Ascensus, LLC, and Newport Group, Inc. are parties-in-interest under ERISA and transactions with these entities qualify as party-in-interest transactions. During 2024, the Plan paid \$21,362 in record keeping and trustee fees to Ascensus, LLC and Newport Group, Inc. These fees have been included in Administrative expenses on the accompanying financial statements.

Beacon Pointe Advisors Company (“PBAC”) is the Plan’s investments advisor as defined by the Plan. Therefore, BPAC is a party-in-interest and transactions with BPAC qualify as party-in-interest transactions. During 2024, the Plan paid a total of \$53,372 to BPAC in fees for investment advisory services. These fees are included in Investment advisory fees within the Investment Income caption in the accompanying financial statements.

Payne & Smith, LLC is the Plan’s independent public accountant (IPA) as defined by the Plan. Therefore, the IPA is a party-in-interest under ERISA and transactions with the IPA qualify as party-in-interest transactions. Fees incurred by the Plan for audit and nonattest services provided by the IPA are absorbed fully by the Company and are not disclosed, not included, and not accrued in the accompanying financial statements.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Tax Status

The Plan sponsor is an adopter of a pre-approved plan that received a favorable Internal Revenue Service (“IRS”) Opinion Letter dated June 30, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended and restated since receiving the Opinion Letter, the Plan Administrator believes this Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

While there is no intention to do so, the Company reserves the right to terminate the Plan. In the event of termination of the Plan, the participants become fully vested in their employer contribution balances, and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
