Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Teton Science School 403(B) DC Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

(1) DESCRIPTION OF THE PLAN

The following description of the Teton Science School 403(B) DC Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all full-time employees of Teton Science School (the Company). The Plan, sponsored by the Company, was adopted on July 1, 1994 with an effective restatement date of October 1, 2016. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Each year, participants may elect to defer his/her compensation and have it contributed to the Plan. Participants may modify or revoke a salary reduction agreement at any time during the year. The Plan allows for catch-up deferrals to be made by participants who are over the age of 50. Contributions are subject to certain statutory limitations. The Plan allows for employees to make nondeductible contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

To become eligible to receive matching and non-elective employer contributions, an employee must have one year of service and at least 1,000 hours of service.

The Plan provides a match which is a discretionary option for the Company. For the years ended December 31, 2024 and 2023 the Company elected to make matching contributions according to the following schedule:

(c) *Participants' Accounts*

Each participant's account is credited with the participant's contribution and an allocation of the Employer's contribution and plan earnings and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) *Vesting*

A participant has a 100% vested interest at all times in his/her accounts attributable to elective deferrals plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service according to the following schedule:

(e) *Investment Options*

Upon enrollment in the Plan, a participant may direct employee contributions to various investment options. The Company's matching contributions are contributed in the same proportion.

(f) *Payment of Benefits*

On termination of service or reaching age 59 ½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or may request a partial distribution, annual installments over a period not to exceed the life expectancy of the participant, or may apply the balance to purchase an annuity contract. Balances of \$5,000 or less are automatically distributed upon termination of service. Participants may request a distribution of rollover contributions at any time.

(g) *Forfeitures*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$890 and \$11 respectively. Additionally, in 2024 and 2023, employer contributions were reduced by \$10,169 and \$17,805, respectively, from forfeited non-vested accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following accounting policies, which conform with accounting principals generally accepted in the United States of America (U.S. GAAP), have been used consistently in the preparation of the Plan's financial statements.

(a) *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) *Notes Receivable - Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, the balance of loans was \$1,581 and \$3,778 respectively, and no allowance for credit losses has been recorded.

(c) *Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(d) *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) *Payment of Benefits*

Benefits are recorded when paid.

(f) Administrative Expenses

All administrative expenses of the plan are paid by the Company and are therefore excluded from these financial statements.

(g) Plan Amendments

Effective October 15, 2024, the Plan adopted SECURE 2.0, Sections 304 and 602, which increase required mandatory distributions, as well as modify hardship withdrawal requirements.

(h) Subsequent Events

Subsequent events were evaluated through June 30, 2025, which is the date the financial statements were available to be issued.

(3) INCOME TAX STATUS

The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

(4) FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at published daily net asset value (NAV) as a practical expedient. The investment is not redeemable at net asset value in the near term and is therefore classified as a Level 3 asset.

Investment Contract with Insurance Companies

Teachers Insurance and Annuity Association of America (TIAA) insurance contracts are valued at contract value which equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. These contracts are not available for sale on any securities exchange. Contract value may provide a good approximation of fair value and is classified as a level 3 asset.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all amounts credited to their accounts.

(6) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant accounts and the amounts reported in the statement of assets available for benefits.

(7) RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of funds managed by TIAA Global Asset Management. TIAA is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(8) INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained certifications from the trustee of the Plan, TIAA, as of and for the years ended December 31, 2024 and 2023, that all information provided by the trustee is complete and accurate. Information included in the accompanying financial statements as to investments in the trust fund administered by the trustees, investment income and investment information in the supplemental schedule is presented in reliance solely upon those certifications.
