## Independent Auditor's Report

We have performed audits of the financial statements of the Saf-Gard Safety Shoe Co., Inc. ### 1. Description of Plan

The following description of the Saf-Gard Safety Shoe Co., Inc. (the “Company”) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan available to eligible employees who have attained 21 years of age and completed two months of service. Employees may begin participation on the first day of the month coinciding with or following the date eligibility requirements are met. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Participants may elect to contribute a percentage of their pre-tax or after-tax compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company may make discretionary matching contributions equal to 50% of participants’ elective contributions, limited to a maximum of 6% of participants’ eligible compensation, which it did in 2024 and 2023. The plan sponsor may also make discretionary profit sharing contributions. No discretionary profit sharing contributions were made in 2024 or 2023.

#### **Participant Accounts**

Participants may direct their contributions into any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any point in time. Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions, plus any actual earnings thereon, is based on years of service according to the following schedule:

### 1. Description of Plan (Concluded)

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant is entitled to receive his or her vested account balance in a lump-sum amount or installment payments. Withdrawals may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts are used to offset Company discretionary matching contributions. During 2024 and 2023, forfeitures of approximately \$8,000 and \$5,000 were used to reduce Company discretionary matching contributions. No forfeitures were available as of December 31, 2024 or 2023.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years or up to 10 years for the purchase of a primary residence. Participants may only have one outstanding loan at a time. The notes are secured by the participants' vested account balance and bear interest at the prime rate plus 1.50%. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including custodian and asset fees, are paid by the Plan. Loan and distribution fees are paid out of affected participant accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan's financial statements are prepared using the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### 2. Summary of Significant Accounting Policies (Concluded)

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through August 28, 2025, the date that the financial statements were available to be issued, and determined that no events require adjustment to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company ("Principal").

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a non-standardized plan document by PA Retirement Solutions Inc. ("PARS"). The IRS has determined and informed PARS by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right to discontinue the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### 7. Party-in-Interest Transactions

Certain investments of the Plan are managed by Principal and Principal Life Insurance Company (“PLIC”). Principal and PLIC are the respective custodian and recordkeeper of the Plan and, as such, these transactions qualify as party-in-interest.

Administrative fees paid by the Plan to PLIC for recordkeeping and other administrative services were approximately \$63,000 and \$51,000 during 2024 and 2023.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurements***

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trusts:* Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

*Pooled separate accounts:* Valued at unit value as reported by the issuer based on quoted market prices of the underlying assets, which is then adjusted for dividends and separate accounts fees. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
