INDEPENDENT AUDITORS' REPORT

To the Board of Directors of Money Management International, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed the audit of the financial statements of Money Management International, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Money Management International, Inc. 401(k) Retirement Plan (the "Plan"), provides only general information. Readers should refer to the Plan document for a more complete description of the Plan's provisions.

- A. **General** – The Plan is a defined contribution plan originally effective April 1, 1987, covering all employees of Money Management International, Inc. (the "Company" or "Plan Sponsor"). The Plan has been restated and amended through the years to comply with tax legislation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

B. **Contributions**

Rollover Contributions

The Plan accepts rollovers from another qualified retirement plan or an IRA.

Elective Deferrals Including Roth 401(k) Deferrals

Each year, participants may elect to make pre-tax or Roth 401(k) deferrals of their total compensation, to be deducted each pay period, up to the maximum amount allowed under the Internal Revenue Service ("IRS") rules. Participants who have attained age 50 or older before the end of the Plan year, and are making maximum contributions, are eligible to make catch-up contributions, up to the maximum as permitted by the Internal Revenue Code ("IRC"). The Plan includes an auto-enrollment provision whereby employees eligible to participate have their deferral rate set at 6% unless they affirmatively elect not to participate or elect a different percentage.

Employer Contributions

Each year, the Sponsor makes a matching contribution equal to 50% of a participants' elective contribution to the Plan limited to 6% of eligible base compensation. The Company may also make a supplemental matching contribution and discretionary profit-sharing contribution to the Plan. There were no supplemental matching and discretionary contributions made during 2024 and 2023. Employer contributions are recorded in the year earned. Employer contribution receivable is recorded for amounts not remitted by the end of the Plan year. The Employer remits the employer contribution receivable before the end of the following year. All employer contributions are expected to be collected; no allowance is deemed necessary.

- C. **Participant Accounts** – Each participant's account is credited with the participant's contributions and allocations of (a) any Sponsor discretionary matching and/or profit-sharing contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses.
- D. **Eligibility** – All employees who have attained 18 years of age and completed 30 days of employment are eligible to participate in the Plan if they do not fall under any of the excluded employee categories. The Plan excludes independent contractors, leased employees, union employees and non-resident aliens. To participate in the employer matching contributions, the employee must have completed one year of eligible service, meaning the employee must have worked at least 1,000 hours of service and have attained 18 years of age. To be eligible to receive the supplemental matching and discretionary contributions, participants must complete 1,000 hours of service in a Plan year and be employed at the end of the Plan year, unless the participant terminates employment during the plan year on or after the participants' normal retirement age, death or disability.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

- E. **Vesting** – Participants are immediately vested in their elective basic contributions plus actual earning thereon. Participants hired on or after October 1, 2017 who complete one hour of service are fully vested in their Company contribution portion of their participant accounts upon completion of one year of service. Participants hired before October 1, 2017 are vested in their Company contribution portion of their participant accounts as follows:

- F. **Payment of Benefits** – A participant shall become immediately vested upon retirement, disability, or death. Normal retirement age under the Plan is 65. Upon retirement, disability, death or termination of employments, participants are eligible for a benefit payment. The Plan also allows in-service distributions for hardships, and upon attainment of age 59 1/2. Benefit payments are distributed in a lump-sum of annuity payment. If a participant terminated employment and the participant's account balance does not exceed \$1,000, the Plan Sponsor will make a mandatory distribution. If the balance of the terminated participant's account is between \$1,000 and \$5,000 (\$7,000 effective January 1, 2024), the Plan Sponsor may authorize that the benefit payments be rolled into an individual retirement account in the participant's name.
- G. **Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at rate of prime plus two percent at the date of the note. The loans bear interest at a rate ranging from 5.25% to 10.5% as of December 31, 2024. Principal and interest is paid ratably through payroll deductions. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.
- H. **Forfeitures** – Forfeitures of non-vested accounts as a result of terminations are credited to the Plan and are used to either offset future contributions under the Plan or offset Plan administrative expenses. There were \$3,538 and \$498 of forfeited non-vested accounts available at December 31, 2024 and 2023, respectively. There were \$0 and \$4,823 of forfeitures used to reduce Company contributions during the years ended December 31, 2024 and 2023, respectively.
- I. **Regulatory Compliance Affecting Retirement Plans** – The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE 1.0 Act made major changes to the Required Minimum Distribution ("RMD") rules, increasing the age from 70 ½ to 72 for participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

The SECURE Act 2.0 (SECURE 2.0 Act) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024. In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. **Basis of Accounting** – The financial statements are prepared using the accrual basis of accounting.
- B. **Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.
- C. **Investment Valuation and Income Recognition** – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three levels, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
- D. **Payment of Benefits** – Benefits are recorded when paid.
- E. **Expenses** – Certain expenses of maintaining the Plan are paid directly by the Sponsor. Administrative expenses recorded by the Plan represent custodian fees and other recordkeeping fees paid directly from the Plan to the Plan’s custodian. Loan fees are deducted directly from the participant’s account.

NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information, and the information contained in the supplemental schedule of assets (held at end of year), were certified as complete and accurate by the Plan’s custodians and were not subjected to any auditing procedures performed by the independent auditors except for comparing such information included in the Plan’s financial statements.

The Plan transferred some of its assets to Empower, a third-party service provider in December 2024. Voya Retirement Insurance and Annuity Company (“Voya”) has certified the completeness and accuracy of the investments included in the financial statements and the supplemental schedule from information from January 1, 2024 through December 31, 2024 and the investment activity included in the financial statements for the period ended December 31, 2024. Empower certified the completeness and accuracy of the investments included in the financial statements and the supplemental schedule from January 1, 2024 through December 31, 2024 and the investment activity included in the financial statements for the year ended December 31, 2024.

VOYA certified the completeness and accuracy of the investments included in the financial statements and the supplemental schedule as of December 31, 2023, and the investment activity included in the financial statements for the year ended December 31, 2023.

Notes receivable from participants of \$367,421 and \$329,134 as of December 31, 2024 and 2023, respectively, have been certified by the custodian. NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuity

Fixed annuities are valued at the price at which the contract could be sold or transferred in an orderly transaction between market participants at the measurement date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2016, the Plan entered into a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company ("Voya"). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity-wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary that cause a significant withdrawal from the Plan or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The crediting interest rate is based on an agreed-upon formula with the issuer, but cannot be less than 1.00%. The carrying value of the guaranteed investment contract, considered a traditional investment contract, was \$2,439,065 and \$5,584,469 as of December 31, 2024 and 2023, respectively.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments consist of mutual funds, other investments and a group annuity contract managed by Voya and Empower. Voya and Empower were the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the participants of the Plan for certain transactional services (i.e., loan issuances, withdrawal fees, etc.) are reflected as administrative expenses in the accompanying financial statements and amounted to \$113,135 and \$68,159 for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 – TAX STATUS

On October 11, 2017, the IRS stated that the Plan and related trust are designed and in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the letter. The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable IRC sections, and therefore, believes that the related custodial accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balance of participant accounts will be distributed in a lump sum.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.
