Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of BrownGreer, PLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of BrownGreer, PLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note A - Description of Plan

The following description of the BrownGreer, PLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a non-discriminatory defined contribution plan covering all employees of BrownGreer, PLC (Employer), who have attained the age of twenty-one (21) or older. Eligible employees join the Plan on the first of the month following the date they meet the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each participant may contribute to the Plan up to the maximum allowable by law. The Plan is a Safe Harbor 401(k) plan which provides for a matching contribution equal to 100% of each participant’s elective deferrals not exceeding 6% of the participant’s compensation. The Plan may also make discretionary profit-sharing contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Each participant’s account is credited with the employer contributions and the participant’s voluntary contribution, in addition to Plan earnings, as well as allocations of Plan expenses and forfeitures, if any. The Plan allocates income and net appreciation in the current market value of the funds on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

The Plan permits every participant to direct the investment of his or her account balance under the Plan. The Plan is intended to comply with Section 401(k) of ERISA which requires that participants have an opportunity to choose from a broad range of investment options that have different risk and return characteristics.

Vesting

Participants are immediately 100% vested in their voluntary, rollover, and Safe Harbor contributions plus actual earnings thereon. Discretionary profit-sharing contributions plus actual earnings thereon are vested according to the vesting schedule as follows:

<u>Years of Service</u>	<u>Discretionary Percentage</u>
Less than 2 years	0%
After 2 years	20%
After 3 years	40%
After 4 years	60%
After 5 years	80%
After 6 years	100%

Participants will be 100% vested in profit-sharing contributions if employed on or after the normal retirement age.

Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used by the Plan for several purposes such as the payment of Plan expenses. Any remaining forfeitures attributable to employer discretionary profit-sharing contributions will be used to reduce any employer contributions. Any remaining forfeitures attributable to employer matching contributions will be used to reduce any employer matching contributions. There were no forfeiture balances available at December 31, 2024 or 2023. There were no forfeitures applied to reduce current year employer matching contributions during the year ended December 31, 2024.

Payment of Benefits

Participants may withdraw from the Plan as a result of attaining the age of 59.5, completion of 10 years of participation of the Plan, total and permanent disability, death, separation from service, or termination of the Plan by the Employer. Also, the terms of the Plan permit hardship withdrawals for purposes of purchasing or preventing eviction from or foreclosure on the mortgage of a principal residence, post-secondary educational expenses or medical expenses resulting from accident or illness and certain other expenses as described by the Plan. All distributions will be made in one lump-sum payment in cash. If the vested benefit (excluding amounts attributable to rollovers) exceeds \$5,000, the participant must consent to the distribution before it may be made.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Note receivable terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The notes receivable are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 6.25% to 11.50% during 2024 and 2023. Loans mature at various dates through 2029.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements and accounting records of the Plan are maintained on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the management of the Plan to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for its fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for expected credit losses has been recorded at December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Significant expenses that are paid by the Employer include, among other things, Plan audit fees and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note C - Tax Status

The Plan is an adoption of a Prototype Non-Standardized 401(k) Plan (the "Prototype Plan") with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Services (IRS) on June 30, 2020, in which the IRS stated that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and the Prototype Plan has been amended since receiving the determination letter. However, the Plan's management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and therefore, the Plan and related trust continue to be tax-exempt.

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note D - Investment Contracts with Principal Life Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$223,748 and \$451,459 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. This contract is not a traditional guaranteed investment contract; therefore, there are not any known cash flows that could be discounted. As a result, the fair value amount is equal to the contract value. The contract does have surrender charges if it is terminated by the contract holder or the Plan terminates its interest in such contract within certain time periods. If a contract is terminated and a surrender charge applies, the Plan may no longer be deemed benefit-responsive.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of the issuer.

Note E - Risk and Uncertainties

The Plan's assets are invested in various financial instruments including mutual funds, common/collective trusts, pooled separate accounts and a guaranteed investment contract. Investments are exposed to various risks, such as changes in interest rates, market conditions and credit assessments. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and amounts reported in the financial statements.

Note F - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Unit value calculated based on the net assets or observable net asset value (NAV) of the underlying pool of securities or investments. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

During the years ended December 31, 2024 and 2023, the Plan did not have any significant transfers between Level 1, 2, or 3. The Plan's policy is to recognize transfers in and transfers out of all levels as of the end of the period.
