Specifically, the automated data push function—used to generate and submit Form 5500 filings—malfunctioned, preventing the information from being sent to the appropriate filing channel in a timely manner. This technical error remained undetected until internal reconciliation procedures flagged the missing submission.

Upon discovery of the issue, our team worked swiftly and diligently with our vendor and technical personnel to resolve the system failure, verify the data integrity, and complete the filing as soon as possible. We have since taken corrective steps to ensure this error does not recur, including implementing manual oversight checkpoints and enhancing system alert protocols to flag failed transmissions immediately.
