To the Trustees of

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the BISSELL Inc. 401(k) PLAN (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all eligible employees of BISSELL Inc. (Company) and provides for retirement benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Benefit Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

Participants may contribute any percentage of their eligible compensation, up to the maximum amount allowable by the Internal Revenue Service, including catch-up contributions for participants who have attained age 50 before the end of the year, through a payroll deduction program. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. The automatic enrollment includes an annual escalation of 1%, up to 10% of eligible compensation, unless the participant affirmatively elects to not participate. Contributions are automatically invested in a designated balanced fund until changed by the participant.

The Company makes Safe Harbor contributions to the Plan equal to 3% of participating compensation for all eligible participants. Participant and Company Safe Harbor contributions are 100% vested at all times.

The Company provides a 50% matching contribution on participant deferrals up to 4% of eligible wages, for a maximum Company match of 2% of eligible wages. Matching contributions are subject to a 3-year vesting schedule as follows:

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, an allocation of that account's investment experience, and charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their individual accounts.

Payment of Benefits

Funds may be withdrawn from a participant's account upon the occurrence of one of the following: hardship, attainment of age 59-1/2, QDRO, death, total disability, termination of employment, transfer of employment, attainment of age for required minimum distribution, domestic abuse distributions, or terminal illness. Upon termination of service, a participant may elect to either receive distribution of a lump-sum amount equal to the value of the participant's account, or to transfer the value of the participant's account into another qualified retirement plan.

Benefits are recorded when paid.

Notes Receivable from Participants

A participant may borrow up to 50% of his or her employee contribution vested account balance, up to a maximum of \$50,000. The loans are secured by the balance in the participant's vested account. Interest is charged on the outstanding loan balance at the prevailing rate for comparable loans. Loans are repaid by payroll deduction over a term that complies with Internal Revenue Code guidelines. Both interest and principal payments are credited to the participant's account.

Forfeitures and Plan Expense Account

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$185,477 and \$113,933, respectively. These accounts will be used to reduce future administrative expenses or employer contributions. Also, in 2024, Plan expenses and employer contributions were reduced by \$54,749 and \$12,003, respectively, from forfeited nonvested accounts. In 2023, Plan expenses and employer contributions were reduced by \$58,723 and \$20,945, respectively, from forfeited nonvested accounts.

At December 31, 2024 and 2023, nonvested expense reimbursement accounts totaled \$17,168 and \$7,075, respectively. These accounts will be used to reduce Plan expenses. Plan expenses were reduced by \$0 from the expense reimbursement account for each of the years ended December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. Should the Plan terminate, all participants' accumulated plan benefits become 100% vested and will be distributed to the participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefit Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Reclassifications

Certain amounts as reported in the 2023 financial statements and footnotes have been reclassified to conform to the 2024 presentation.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms

of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

NOTE 4 – INCOME TAX STATUS

Effective January 1, 2022, the Plan was amended and restated using the Empower Retirement, LLC Defined Contribution Pre-Approved Plan #02. The Plan document has received an opinion letter from the Internal Revenue Service dated November 14, 2022, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 5 – TRANSACTIONS WITH PARTIES IN INTEREST

Fees incurred for legal, accounting, and administrative services rendered by parties in interest were based on customary and reasonable rates for such services and are the responsibility of the Plan. The Company may, at its discretions, elect to pay certain administrative expenses on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Empower Retirement LLC served as the Plan's record keeper for the years ended December 31, 2024 and 2023. Fees paid by the Plan to Empower Retirement LLC and its affiliates amounted to \$57,263 and \$54,067 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan to Vander Ploeg, Bergakker & Associates amounted to \$10,750 and \$9,970 for the years ended December 31, 2024 and 2023, respectively. Custodial fees for 2024 and 2023 are included in net appreciation (depreciation) in fair value of investments on the statements of changes in net assets available for benefits. These transactions qualify as exempt party-in-interest transactions.

NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are presented as level 1 in the fair value measurements table.

Self-Directed Brokerage Accounts: Consists of money market funds, mutual funds, corporate stocks, and preferred stocks. The money market funds and mutual funds are valued at the daily closing price as reported by the fund and are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The corporate stocks and preferred stocks are valued at the closing price reported on the active market on which the individual securities are traded. The money market funds, mutual funds, corporate stocks, preferred stocks held by the Plan are presented as level 1 in the fair value measurements table.

Collective investment trusts: Valued based on their daily net asset value (NAV) as provided by the plan. The NAV is based upon other significant observable inputs (including quoted market prices for similar securities, interest rates, prepayment speeds, credit risk, etc.). The net asset value of a collective investment trust is not publicly quoted. The net asset values, as provided by the custodian, are used as practical expedients to estimate fair value. This class invests in a collective trust fund as well as a variety of security-backed contracts. The collective investment trusts can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There are no unfunded commitments.
