**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of Versiti 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter – supplemental schedules required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Versiti 403(b) Retirement Plan (Plan) provides only general information. More complete information regarding the Plan's provisions may be found within the Plan documents.

***General***

The Plan is a defined contribution plan originally established by BloodCenter of Wisconsin, Inc. (BloodCenter) in July 1991. Effective December 1, 2017, the Plan was restated with Versiti, Inc. (Employer), the parent of BloodCenter, as the Plan sponsor. The Plan operates under Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Also, effective December 1, 2017, the Plan was frozen. Beginning December 1, 2017, all Employer and employee contributions are made to the Versiti, Inc. 401(k) Retirement Plan.

Overall administration of the Plan is performed by the Plan administrator. Plan investments are administered by the Employer's retirement benefit plans committee, with oversight from the Employer's executive compensation committee appointed by the Employer's board of directors. Captrust Financial Advisors (formerly known as Ellwood Associates) serves as the investment advisor. Fidelity Workplace Services serves as the Plan's primary recordkeeper and Fidelity Management Trust Company serves as custodian of the Plan assets (together, Fidelity). Plan participants have the option to maintain Plan assets with a previous recordkeeper, Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (together, TIAA-CREF), an insurance company and issuer of certain annuity contract investment assets of the Plan, and record-keeper and agent for TIAA-CREF Trust Company, FSP (Trust Company), the custodian of certain assets of the Plan.

***Investment Options***

Participants are allowed to direct account balances into any of the investment options offered by the Plan.

***Participant Accounts***

Individual accounts are maintained for each of the Plan's participants to reflect the accumulation of the participant's contributions, related Employer contributions, and the participant's share of the Plan's income (loss) and related administrative expenses. Allocations of the Plan's income (loss) and administrative expenses are based on the relative value that each participant's account bears to the total of all participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting and Forfeitures***

Participants are fully and immediately vested in both participant and Employer matching contributions under the Plan. For Employer discretionary contributions, participants become fully vested in Employer discretionary contributions upon completion of three years of service at the Company or at normal retirement age, death, or disability, if earlier.

Forfeitures resulting from the non-vested portions of accounts of participants who terminate prior to being fully vested may be used to pay administrative expenses of the plan. There were \$26,293 and \$29,951 of forfeitures used to pay administrative expenses of the Plan for the years ended December 31, 2024 and 2023, respectively. There were \$129,014 and \$140,659 of unallocated forfeitures from non-vested accounts as of December 31, 2024 and 2023, respectively.

#### ***Payments of Benefits***

Upon retirement, termination of service, death or disability, participants may elect to receive an amount equal to the value of the participant's account or receive annuity payments based upon the option that is chosen by the participant. The participant may choose either a single life annuity, which pays the participant income for as long as they live, or a survivor annuity, which pays lifetime income to the participant, and upon death, to the participant's spouse until death of the spouse. The annuities are available with 5, 10, 15 or 20-year guaranteed payments.

#### ***Plan Loans***

Participants may borrow directly from TIAA, subject to certain limitations, if plan assets are held through TIAA. Applicants receiving a loan from TIAA are required to pledge 110% of the loan amount in their Traditional Annuity account for the period of time the loan is outstanding. As of December 31, 2024 and 2023, the loan balances outstanding from TIAA to the Plan's participants, based on their accumulations in the Traditional Annuity account, were \$58,651 and \$55,745, respectively. As such, approximately \$65,000 and \$61,000 (110% of outstanding loans from TIAA) as of December 31, 2024 and 2023, respectively, serves as collateral for the related loans in the Traditional Annuity account. These amounts are included in the accompanying statements of net assets available for benefits.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance held through Fidelity. The loans are secured by the balance in their participant accounts. The loans bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the Plan administrator. The interest rates ranged between 3.25% - 9.50% and 3.25% - 9.25% for all outstanding loans at December 31, 2024 and 2023, respectively. Principal and interest is paid directly by participants.

#### ***Other Withdrawals***

Participants can withdraw rollover contributions at any time.

Participants can take an in-service withdrawal given the following requirements are met: attained age 59½, becomes disabled, or incurs a hardship.

Participants may be eligible for hardship withdrawals permitted that the employee, the employee's spouse or dependent has an immediate and heavy financial need and the hardship distribution is necessary to satisfy the financial need.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of the Plan's assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Except for investments as discussed in Note D, the Plan's investments are stated at fair value. Fair value is the price that would be received when an asset is sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain TIAA Traditional Annuity contract types, including the Supplemental Retirement Annuity (SRA) and the Group Supplemental Retirement Annuity (GSRA), are considered fully benefit-responsive. See Note D for further discussion.

Purchases and sales of securities are recorded on the date the trade is made. Interest income is recorded on the accrual basis. Dividends are recorded on the date the dividend is received. Net appreciation includes realized gains and losses on investments sold during the year as well as unrealized gains and losses on investments held as of the end of the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. There is no allowance for credit losses as of December 31, 2024 and 2023.

#### ***Benefits Paid to Participants***

Benefits are recorded when paid.

#### ***Administrative Fees***

The Plan's participants are responsible for all administrative fees that relate to fund assets and fees under the TIAA annuity contracts, and the fees are expensed as incurred. The remaining costs of the Plan are shared between the participants and the Employer.

**NOTE C - FAIR VALUE MEASUREMENTS**

To differentiate between the approaches to fair value measurements, a hierarchy of three levels is used to classify fair value measurements. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment company funds* - Values are determined by obtaining quoted prices on nationally recognized securities exchanges and are classified within Level 1 of the fair value hierarchy.

*Self-directed brokerage* - Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

*Pooled separate account* - Valued at the closing price of the fund's daily net asset value, which is reported on the NASDAQ.

*Investments in certain TIAA Traditional Annuity contracts (non-fully benefit responsive)* - Certain TIAA Traditional Annuity contract types, including the Retirement Annuity (RA) and Group Retirement Annuity (GRA), are reported at contract value, which approximates fair value. As the underlying investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs. The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Contract value is deemed to approximate fair value for retirement annuities and group retirement annuities contracts based on observation of recent participant investments at contract value and by comparison of historical and current yields of highly rated long-term corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts. See Note D.

**NOTE D - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract (Traditional Annuity) is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including RAs, GRAs, SRAs and GSRA's. The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account and the options for receiving income upon retirement.

As described in Note B, because the SRA and GSRA are fully benefit-responsive guaranteed contracts, contract value is the relevant attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The RA and GRA are non-benefit responsive guaranteed contracts, of which the value is based on TIAA's quoted redemption value of the contract owned by the Plan participant at year end.

When participants chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchased a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium was paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset yearly. For accumulating SRA and GSRA contracts, the crediting interest rates were 3.00% to 5.75% and 3.25% to 6.00% at December 31, 2024 and 2023, respectively.

The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over ten annual installments. With the GRA contracts, lump-sum withdrawals are available within 120 days of termination

of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over ten annual installments (five annual installments for withdrawals after termination of employment). The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

There are no events identified that are expected to limit the ability of the Plan to transact at contract value with the issuer.

#### **NOTE E - RISKS AND UNCERTAINTIES**

In general, the investments provided by the Plan are exposed to various risks including, but not limited to, interest rate, market and credit risks. Due to the level of risks associated with certain investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE F - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt. No provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would likely not be sustained upon examination by a tax authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Fidelity and TIAA-CREF, the custodians of the Plan. Any transactions with these parties would be deemed as party-in-interest activity. Additionally, the Plan issues notes receivable from participants, which are also considered party-in-interest transactions.

The Employer also pays certain administrative expenses of the Plan.

#### **NOTE H - TERMINATION OF THE PLAN**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The recordkeeper would be directed to distribute the assets remaining in the fund in accordance with the provisions for payments of benefits in Note A.

**NOTE I - FINANCIAL DATA CERTIFIED BY THE PLAN'S RECORDKEEPERS AND CUSTODIANS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA-CREF has certified as (1) the insurance company and issuer of certain annuity contract investment assets of the Plan, and (2) recordkeeper and agent for the Trust Company, the custodian of certain assets of the Plan, and Fidelity Management Trust Company, a custodian of certain assets of the Plan, that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

**NOTE J - REGULATORY REQUIREMENTS**

In November 2007, the Department of Labor issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of ERISA. Prior to the amended regulations, the Plan (established in 1991) was historically viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Employer. Accordingly, various accounting and payroll records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not retained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements cannot be determined.

**NOTE K - SUBSEQUENT EVENTS**

Plan management evaluated its December 31, 2024 financial statements for subsequent events through August 8, 2025, the date the financial statements were issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements.
