Note 1 – Plan Description

The following description of the IndoorMedia, Inc 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of IndoorMedia, Inc. IndoorMedia, Inc. is a member of a controlled group, whereby other employers may adopt the provisions of the Plan. AutoMate Labeling Solutions, LLC, a participating employer, adopted the provisions of the Plan effective January 1, 2019. IndoorMedia, Inc. and AutoMate Labeling Solutions, LLC are hereinafter collectively referred to as (the “Employer” or “Company”). The Plan, which commenced effective January 1, 2016, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). The Plan was amended and restated effective April 1, 2022, to comply with the latest rules and regulations.

Plan Custodian and Trustee

Standard Insurance Company (“Standard” or the “Custodian”) is the Custodian of the Plan and holds the Plan’s assets. Among other duties, the Custodian receives contributions, holds, and invests fund assets in accordance with the directions of participants, and makes distributions as directed by the Company. Certain officers of the Company serve as trustees of the Plan.

Eligibility and Plan Entrance Date

Certain employees of the Company are not eligible to participate in the Plan, including union employees and nonresident aliens. All other employees become eligible to participate in the Plan after reaching the age of 21 and completing two consecutive months of service during which they work at least 250 hours. Eligible employees are permitted to enter the Plan upon the first day of the month beginning the month next following the satisfaction of the eligibility requirements.

Contributions

Participants may elect to contribute, on a pre-tax or Roth basis, up to 100% of their annual compensation, as defined in the Plan, up to the maximum amount allowed annually by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually under the IRC, which was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Employer may make matching contributions on behalf of participants at the discretion of the Company’s management. For the Plan year ended December 31, 2024, the Employer matched 50% of each \$1 contributed by a participant, up to a maximum of \$1,250. Highly compensated employees are not eligible for the Employer matching contributions.

Participant Accounts

Each participant account is credited with the participant’s contributions, Employer’s matching contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Plan Description (continued)

Vesting

Participants are vested immediately in their pre-tax or Roth deferred contributions, rollover contributions, and any related income or loss. Vesting in the Employer's matching contributions plus any income or loss thereon, is based upon years of service according to the following schedule:

In addition, Participants also become 100% vested in any unvested portion of the Employer's contributions and related earnings immediately upon death, disability, or retirement.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct their account balances to one or more of these investment options. The options vary in types of investments, rates of return, and investment risk.

Payment of Benefits

Upon separation of service due to death, disability, or retirement, a participant receives a lump sum payment equal to the value of the participant's vested balance. The participant may elect whether to receive the distribution directly or to roll over the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,606 and \$5,692, respectively. These accounts will be used to reduce future Employer contributions or to pay Plan administrative expenses. Also, in 2024, forfeitures of \$18,819 were used to reduce Employer contributions and \$870 were used to pay administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Note 2 – Summary of Significant Accounting Policies (continued)

Basis of Accounting (continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in the net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account. Plan expenses could include, but are not limited to, costs to process Plan distributions.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodian. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations are carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains a guaranteed investment contract-related investment option, the MN Life Guaranteed Return Account (the “Fixed Account”), issued by Minnesota Life Insurance Company. The contract underlying these investment options meets the fully benefit-responsive investment contract criteria, thus these investment contracts are reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

As this traditional investment contract held by the Plan is a guaranteed investment contract, the contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The Fixed Account minimum guaranteed interest rate, which is guaranteed for the lifetime of the contract, is 1.00%. The contract cannot be terminated before the scheduled maturity date. The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 5 – Guaranteed Investment Contract with Insurance Company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, the following: (i) amendments to the Plan Document, including complete or partial Plan termination or merger with another plan; (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (iv) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 – Related Party and Party-in-Interest Transactions

Plan investments are units of pooled separate accounts and a fully benefit-responsive investment contract that are managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan adopted a nonstandardized, preapproved profit-sharing plan sponsored by Minnesota Life Insurance Company ("MLIC"). The Internal Revenue Service ("IRS") has determined and informed MLIC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and thus believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

The Company failed to remit to the Plan’s Custodian certain participant contributions and participant loan repayments in the aggregate amount of \$47,555 within the period prescribed by DOL Rules and Regulations. The DOL considers late deposits to be nonexempt prohibited transactions. Delays in remitting contributions to the Custodian were due to unintentional administrative errors. During 2024, the Company corrected these contributions and remitted potential lost earnings due to the delay.
