We have performed audits of the financial statements of the Ayers/Saint/Gross, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



NOTE 1 - DESCRIPTION OF THE PLAN

General: The following description of the Ayers/Saint/Gross, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution plan covering substantially all eligible employees of Ayers/Saint/Gross, Incorporated (Employer or the Company) as described in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration: T. Rowe Price Trust Company (T. Rowe) has been engaged to serve as trustee and third-party administrator of the Plan. The trustee processes and maintains the records of participant data and holds the Plan assets. Fund line-up and plan investment advice is provided by an outside certified financial professional. The Employer serves as the Plan Administrator and is responsible for the day-to-day operations and oversight of the Plan.

Eligibility: All employees who are 21 years of age or older are eligible to participate in the Plan upon completion of 3 months of service. The Plan has an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Investments: Upon enrollment in the Plan, a participant may direct their contributions in any or all of the investment options of the Plan. These investment options include stable, conservative, moderate, aggressive, and dynamic funds.

Participant Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan up to the IRS defined maximum contribution of \$23,000 in 2024. Participants may designate a portion of their contributions as Roth deferral contributions, which are after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 in 2024.

Newly eligible employees are automatically enrolled at a 7% deferral rate of an eligible employee's compensation that is contributed to the Plan as pre-tax contributions unless the employee elects not to make an elective deferral or elects to make changes in contribution percentages.

Automatically enrolled participants' pre-tax deferral rates are automatically increased by 1% annually on January 1st, except the first such annual increase which shall not apply to a participant within the first six months following the date the participant was automatically enrolled. This automatic escalation increases annually until the participant's pre-tax deferral rate reaches 15%. Participants can elect to change the pre-tax deferral rate or opt out of automatic increases at any time.

Participants are permitted to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such rollover contributions are deposited in the appropriate investment funds in accordance with the participant's election and the Plan's provisions. In addition, participants are permitted to make in-Plan rollovers from pre-tax contributions to Roth contributions.

Employer Contributions: The Employer matches participant contributions equal to 50% of the participant's elective deferral not to exceed 7% of the participant's compensation or \$1,500, whichever is lower. The Employer may also make discretionary non-elective profit-sharing contributions to all eligible participants. Effective March 1, 2024, the Plan was amended to allow Employer matching contributions on qualified participant student loan repayments. The Employer contributions are allocated to participant accounts in accordance with the Plan document.

During the year ended December 31, 2024, there were no discretionary contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, Employer matching, allocations of the Employer's discretionary non-elective profit-sharing contributions, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their salary deferral contributions, rollover contributions, and related earnings. Participants vest in the Employer's matching and discretionary non-elective profit-sharing contributions according to the following schedule:

Forfeitures: Terminated employees of the Employer are paid the current value of the vested balance in their plan accounts as soon as administratively feasible. Unvested amounts are forfeited and used to pay administrative expenses and reduce the Employer contributions. As of December 31, 2024 and 2023, the unallocated forfeiture balance was \$0 and \$2,549, respectively. During the year ended December 31, 2024, \$45,628 of forfeited non-vested accounts were applied against employer matching contributions.

ERISA Budget Account: The Company holds an ERISA budget account as part of the Plan. For the year ended December 31, 2024, \$105,789 was credited to the Plan from excess revenue from the assets of the Plan. At the Plan level, this account is unallocated and will be used to pay for administrative expenses. Any amounts credited to the Plan and not used shall be allocated as determined by the plan sponsor. During the year ended December 31, 2024, \$76,394 was paid out of this account to pay for administrative expenses. An allocation to participants was not made in 2023. As of December 31, 2024 and 2023, the budget account had an unallocated balance of \$84,425 and \$50,931, respectively.

Payment of Benefits: Benefit payments are available to participants upon normal retirement age of 65, termination of employment, death, attainment of age 59 ½, or disability. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Participants are entitled to a benefit equal to their account balance, which will be distributed in the form of a lump sum payment. Upon termination, all vested account balances that do not exceed \$7,000 shall be automatically distributed to the participant. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½.

Notes Receivable from Participants: The Plan allows participants to borrow no less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance, except for amounts borrowed under the CARES Act. The notes are secured by the participant's vested balance and no more than two outstanding notes are permitted at any time. Notes issued bear interest at the prime rate plus 1%. Notes must be repaid to the Plan within a period of five years unless the note is used to purchase a principal residence. Notes mature at various times through July 2029. As of December 31, 2024, interest rates on these notes were between 4.25% and 9.5%. Specific terms and conditions of such notes are established by the Trustee of the Plan. Principal and interest is paid ratably through payroll deductions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements of the Plan have been presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Administrative Expenses: Plan administration and recordkeeping fees are paid by the Plan and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA–related required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual Funds: Mutual funds are registered investments with various investment managers. The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds held by the Plan are traded on national securities exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

Collective Trusts: Investments in the collective trusts are valued at net asset value (NAV). The NAV, as provided by the trustee and reported by the fund managers, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner. At the participant level, there are no redemption frequency or notice period restrictions and no withdrawal limits. Additionally, there are no unfunded commitments. The investments are direct filing entities.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

NOTE 6 – INCOME TAX STATUS

The Plan adopted a volume submitter plan which received an opinion letter from the IRS on August 2, 2017, which states that the volume submitter plan, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, liquidity, credit, and overall market volatility risk, including global events, such as pandemics and conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – RELATED PARTIES AND PARTY – IN – INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan invests in various mutual funds managed by and affiliate of T. Rowe, the trustee, and collective trusts issued by T. Rowe. These investments and the Plan's payment of trustee fees, recordkeeping fees, and investment management fees are party-in-interest transactions, as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions.
