Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bi-Mart Corporation Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Bi-Mart Corporation Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General – The Plan includes a voluntary contribution feature and a noncontributory, defined contribution retirement feature for the employees of Bi-Mart Corporation (the Corporation or Plan Sponsor). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is controlled and managed by the Board of Directors of the Corporation and an Administrative Committee appointed by the Board of Directors of the Corporation. The Plan's recordkeeping functions are performed by Empower Annuity Insurance Company of America. Empower Trust Company, LLC, is the trustee of the Plan.

Eligibility – Employees of the Corporation who have completed three months of eligible service and are 21 years of age, excluding those employees covered by a collective bargaining agreement that does not provide for participation, are eligible for participation in the Plan.

Contributions

Participant contributions – Each year participants may contribute between 2% and 75% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect to participate at a different deferral rate. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation increasing by 1% annually, on January 1 of each year, after one year of participation. The deferral rate increases up to 7% and contributions are invested in the applicable Timeframe Portfolio based on a retirement age of 65 (an investment mix designed to achieve positive results for participants retiring at age 65).

Employer discretionary contributions – The Board of Directors of the Corporation may elect to make discretionary contributions to the Plan. The formula for discretionary contributions will be determined each year by the Board of Directors of the Corporation. There were no employer discretionary contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions, as well as allocations of the Corporation’s discretionary contributions, as applicable, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan. The Plan offers a variety of mutual funds and certain other investments, which provide safety of principal, adequate liquidity, and competitive yield with low return volatility by investing primarily in investment contracts.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in discretionary employer contributions 20 percent per year over a five-year period.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years; however, terms may exceed five years for a purchase of a primary residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan Document, plan loans will bear a reasonable rate of interest as determined by the Plan Administrative Committee. Principal and interest are paid ratably through periodic payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans was between 4.25% and 12.00% with various maturities through June 2039.

Payment of benefits – Benefits are distributable to a participant or the participant’s beneficiary in a cash lump sum, unless the participant elects to receive benefits over a period of time, upon any break in employment. After attaining age 59 ½, a participant may elect to withdraw amounts, in cash, from the participant’s account balance. Financial hardship withdrawals may be made by a participant with the approval of the Administrative Committee. Such approval is limited to cases allowed by the Internal Revenue Code (IRC).

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and are used to pay plan administrative expenses and reduce future employer contributions, if any. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$52 and \$16, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes to Financial Statements

Investment valuation – The investments are reported at fair value. The Plan’s custodian and trustee certify the fair value of investments except for the collective trust and pooled separate accounts which are valued at the net asset value practical expedient (NAV practical expedient). If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses for administration and servicing of the Plan are paid directly by the Corporation and are excluded from these financial statements. Expenses which are not paid by the Corporation are satisfied directly out of the Plan’s assets, except for certain transactional charges which are paid by the particular participants involved.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 2, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Pooled separate accounts – Units held in pooled separate accounts (PSA) are valued using the NAV practical expedient of the PSA as reported by the PSA managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

Investments held by the CT contain no redemption restrictions or unfunded commitments. In addition, there are no significant restrictions on the ability to sell investments.

The valuation techniques used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Corporation by a letter dated November 14, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrative Committee believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Corporation and Administrative Committee have evaluated the Plan's tax positions and do not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest-rate, market-volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near-term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 7 – Party-in-Interest Transactions

Empower Trust Company, LLC, the custodian of the Plan, is an affiliate of Empower Annuity Insurance Company of America and Empower Advisory Group, LLC (the Affiliates). The Affiliates provide trust, recordkeeping, and advisory services to the Plan. Transactions with the Affiliates qualify as exempt-party-in-interest transactions. Fees paid by the Plan to the Affiliates for services were \$141,419 for the year ended December 31, 2024.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Corporation has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 10 – Subsequent Event

In March 2025, the Plan sponsor was notified by Empower Trust Company, LLC that certain participants did not have their elective deferrals change based on the Plan's automatic escalation provision. This occurred during 2023, 2024, and 2025, and affected 244 plan participants. The Plan is currently implementing a corrective action plan scheduled for completion during 2025.
