Note A - Description of Plan

The following description of the NPC Companies 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all employees the month following employment of NPC Companies (Company) and its wholly owned subsidiaries who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

2. Contributions - Each year, participants may contribute up to 75 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible or those without an affirmative election employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent with an auto-escalation provision whereas enrolled participants with less than a 6 percent affirmative election are increased by 1 percent each year up to 6 percent eligible compensation unless a contrary election is made, changing effective January 1, 2024 to up to 10 percent of eligible compensation and their contributions invested in a designated target date fund. The Company contributes to a safe harbor match 100 percent on the first 1 percent of compensation plus 50 percent on the next 5 percent of compensation changing effective January 1, 2024 to 50 percent on the next 8 percent of compensation that a participant contributes to the Plan based on plan year compensation. A true-up contribution may be required at the end of the plan year. The safe harbor matching Company contribution is also directed by participants. Additional discretionary amounts may be contributed at the option of the Company's board of directors and are also directed by participants. Participants who are not employed on the last working day of the plan year are not eligible for an allocation of Company discretionary contributions for such year. Contributions are subject to certain limitations.

3. Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, account earnings, as well as an allocation of the Company discretionary contribution based on participant compensation with an integration level of the taxable wage base, as defined. Participant accounts are charged directly for participant requested services and an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or the number of participants in the Plan, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are vested immediately in their contributions plus actual earning thereon. Vesting in the Company's contribution portion of their account and earnings thereon is based on years of continuous service. A participant is 100 percent vested after two years of credited service for the safe harbor matching contribution.
5. Notes Receivable from Participants - Since January 1, 2003, participants are not allowed to borrow from their fund accounts.
6. Payment of Benefits - On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments.
7. Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,156 and \$50,261 respectively. During 2024 and 2023, amounts forfeited from nonvested accounts used to reduce Company contributions were \$2,615 and \$-0- or pay administrative expenses were \$22,546 and \$29,693, respectively.

Note B - Summary of Accounting Policies

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Pooled separate accounts by their nature do not pay dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction. The Plan usually distributes any excess contributions to the applicable participants prior to March 15th of the year following the excess, with amounts paid being \$-0- and \$-0- in 2024 and 2023, respectively.
5. Payment of Benefits - Benefits are recorded when paid.
6. Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for third party advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.
7. Subsequent Events - The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

Note C - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be activity traded.

Pooled separate accounts: Valued daily at the daily net asset value (NAV) of the underlying mutual fund shares held by the Plan subject to a unitization valuation process by the trustee, is used as a readily determinable fair value. These accounts are part of a group annuity contract that not themselves publicly traded but are composed of mutual funds that are either priced by a pricing service or directly by the relevant mutual fund company trading partner.

Common/Collective trust: Valued either by the trust using a discounted cash flow methodology based on the prevailing market rates of similar instruments with comparable durations or by the contract issuer using independent pricing services for investment contracts in which the readily determinable fair value is used to estimate fair value. Participant transactions occur daily and the trust is priced daily.

The Internal Revenue Service (IRS) has determined and informed the pre-approved plan provider by letter dated September 16, 2022, that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Non-Standardized Pre-Approved Profit Sharing Plan With CODA has been amended since receiving its determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Since the Plan is a pre-approved plan, it is not necessary for the Plan administrator to submit the Plan for favorable determination.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H - Related-Party Transactions

Plan investments are with Empower/Empower Trust Company, LLC as the current trustee for the Plan. Empower/Empower Trust Company, LLC is also the recordkeeper for the Plan, therefore, these transactions qualify as party-in-interest transactions.

The Plan as of April 1, 2022 has a Administrative Services Agreement with Empower for administrative and recordkeeping. The Plan also has a Retirement Plan Advisory Services Agreement with CAPTRUST Financial Advisors for investment advisory fiduciary services. The Plan or Company may make a payment for administrative expenses. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. See Note B for further description on administrative expenses.

Investment advisor fees paid by the Plan amounted to \$43,798 and \$46,641 in 2024 and 2023, respectively.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note J - Plan Amendments

The Plan was amended effective as of January 1, 2024. Significant changes were increasing the safe harbor matching Company contribution to a maximum of 5% from 3.5%, and changing both the safe harbor automatic enrollment automatic deferral percentage and the automatic escalation provision to increasing 1% per year up to a maximum of 10% from 6% of plan compensation.

Note K - Subsequent Event

The Plan was amended effective as of January 1, 2025. A significant change was increasing the auto enrollment percentage to 5% from 3% of plan compensation.
