Note 1. Description of Plan

The following description of the W.B. Mason Company Retirement 401(k) Plan & Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide employees of W.B. Mason Co., Inc. (the “Company”) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

Eligibility

Employees classified by the Company as common law employees, who are at least 18 years of age, and are not residents of Puerto Rico are eligible to participate in the Plan.

The Plan also includes an automatic enrollment provision. Therefore, 35 days following the participant’s date of hire, the Company automatically, on behalf of those participants, defers 3% of the participants’ eligible compensation (as defined). Participants who remain automatically enrolled will have their deferral increased by 1%, annually, on January 2nd, until a deferral rate of 8% is reached. This first such annual increase does not apply to a participant within the first six months following the date of their initial automatic enrollment. These deferrals will be automatically invested in a Fidelity Freedom Fund based on the participant’s age at the time of enrollment. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 60% of their annual pre-tax compensation, as defined by the Plan. In addition, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional “catch up” contribution. The Plan also allows participants to defer funds into a “Roth 401(k) deferral.” These deferrals are subject to federal income taxes.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. The Plan currently offers various mutual funds, a money market fund, and a common collective trust as investment options for participants.

Employer Contributions

Participants that have completed a minimum of 1,000 hours of service and are employed on the last day of the plan year are eligible to share in the Company’s discretionary matching contributions. The Company may make a matching contribution equal to 100% of the participant’s contributions, with various tiered maximum contribution amounts based on the participant’s eligible earnings and job function. For 2024 the Company elected not to fund the Employer Match. Matching contributions for 2023 ranged from \$250 to \$1,000 per participant.

Participants’ Accounts

Each participant’s account is credited with its respective contribution and its allocation of (a) employer matching contributions and (b) plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants' voluntary contributions and earnings thereon vest immediately. Participants are immediately vested in the Company matching contributions, plus earnings thereon.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in installment payments or a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons or after attaining the age of 59½. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and becomes a taxable distribution.

Participants may borrow up to 50% of their vested account balance with a maximum of \$50,000. The interest rate is set periodically to be in line with current market rates for similar types of loans (9.50% at December 31, 2024 and 2023). Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended up to ten years. Loans are secured by the balance in the participant's account. Principal and interest are paid ratably through automatic payroll deductions.

Other Income

Certain mutual fund and collective trust expenses that are charged by the mutual fund companies to the individual participants are credited to the Plan on a quarterly basis. These assets are held in a reserve account and may be used to pay for expenses of the Plan, as described in the agreement. Amounts unused for expenses may be allocated to eligible participant accounts based upon each participants' pro rata percentage of total plan investments. Such allocation is permitted to take place no more frequently than on a quarterly basis.

As of December 31, 2024 and 2023, the balance in the reserve account amounted to \$30,422 and \$19,827, respectively. During the year ended December 31, 2024, funds credited to the Plan amounted to \$74,967 and is included in other income in the accompanying statement of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company may, at its discretion, pay the expenses incidental to administering the Plan. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Other income shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan

Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of mutual funds, a money market fund and a common collective trust managed by Fidelity. Fidelity is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$359,462 of recordkeeping fees to Fidelity during the year ended December 31, 2024. Individually nonmaterial expenses paid to parties in interest aggregated \$56,275 during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.

Level 3 - Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.
