Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Rockingham Group Retirement Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Plan Description

The following description of Rockingham Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Rockingham Insurance Company (the “Company”), except leased employees and employees that are compensated on a fee or a commission basis. Eligible employees may begin making salary deferrals effective the first day of the plan quarter following their date of hire. In order to receive the Company contributions, eligible employees must complete six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute amounts of pre-tax or after-tax compensation, not to exceed annual limits established by the *Internal Revenue Code (IRC)*, as defined in the Plan. The Plan contains an automatic enrollment feature where eligible participants are enrolled with a default deferral rate of 6%, unless an alternative election is provided. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may contribute to the Plan in the form of matching or additional discretionary contributions at the option of the Board of Directors. For the years ended December 31, 2024 and 2023, the Company matched 50% of participant deferrals, up to a maximum of 6% of eligible compensation. For the year ended December 31, 2024, these matching contributions totaled \$244,626. The company also may elect to provide a gainsharing contribution to participants with 6 months of service. From January 1, 2024 to March 31, 2024, the Company contributed 1.2% of gainsharing contributions to eligible participants, totaling \$24,489 for the year ended December 31, 2024. Finally, the Company may elect to provide a fixed employer contribution of 4.5% each year to participants with 6 months of service, work over 1,000 hours during the Plan year, and are employed on the last day of the plan year, aside from those who are terminated after reaching normal retirement age, as defined. During the year ended December 31, 2024, the fixed employer contribution totaled \$276,502. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching and any additional discretionary contributions, plan earnings, and charged with an allocation of administrative expenses. Forfeited balances of terminated participants’ nonvested accounts are used to pay administrative expenses or reduce employer contributions.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company’s matching and additional discretionary contribution portions of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested in Company matching and profit-sharing contributions after five years of credited service or at normal retirement age, as defined by the Plan.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years unless the note is for purchase of a primary

residence, in which case the term may exceed five years. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rate ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution, annuity, or installment payments equal to the value of the participant's vested interest in his or her account. In-service withdrawals are permitted as specified in the Plan agreement.

Administrative Costs

Plan administrative expenses may be paid by the Company or the Plan on a discretionary basis.

Forfeitures

Forfeitures of terminated non-vested account balances may be used to pay administrative expenses, reduce employer contributions, or allocated to participants, as defined. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$43,176 and \$86,266, respectively. During 2024, \$86,343 was used to reduce employer contributions and \$80 was used to pay Plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefit payments are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The fair values of mutual funds and the collective investment trust are based on quoted net asset values of the shares held by the Plan at year end.

Note 4 – Investment Contract

The Plan has investments in the Principal Global Investors Trust Company Principal Stable Value Fund. Included in this fund are certain guaranteed investment contracts and synthetic investment contracts. These contracts are considered to be benefit-responsive and are presented at fair value. The average yields for this fund is as follows:

The objective of this fund is to provide diversification of investments consistent with a stable fixed-income methodology and the careful and prudent assumption of investment risk providing for preservation of capital, stability and predictability of returns, liquidity to pay plan benefits, and high credit quality. The percentage of contributions allocated to the stable value fund is determined by the participants.

Note 5 – Related Party Transactions

Officers or employees of the Company perform certain administrative functions. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds issued and managed by the Plan Trustee. Investments in funds issued by the Trustee are considered related party transactions. Fees paid to the Plan Trustee by the Plan for investment management and administrative services were \$60,628 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7 – Income Tax Status

The Plan was adopted under a non standardized pre-approved profit sharing plan arrangement with Principal Life Insurance Company. Principal Life Insurance Company received a letter from the Internal Revenue Service dated June 30, 2020, stating that its master plan is designed in accordance with applicable sections of the IRC. Although the Plan document has been amended, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 10 – Subsequent Events

Subsequent events have been evaluated through August 25, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan document was amended to become a safe harbor plan, implement an employer safe harbor matching formula of 100% of elective deferrals up to 3%, plus a 50% match on additional deferrals between 3% and 6%. The Plan will also implement an auto-escalation provision for participant deferrals. Each January 1, participants' deferral percentages will automatically increase by 1%, up to a maximum of 10%. Individuals must actively opt out for non-participation in the program.

Further, the Plan will require 90 days of service for all contribution types and plan entry has been changed from the first day of each plan year quarter to the first day of each month.
