We have performed audits of the financial statements of Ozarks Community Health Center 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ozarks Community Health Center 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of the Plan

General

The following description of Ozarks Community Health Center 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Ozarks Resource Group (Company) for the benefit of its employees who are 18 years old or older. All eligible employees 18 years of age or older may begin to make salary deferral contributions to the Plan on the first day of the month coinciding with or next following the date they become eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

From January 1, 2023, through August 12, 2024, Capital Bank and Trust Company served as the Plan's custodian and Capital Group Retirement Plan Services served as the Plan's recordkeeper. Starting August 13, 2024, the Plan is invested in a group annuity contract with OneAmerica Financial's American United Life Insurance Company (AUL) and AUL serves as the Plan's contract administrator and recordkeeper.

Change in Custodian and Recordkeeper

Effective August 13, 2024, AUL became the Plan's new recordkeeper and insurance company. Plan assets transferred to AUL were transferred into funds comparable to those offered by the previous custodian. The conversion initiated a "Black Out" period beginning August 5, 2024, and continued through August 22, 2024. During this period, funds could not be applied to the employee-selected funds with AUL or withdrawn from the Plan until AUL had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited and held in a Plan holding account until the completion of the Black Out period. At the end of the Black Out period, these funds were then allocated in accordance with the investment elections requested by each participant.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to the maximum allowed by the Internal Revenue Code as either pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Plan provides for discretionary employer matching contributions and employer nonelective contributions as determined by the Company's Board of Directors. For 2024 and 2023, the Company made discretionary matching contributions of 30% of employees' salary deferral amounts that are not in excess of 10% of eligible compensation. Participants must be employed on the last day of the plan year and have completed a minimum of 1,000 hours of service during the year to qualify for the Company's annual discretionary nonelective contributions, unless their termination is the result of death, total and permanent disability, or normal retirement. For 2024 and 2023, the Company elected to make discretionary nonelective contributions of 3% of eligible compensation, plus an additional 3% of any eligible compensation in excess of 81% of the Social Security Wage Base.

Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the investment account options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after 5 years of credited service. In the event of termination due to death, total and permanent disability, or normal retirement, participants also become 100% vested.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,662 and \$9,018, respectively. These accounts may be used to pay plan expenses or to reduce future employer contributions. During 2024 and 2023, forfeited nonvested accounts of \$9,018 and \$7,779, respectively, were used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts are valued based on the net asset value of the shares of the underlying mutual funds as provided by AUL.

The AUL Stable Value Account, a fully benefit-responsive investment contract, is reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Employer are recorded in the year in which the plan compensation is paid and the employee contributions are deducted.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan has an unallocated plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. Pursuant to the revenue sharing agreements, the expense budget account is treated as a plan asset and must be used only for appropriate plan expenses. As of December 31, 2024 and 2023, the expense budget account totaled \$0. During 2024, the Plan received revenue sharing credits from Capital Bank and Trust Company and AUL totaling \$16,876 and \$9,209, respectively, and utilized \$26,085 to pay certain plan expenses. During 2023, the Plan received revenue sharing credits of \$15,398 from Capital Bank and Trust Company and utilized \$15,437 to pay certain plan expenses. All funds utilized from these accounts are treated as administrative expenses on the statements of changes in net assets available for benefits, and are presented net of the respective revenue sharing credits.

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian and Insurance Company

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company and AUL, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of pooled separate accounts and a fixed account managed by AUL. Certain plan investments were shares of mutual funds managed by The American Funds Group, which is an affiliate of Capital Bank and Trust Company. Capital Bank and Trust Company and AUL are the Plan's custodian and insurance company, respectively, therefore, these transactions qualify as party-in-interest transactions. Certain plan expenses are included in net appreciation in fair value of investments, as they are paid through indirect compensation, rather than a direct payment.

The Company pays directly any other fees related to the Plan's operations and provides certain additional administrative services at no cost to the Plan.

Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds which are valued at the net asset value (NAV) of shares held at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projection, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities include the pooled separate accounts which are valued daily based on the net asset value of the underlying mutual funds as provided by AUL. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract (fixed account fund) with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract permits the insurance company to terminate the agreement only under limited circumstances and with advance notification requirements.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by CCH Incorporated, dba ftwilliam.com. The pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the form of the pre-approved plan document is acceptable under Section 401 of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$36 and \$111,309 were not remitted within the established remittance pattern for the years ended December 31, 2024 and 2023, respectively.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Subsequent Events

Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.
