## Independent Auditor's Report

#### Report on the Financial Statements

#### Basis for Disclaimer of Opinion

As permitted by 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the Plan Administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 3, which was certified by John Hancock Life Insurance Company, the custodian of the Plan, except for comparing this information with the related information included in the financial statements. We have been informed by the Plan Administrator that the custodian holds the Plan's assets and executes transactions. The Plan Administrator has obtained a certification from the custodian as of and for the year ended June 30, 2019, that the information provided to the Plan Administrator by the custodian is complete and accurate.



## **Disclaimer of Opinion**

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

## **Emphasis of Matter – Plan Termination and Liquidation Basis**

As discussed in Note 1 to the financial statements, the Board of Trustees of Antelope Valley Community Clinic, the Plan's sponsor, adopted a resolution to terminate the Plan effective October 1, 2021. In accordance with U.S. GAAP, the Plan has prepared the 2019 financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### ***December 31, 2018 Statement of Net Assets Available for Benefits***

The accompanying statement of net assets available for benefits of the Plan as of December 31, 2018 was not audited, reviewed, or compiled by us and accordingly, we do not express an opinion or any other form of assurance on it.

The supplemental schedule of assets (held at end of year) as of June 30, 2019 is required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 and is presented for the purpose of additional analysis and is not a required part of the financial statements. The supplemental schedule is the responsibility of the Plan's management. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we do not express an opinion on the supplemental schedule.

**NOTE 1      DESCRIPTION OF THE PLAN**

The following description of the Antelope Valley Community Clinic 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established on January 1, 2013 by Antelope Valley Community Clinic (the Company or the Plan Sponsor) to provide benefits to eligible employees, as defined in the Plan document. The Plan's purpose is to enable employees to accumulate long-term savings for their retirement while benefiting from favorable tax treatment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2015, the Plan was amended to comply with the current law.

The Plan Sponsor terminated the Plan effective October 1, 2021, and Plan assets will be distributed to participants subject to the provisions of ERISA. All participants became fully vested as of the termination date. Therefore, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan has changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2019 financial statements.

**Eligibility**

Prior to Plan termination, all employees, who attained the age of 21 and were not classified as an excluded class were eligible to make an elective deferral contribution and Roth contributions into the Plan and to receive the employer matching contribution. Excluded classes of employees were collective bargaining (union) employees; non-resident aliens; and leased employees. Employees must also satisfy completing at least 250 hours of service during the first 3 months of employment. If the employee did not work at least 250 hours during their first 3 months of employment, they will be able to satisfy the Plan's minimum service requirement once they have completed a year of service.

**Participant Contributions**

Prior to Plan termination, participants are able to elect to make pre-tax or after-tax Roth deferral, as defined in the Plan and subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Company Contributions**

The Plan provides for discretionary matching contributions to participants deferring into the Plan as a percentage that a participant defers into the Plan or as a uniform dollar amount. For the year ended December 31, 2019, there were no discretionary matching contributions. The Plan also provides for Company qualified matching contributions (QMAC).

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Plan earnings or losses, and an allocation of the Company's contribution, if any. Allocations of the Company's contribution is based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their salary deferral, rollover contributions, and related earnings. Prior to the Plan termination, participants vest in Company contributions based on years of service. A participant will be credited with a year of vesting service for each year in which at least 1,000 hours is rendered.

**Forfeitures**

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay Plan administrative expenses or reduce future employer contributions, if so, directed by the Plan. As of December 31, 2019, the forfeiture account balance was \$0. There were no forfeitures in 2019.

**Loans Receivable from Participants**

Effective June 10, 2021, notes receivable from participants were no longer allowed to be taken following the termination of the Plan.

Prior to Plan termination, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are up to 5 years unless for the purchase of the primary residence of the participant wherein loan period may extend beyond five years (but in no case more than 10 years). A participant may have only 1 loan outstanding at any time.

Loans receivables from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distribution based upon the terms of the Plan document.

**Basis of Accounting**

As a result of the Plan termination, the financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with U.S. GAAP.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is reported in the accompanying Statement of Changes in Net Assets Available for Benefits in Liquidation as net appreciation (depreciation) in fair value of investments.

**Benefits Paid to Participants**

Benefit payments to participants are recorded when paid.

**Administrative Fees**

All usual and reasonable expenses are paid by the Plan Sponsor, and any fees not paid by the Plan Sponsor may be paid from the Plan assets if not prohibited by applicable laws or regulations. Participant-directed fees such as loan set-up fees are charged against the participant's account.

**Risks and Uncertainties**

The Plan provides for various investment options in separate pooled accounts. Investment securities are exposed to various risks such as interest rate, market, and credit. Because of the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 3            INVESTMENT CERTIFIED BY CUSTODIAN**

The Plan Administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value as of December 31, 2019, as reflected in the Statement of Net Assets Available for Benefits in Liquidation;
- Investment activity, as reflected in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the year ended December 31, 2019;
- Investment information disclosed in Note 4 to the Plan's financial statements; and
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2019.

The Plan Administrator instructed the Plan's independent auditors not to perform any audit procedures on the information certified, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4            FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 4      FAIR VALUE MEASUREMENT (CONTINUED)**

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Investments in pooled separate accounts* - These funds are valued using the net asset value (NAV) provided by the custodian of the funds. The NAV is based on the value of the underlying assets owned by the funds, minus its liabilities, and then divided by the number of shares outstanding.

The NAV is used as a practical expedient to estimate fair value. The pooled separate accounts are not classified within the fair value hierarchy; however, the amounts measured using NAV are disclosed to permit reconciliation of the fair value of investments in the Statements of Net Assets Available for Benefits in Liquidation.

All the Plan's investments at fair value amounting to \$638,329 as of December 31, 2019 are measured at NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5            RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of pooled separate accounts managed by John Hancock. John Hancock is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt under ERISA. Fees paid by the Plan to the custodian amounted to \$7,434 in 2019.

**NOTE 6            INCOME TAX STATUS**

The Plan Administrator adopted a Prototype Non-standardized Profit Sharing Plan. The Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. No provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7            RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits in Liquidation.

**NOTE 8            SUBSEQUENT EVENTS**

The Plan Administrator has evaluated events or transactions that occurred subsequent to December 31, 2019 through February 24, 2023, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements and determined that no subsequent matters require disclosure or adjustment to the accompanying financial statements other than the matter described in Note 1.
