- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Blue Acorn iCi, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of a Matter - Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, as described in Note 2 to the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (held at End of Year) (modified cash basis) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule (modified cash basis), we evaluated whether the supplemental schedule (modified cash basis), other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1. Description of Plan**

The following description of Blue Acorn iCi, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan that provides retirement benefits for employees of Blue Acorn, iCi, Inc. (the “Company”) who have at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code of 1986, as amended (the “Code”).

#### ***Employee Contributions***

Participating employees may contribute up to the maximum allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees also may contribute amounts representing distributions from other qualified retirement plans.

#### ***Employer Contributions***

The Company may make a discretionary profit sharing contribution at the discretion of the Board of Directors. There was no discretionary profit sharing contribution for the year ended December 31, 2024.

The Company also makes safe harbor matching contributions. The safe harbor matching contribution is made to the account of each eligible participant in the amount equal to the sum of 100% of the amount of the participant’s elective deferrals that do not exceed 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals between 3% and 5% of the participant’s compensation. In 2024, the Company only made safe harbor matching contributions to the Plan. All contributions are subject to certain limitations imposed by the Code.

#### ***Participant Accounts***

Participants have accounts that may consist of employee, rollover, and employer contributions for each investment option selected. Participants may elect to have contributions invested in any or all of the funds, subject to certain limitations. Investment income and administrative expenses are allocated to the participants’ accounts regularly. Allocations of investment income and administrative expenses are based on a participant’s compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balances.

### 1. Description of Plan (*continued*)

#### ***Vesting***

Participants are immediately vested in their deferral, rollover, and safe harbor contributions, including the earnings on these amounts. Vesting in the remainder of their accounts is based on years of continuous service. Participants are fully vested upon reaching their normal retirement date, death or total disability. Participants are fully vested in employer discretionary contributions upon the completion of four years of service as detailed in the following table:

| <u>Years of Service</u>           | <u>Vesting Percentage</u> |
|-----------------------------------|---------------------------|
| Less than 1 year                  | 0%                        |
| At least 1 year, but less than 2  | 25%                       |
| At least 2 years, but less than 3 | 50%                       |
| At least 3 years, but less than 4 | 75%                       |
| 4 or more years                   | 100%                      |

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term up to thirty years. The loans are secured by the balance in the participant's account and bear interest at 2% over the prime rate published in the Wall Street Journal on the first business day of the month before the loan is originated. The loans bear interest at rates ranging from 4.25% to 10.50%. Participants may only have one loan outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

#### ***Payment of Benefits***

Upon retirement, disability, death or termination of employment, participants become entitled to the total value of their vested account, determined as of the valuation date. The Plan also provides for in-service withdrawals by qualified participants. Distributions will be paid by lump sum or in installments over a number of years, based upon election of the participant or the Plan, as defined in the Plan or the Code.

Upon filing for financial hardship, participants are entitled to the value of their deferral accounts, but not the earnings thereon, determined as of the valuation date, which is payable immediately in a lump-sum distribution.

### **1. Description of Plan (*continued*)**

#### ***Forfeitures***

Forfeitures are used to reduce the Plan's administrative expenses or the Company's future contributions. Forfeited non-vested matching accounts totaled \$7,278 and \$32,304 as of December 31, 2024 and 2023. For the year ended December 31, 2024, \$30,414 of forfeitures were used to reduce Company contributions. For the year ended December 31, 2024, no forfeitures were used to reduce administrative expenses.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

#### ***Use of Estimates***

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist. At December 31, 2024, all investments, that were measured at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except for the common collective trusts, which consists of the Putnam Stable Value Fund. The Putnam Stable Value Fund is valued at contract value because it is a fully benefit responsive contract. Mutual funds underlying the investment in the Putnam Stable Value Fund are valued at the daily net asset value ("NAV") as reported by the fund. The NAV is based on the fair value of the investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. The Plan considers a loan to be in default at the end of the quarter following the quarter when payments have not been received. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. The Plan records certain costs for record keeping and participant loan administration. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is August 29, 2025.

### **3. Investments Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends on investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company, a qualified institution.

### **4. Putnam Stable Value Fund**

Participants have the option to invest in a fully benefit-responsive stable value fund called the Putnam Stable Value Fund (the “Fund”), which was established and is maintained by Putnam Fiduciary Trust Company. The Fund invests in guaranteed investment contracts (“GIC’s”) and similar contracts issued by insurance companies, banks and other financial institutions. The Fund also invests up to 75% of its assets in security-backed investment contracts, including separate account products of insurance companies, and at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds. The Fund is valued on a daily basis by Putnam Fiduciary Trust Company. Contributions and redemptions to the Fund may be made daily at the current net asset value.

Because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the statements of net assets available for benefits at contract value. Contract value, as reported by Putnam Fiduciary Trust Company, represents contributions made to the Fund, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Fund at contract value.

The average yield earned by the Fund is calculated by dividing the annualized earnings of all investments in the Fund by the fair value of all investments in the Fund. For the year ended December 31, 2024, the average yield was 4.22%.

### **5. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **6. Tax Status**

The Plan has adopted a non-standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 stating that it was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. The plan administrator has analyzed the tax positions and determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain Plan investments are managed by Voya Institutional Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Event**

Effective January 1, 2025, the Company was merged into Infosys Nova Holdings LLC d/b/a Blue Acorn iCi ("Infosys Nova"). As a result, beginning on January 1, 2025 Infosys Nova became the sponsor of the Plan.
