INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Huvepharma Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Huvepharma Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements related to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A – DESCRIPTION OF THE PLAN

The following description of the **Huvepharma, Inc. (the Company) 401(k) Profit Sharing Plan and Trust (the Plan)** provides only general information. Participants should refer to the **Plan** document for a more complete description of the **Plan's** provisions.

General

The **Plan** is a defined contribution plan covering substantially all employees of the **Company**, as defined in the **Plan** document, who are twenty-one years of age or older. The same requirements must be met for purposes of being eligible for safe harbor matching contributions from the **Company**. The participant must be employed on the last day of the **Plan** year to be eligible for any discretionary nonelective contributions. If continuous service is terminated by death, disability, or retirement, participants or their beneficiaries will be eligible to receive any discretionary nonelective contributions that the **Company** may make for the year in which employment is terminated. The **Plan** is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute up to 90% of annual compensation as pretax or Roth elective deferrals, as defined in the **Plan** document. If a newly eligible participant fails to file a salary reduction election with the **Plan** administrator, such participant will be automatically enrolled in the **Plan** to contribute 2% of pre-tax eligible compensation and those contributions are invested in a default fund until changed by the participant. The default fund is currently established as the Vanguard target dated funds. Participants who have attained age 50 before the end of the **Plan** year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the **Plan**. The **Plan** currently offers various mutual funds as investment options for participants. The **Company** makes safe harbor matching contributions equal to 100% of the participant's elective deferral, not to exceed 6% of the participant's annual compensation. The **Company** may also make discretionary matching contributions not to exceed 4% of the participants compensation. In addition, the **Company** may make nonelective contributions to the **Plan**, in accordance with the **Plan** document. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the **Company's** safe harbor matching, discretionary matching and any discretionary nonelective contributions, and an allocation of **Plan** earnings or losses. Each participant is charged with an allocation of administrative expenses and fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the **Plan** document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, safe harbor matching, discretionary matching and any discretionary nonelective contributions from the **Company**, and actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and generally bear interest at prime plus 1%. The maximum term for all loans is five years, except for loans used to acquire a principal residence for which the **Plan** administrator may permit a longer repayment term not to exceed thirty years. Principal and interest are paid ratably through bi-weekly payroll deductions. A participant can have up to two active loans at one time, only one of which may be a principal residence loan.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, the participant or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in their account if their vested interest does not exceed \$1,000. If the vested interest exceeds \$1,000 but is less than \$5,000, the participant or beneficiary can elect to receive a lump-sum amount, or the vested interest will be automatically rolled over to an IRA account for the benefit of the participant or beneficiary at a provider selected by the **Plan** administrator. If the vested interest exceeds \$5,000, the participant or beneficiary can elect to receive a lump-sum or partial amount, or an amount in installments with the option to defer until retirement age.

Payment of Benefits (Continued)

Distributions may also be taken by participants prior to termination of service in the event of financial hardship, as defined in the **Plan** document.

Participants who are age fifty-nine and a half or older may also withdraw from their vested account balance prior to termination of service. Certain of these withdrawals may be subject to penalty, in accordance with the Internal Revenue Code (IRC).

If a qualified domestic relations order is received by the **Plan** administrator, all or a portion of the participant's account balance may be used to satisfy the obligation.

Forfeited Accounts

During the years ended December 31, 2024 and 2023, additions to forfeited nonvested accounts including earnings totaled \$143 and \$1,766, respectively. These accounts may be used to reduce employer contributions or to pay **Plan** administrative expenses. Employer contributions were reduced by \$0 for each of the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,888 and \$2,745, respectively .

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the **Plan** have been prepared on the modified cash basis of accounting, which is a basis of accounting other than generally accepted accounting principles. Accordingly, investment income is recognized when received, disbursements are recognized when made, and employer and participant contributions, if any, are accrued at year end.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the **Plan** administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Accounting for Uncertainty in Income Taxes

The **Plan** recognizes material amounts of uncertain tax positions as income tax expense. The **Plan** recognizes accrued interest and penalties associated with uncertain tax positions as part of deductions from net assets.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a timely transaction with an independent buyer in the principal market, or in the absence of a principal market, the most advantageous market for the asset or liability. See Note D.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as fees and are expensed when incurred. The **Plan** administrator reviews the collectability of all notes receivable and any delinquent notes receivable are recorded as distributions based on the terms of the **Plan** document.

Payment of Benefits

Benefits payments are recorded when paid by the **Plan**.

Administrative Expenses and Fees

Pursuant to provisions of the **Plan**, administrative expenses incurred in the administration of the **Plan** may be paid by the **Plan** or by the **Company**. The administrative expenses paid from **Plan** assets are allocated to all participants. Investment advisor expenses are currently being paid by the **Plan**. All other direct administrative expenses are currently being paid by the **Company**.

Administrative Expenses and Fees (Continued)

Pursuant to the provisions of the **Plan**, fees paid from the **Plan** are charged directly to the account of the participant on whose sole behalf the fee was incurred.

Subsequent Events

The **Plan** administrator has evaluated subsequent events that have occurred up through August 29, 2025, the date the financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024, that required recognition or disclosure in the current period financial statements.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The **Plan** administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the **Plan's** independent auditors did not perform any auditing procedures with respect to the following information certified by **Reliance Trust Company** as complete and accurate, except for comparing such information with information included in the **Plan's** financial statements and supplemental schedule:

- Investments at fair value as shown in the accompanying statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends as shown in the accompanying statement of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023.
- All investment-related information in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurement, provides the framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Following is a description of the valuation methodology used for investment assets measured at fair value.

Mutual Funds: The daily closing price as reported by the fund is used to estimate fair value. Mutual funds held by the **Plan** are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Certain mutual funds offered by the **Plan** are subject to redemption fees, up to a maximum of 2%, for shares held less than ninety days, depending on the mutual fund. In addition, certain mutual funds only allow shares to be bought and sold one to two times within a specified time frame that ranges from thirty to ninety days, depending on the mutual fund.

As of December 31, 2024 and 2023, all of the **Plan's** investments at fair value are mutual funds and are classified within the fair value hierarchy in Level 1.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

All three administrative committee members participate in the **Plan** and one of them is also an officer of the **Company**. The **Company** is the **Plan** administrator.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the **Company** has the right under the **Plan** to discontinue its contributions at any time and to terminate the **Plan** subject to the provisions of ERISA. In the event of **Plan** termination, participants will become 100% vested in their accounts.

NOTE G – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed ADP, LLC (ADP), the recordkeeper as defined in the **Plan** document, by letter dated July 8, 2014, that the **Plan** and related trust are designed in accordance with applicable sections of the IRC. There have been no amendments to the **Plan** since receiving the determination letter. The **Plan** administrator and the **Plan's** tax counsel believe that the **Plan** is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the **Plan** is qualified, and that the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the **Plan's** financial statements.

For the years ended December 31, 2024 and 2023, the **Plan** administrator believes there were no material amounts of uncertain tax positions. Additionally, there were no amounts of interest or penalties recognized in the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 or the statements of changes in net assets available for benefits (modified cash basis) for the years then ended. Further, the year ended December 31, 2021, and all years subsequent remain subject to examination.

NOTE H – RISKS AND UNCERTAINTIES

The **Plan** invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
