Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

December 31, 2024, and 2023

1. Description of Plan

The following description of the Concerto Health AI Solutions 401(k) Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on August 23, 2018, is a profit-sharing plan, available to all employees of Concerto AI, LLC (the Company) who have met the eligibility requirements stipulated by the Plan. The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

In February 2020, assets of the Vector Oncology, LLC 401(k) Plan in the amount of \$7,864,449 were transferred into the Concerto Health AI Solutions 401(k) Plan. Also in February 2020, assets of the Prometrics LLC 401(k) Plan in the amount of \$9,227,563 were transferred into the Concerto Health AI Solutions 401(k) Plan. In March 2020, assets of the Precision Health AI, LLC 401(k) Plan in the amount of \$420,318 were transferred into the Concerto Health AI Solutions 401(k) Plan.

In January 2023, assets of the Tera Recon Inc. 401(k) Plan in the amount of \$18,887,216 were transferred into the Concerto Health AI Solutions 401(k) Plan.

Eligibility

In general, employees are eligible to participate in the Plan upon attainment of age 18. Employees who meet the eligibility requirements can enter into the Plan on the date requirements are met.

Contributions

Each year, participants may contribute a dollar amount or percentage from 1% through 90% of their pretax annual compensation as defined by the Plan. Participant's contributions are subject to limitations imposed by the Internal Revenue Code, which was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively (plus additional \$7,500 for certain eligible catch-up contributions for participants age 50 and older in 2024 and 2023, respectively). Participants may also designate a portion of their contributions as Roth 401(k) contributions, which are taxable to the participant at the time of deferral. The Plan has an automatic deferral provision at 2% of compensation.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions (continued)

The employer makes matching safe harbor contributions for all eligible participants equal to up to 4% match of the Participant's compensation percentage which is deferred as an elective deferral. Such contributions were \$2,611,563 and \$2,612,840 for the years ended December 31, 2024 and 2023, respectively.

The employer may also make non-elective discretionary profit-sharing contributions. No such contributions were made for the years ended December 31, 2024, and 2023.

Investment Options

All of the assets of the Plan are held by Reliance Trust Company. All investments are fully participant directed. Participants may direct the investment of their contributions and the Company matching contribution into any of the Plan's available investment options.

Participant Accounts

The account of each participant reflects a separate record of participant contributions, Company matching and discretionary contributions, withdrawals, expenses, and investment gains and losses.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon, including salary deferrals, Roth 401(k) deferrals, catch up-contributions and rollovers. Participants are immediately vested in safe harbor contributions and profit-sharing contributions.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

1. Description of Plan (continued)

Notes Receivable from Participants (continued)

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a minimum of \$1,000 and may only have two loans outstanding at a time. Loans must be repaid over the agreed term period. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the balance in the participant's account. The loan bears interest at a rate that is determined by the Plan Administrator based on prevailing market conditions and is fixed over the life of the note. Interest rates on participant loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the value of their account or through installments over a certain period at the participant's election. Active participants may also withdraw funds from their accounts under certain hardship conditions.

Forfeitures

As participants are always 100% fully vested in their total account balances, there are no forfeited non-vested accounts in the Plan.

Administrative Expenses

All costs related to the administration of the Plan, other than loan servicing fees, are paid by the Company.

2. Summary of Accounting Practices

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

2. Summary of Accounting Practices (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests primarily in various mutual fund securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Benefit Payments

Benefits are recorded when they have been approved for payment and paid by the Plan.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of both realized and unrealized gains (losses) on these investments.

2. Summary of Accounting Practices (continued)

Fair Value of Financial Instruments

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

3. Information Certified by the Trustee

The Company entered into an agreement with the Reliance Trust Company. Pursuant to the trust agreement, the assets of the trust are held and administered by the Reliance Trust Company, the trustee, as of December 31, 2024, and 2023 and for the years then ended. The trustee holds mutual funds stated at fair value and common collective trusts stated at contract value. In accordance with the trust agreements, the trustee holds the Plan assets and executes investment transactions. All investment information disclosed in the accompanying financial statements, including investments and notes receivable from participants at December 31, 2024 and 2023, and interest and dividends and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained and certified as complete and accurate by the Reliance Trust Company.

4. Fair Value Measurements

Under US GAAP, a framework for measuring fair values has been established to clarify the definition of those fair values and expand disclosures about assets and liabilities measured at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy described under US GAAP are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements (continued)

The Plan's investment in the common collective trust is measured using the NAV per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, no further contributions could be made.

6. Party-in-Interest and Related Party Transactions

During 2024 and 2023, certain Plan investments are held by Reliance Trust Company. Reliance Trust Company is also the trustee and recordkeeper of the Plan, therefore, these transactions, qualify as party-in-interest transactions and notes receivable from participants and interest.

7. Tax Status

The Plan adopted a Prototype Non-Standardized Profit-Sharing Plan, an Automatic Data Processing prototype plan. In accordance with Revenue Procedure 2005-16, the Company has chosen to rely on the advisory opinion letter dated October 6, 2020. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended since receiving the advisory opinion letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
