### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Deco Products 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Deco Products 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Notes 3 through 5 to the financial statements, are complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. Description of Plan

The following description of the Deco Products (Company) 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

##### a. General

The plan is a defined contribution plan with 401(k) plan provisions covering all employees of Deco Products Company, LLLP who have completed six months of service and are not subject to a collective bargaining agreement. An employee may become a participant in the plan on the first day of the month following the date on which the employee meets the eligibility requirements. The plan is subject to the provisions of the Employee Retirement Income Security Tax Act of 1974 (ERISA).

In December of 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect.

The plan is administered by the Company's Partner Group. The Partner Group has overall responsibility for the operation and administration of the plan. The Partner Group determines the appropriateness of the plan's investment offerings and monitors investment performance of the plan.

##### b. Contributions

Participants may elect to contribute up to 90% of their annual eligible compensation as pre-tax or Roth contributions as defined in the plan subject to the following limitations. The maximum amount an individual can contribute to the plan in any calendar year is limited to the applicable limit under the Internal Revenue Code Section 402(g). The maximum amount under the Internal Revenue Code Section 402(g) is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution is \$7,500 for each of the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants can change their elective deferral contribution withholding rates each payroll period. Participants direct the investment of their contributions into various investment options offered by the plan.

The plan currently offers various mutual funds, collective trust funds, and an insurance investment contract as investment options for participants. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation.

**1. Description of Plan (Continued)****b. Contributions (Continued)**

The Company contributes as a safe harbor matching contribution where 100% of deferrals that do not exceed 3% of eligible compensation, plus 50% of deferrals that exceed 3% of eligible compensation but do not exceed 6% of eligible compensation, with a maximum Company matching contribution of 4.5% of eligible compensation. Additional amounts may be contributed at the Company's discretion, as described in the plan.

**c. Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Company's matching contribution and plan earnings. In addition, contract fee expenses are deducted from each participant's account. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d. Vesting**

Participants are immediately vested in the value of their voluntary contributions and Company safe harbor matching contributions, including actual earnings thereon.

**e. Notes Receivable from Participants**

Effective June 23, 2021 through October 31, 2023, the plan did not permit new loans. Effective November 1, 2023, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through biweekly payroll deductions.

**f. Retirement, Disability and Death Benefits**

On termination of service due to retirement, disability or death, the plan permits several payment options, including lump sum payments, substantially equal installment payments, and partial withdrawals. The plan also provides for certain in-service withdrawals, including hardship and withdrawals at age 59 ½, as defined in the plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**g. Hardship Withdrawals**

The amount of the withdrawal cannot exceed the amount of the hardship but may include the amount necessary to pay federal and state taxes. Hardship withdrawals can be for medical expenses, costs to purchase principal residence, tuition, related educational fees, and room and board expenses for the next twelve months of postsecondary education, payments to prevent eviction from principal residence, payments for burial or funeral expenses and expenses for the repair or damage to principal residence that would qualify for the casualty deduction under the Internal Revenue Code. Earnings on accounts, safe harbor, qualified nonelective or qualified matching contribution accounts may not be included in the hardship withdrawal.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

b. Investment Valuation and Income Recognition

The plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments purchased and sold as well as held during the year.

c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative fees when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

d. Payments of Benefits

Benefits are recorded when paid.

e. Management Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

f. Administrative Expenses

Certain expenses of the plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

g. Date of Management's Review

Management has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.

4. Guaranteed Interest Fund

In 2023, the plan had a fully benefit-responsive guaranteed interest fund with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintained the contributions in a general account product until the funds were transferred into another investment during 2024. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

Because the guaranteed interest fund is fully benefit-responsive, contract value is the relevant measurement for the guaranteed interest fund. The guaranteed interest fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the plan by Reliance Trust Company and Empower Annuity Insurance Company of America, represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the group contract issuer or otherwise. The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

4. **Guaranteed Interest Fund (Continued)**

Certain events might limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan’s prohibition on competing investment options or deletion of equity wash positions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan trustees do not believe any events, which would limit the plan’s ability to transact at contract value with plan participants or the issuer are probable of occurring.

The guaranteed interest fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for the years ended December 31, 2024 and 2023 is 1.66% and 1.48% respectively.

5. **Fair Value Measurements**

The plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the report date.

5. Fair Value Measurements (Continued)

The fair value measure accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs include quoted prices for similar assets and liabilities in active markets, and level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when level 1 or level 2 inputs were not available. The plan had no level 2 or level 3 measurements as of December 31, 2024 and 2023.

Accounting guidance on fair value measurements are classified and disclosed in one of the following three categories:

**Level 1 Fair Value Measurements**

The fair values of common stocks, certain corporate bonds and U.S. government securities are based on the closing price reported on the active market where the individual securities are traded, when available.

**Level 2 Fair Value Measurements**

The fair value of certain corporate bonds for which quoted market price are not available are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less an appropriate discount.

**Level 3 Fair Value Measurements**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**Collective Trust Funds**

Valued based on the NAV of units of the collective trust. The NAV, as provided by the plan trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their accounts.

7. Income Tax Status

The non-standardized pre-approved plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the underlying non-standardized, pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the plan administrator and the plan's tax counsel believe that the plan is currently being designed and operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified, and the related trust is tax exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. Forfeited Accounts

Forfeited non-vested accounts totaled \$10 for each of the years ended December 31, 2024 and 2023. These accounts will be reallocated to participants in the same manner as employer contributions. Forfeitures of terminated participants' non-vested accounts are used to reduce the Company's match and plan expenses.

9. Related Party Transactions

Certain plan investments are managed by Reliance Trust Company effective November 8, 2023, and previously by Empower Annuity Insurance Company of America, and Empower Trust Company LLC, the custodians as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are paid from the underlying assets within the plan and are not directly paid by the plan. As described in Note 2.f., the plan made direct payments to the third-party administrators and other service providers of \$42,770 and \$10,745 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the plan's operations.

Certain employees and officers of Deco Products Company, LLLP, who may also be participating in the plan, perform administrative services to the plan. Deco Products Company, LLLP does not charge fees for these administrative services to the plan.

10. Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect each participant's account balances and the amounts reported in the statements of net assets available for benefits.
