### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at year end) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### ( 1 ) DESCRIPTION OF PLAN

The following description of the Wuxi Biologics USA LLC 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan sponsored by WuXi Biologics USA LLC, together with participating employer XDC Conjutech USA LLC, (the “Company”) for the benefit of its employees over age 21. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (“ERISA”).

The Plan is administered by the Company’s plan administrator who has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Contributions** – Participating employees may contribute to the Plan up to 80% of their eligible annual compensation as defined in the Plan, as either a pre-tax or Roth deferred contribution. Employees are automatically enrolled as a participant at a deferral rate of 6% of the employee’s eligible compensation unless the employee makes a contrary election. Participation in the Plan commences 60 days following their first day of employment. The automatic deferral rate will increase 1% each year up to a maximum of 10% on January 1 of each plan year. Participants may also contribute, as rollover contributions, amounts representing distributions from other qualified plans. Additionally, participants age 50 or older, who are making deferred contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan agreement. Participants may make changes to their elective deferral contribution rates on a quarterly basis and may terminate their elective deferral at any time.

The Company makes a matching contribution of participants’ elective deferral contribution of 100% of the first 2% and 50% for the next 4% of eligible participant contributions, with a maximum Company matching contribution of 4% of eligible participant compensation (qualified automatic contribution arrangement safe harbor contribution). The Company, at its discretion, may also make annual discretionary profit-sharing contributions to the Plan which will be allocated to participants, as defined in the Plan. For the year ended December 31, 2024, the Company did not make a profit-sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”).

**Participant investment account options** – The Plan currently offers a variety of common/collective trusts, mutual funds, pooled separate accounts, and a fixed income guaranteed option as investment options for participants. Participants may change their investment designation with respect to their account balance and future contributions at any time.

**Participant accounts** - Each participant’s account is credited with the participant’s contributions, rollover contributions from other qualified plans, Company matching contributions, the Company’s discretionary profit-sharing contributions, if any, the related earnings (losses) from investment options chosen by each individual and an allocation of administrative expenses. Allocations of earnings (losses) and expenses are based on account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ( 1 ) DESCRIPTION OF PLAN (CONTINUED)

**Vesting** – Participants are fully vested in their deferral and rollover contributions plus actual earnings (losses) thereon at all times. Participants become 50% vested in Company matching contributions plus actual earnings (losses) after one year of service and fully vested after two years of service. Participants become 20% vested in their respective portion of the Company's profit-sharing contributions after two years of service, and vest an additional 20% annually thereafter until fully vested in the sixth year of qualified service. In the event of retirement after attainment of age 65, death, disability or termination of the Plan, participants become fully vested.

**Forfeitures** – If a participant terminates employment for any reason other than death, disability or retirement, the unvested portion of the participant's account, if any, is forfeited. Forfeitures may be used for payment of Plan expenses or to offset employer matching contributions. Employer contributions were reduced by \$48,475 and administrative expenses were reduced by \$17,822 from forfeited non-vested accounts during the year ended December 31, 2024. There were no unallocated forfeitures at December 31, 2024 and 2023.

**Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** – On termination of service, retirement, death or disability, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account or a series of cash payments if they have achieved retirement age.

### ( 2 ) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ( 2 ) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits** – Benefit payments are recorded in the period in which the benefit is paid.

**Administrative expenses** – Costs of administering the Plan are paid by the Company except for investment management expenses and fees incurred for participant loans and distribution payments to participants. Fees for participant loans and distribution payments are charged to individual participant accounts.

#### ( 3 ) INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company held certain Plan investment assets and executed investment transactions from December 31, 2023, through September 30, 2024, and ADP held the Plan's investment assets and executed investment transactions from January 1, 2024, to December 31, 2024. The trustees (or custodians) of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest
- Interest income on notes receivable from participants
- Supplemental schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### ( 4 ) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. Participant transactions (purchases and sales) may occur daily and there are no restrictions on redemptions. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Additionally, there are no unfunded commitments.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts are valued at the NAV of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily and there are no restrictions on redemptions. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. Additionally, there are no unfunded commitments.

**( 4 ) FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### ( 5 ) PRINCIPAL FIXED INCOME GUARANTEED OPTION CONTRACT

The Plan had a benefit-responsive fixed income guaranteed option investment contract (PFIGO) with Principal Life Insurance Company (PLIC). PLIC maintained the contributions in a separate account. The account was credited with interest income at the crediting rate, which was reset on a semiannual basis, and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than one percent. The crediting interest rate was reviewed semi-annually for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract was fully benefit responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PLIC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations would have been affected by future economic and regulatory developments. There were no reserves against contract value for credit risk of contract issuer or otherwise.

Certain events might have limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events were probable of occurring at December 31, 2023 that might have limited the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants. The Plan terminated the contract upon the change in recordkeeper and custodian effective January 1, 2024.

#### ( 6 ) RELATED PARTY TRANSACTIONS

One of the Plan's investments is a common/collective trust managed by ADP. ADP is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$85,360 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### ( 7 ) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their employer matching and profit sharing contributions.

#### ( 8 ) TAX STATUS

The Internal Revenue Service has determined that the prototype 401(k) plan is designed in accordance with applicable sections of the IRC and informed the Trustee of such in a letter dated October 6, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrative committee/plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ( 9 ) RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 18% of the Plan's investments were invested in the Vanguard 500 Index Fund.

#### ( 10 ) SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 29, 2025, which is the date the financial statements were available to be issued.
