## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Newco Distributors, Inc. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Newco Distributors, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Newco Distributors, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

Newco Distributors, Inc. (the Company) sponsors the Newco Distributors, Inc. Retirement Plan (the Plan). The Plan was adopted October 1, 1993 with a year end of December 31 and is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The Plan consists of a tax deferred savings program (401(k)) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Company executed an amendment and restatement of the plan document and transferred all plan assets to a new asset custodian. As part of this restatement, the employer contribution provisions were revised to comply with IRS safe harbor requirements. Additionally, the automatic elective deferral percentage was updated to 3%, and the maximum elective deferral limit was set at 90% of eligible compensation.

The following description of the Newco Distributors, Inc. Retirement Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility and Participation

Employees are eligible to participate in the Plan when they have completed six months of service, in which the employee completes at least 1,000 hours, and attainment of age 21. Participation begins on the first day of each month of the Plan year coincident with or immediately following the completion of the participation requirements.

Contributions

Participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan, and participants qualifying for age-based catch-up provisions may contribute additional amounts of pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The participant's deferral rate is subject to automatic annual escalation up to a maximum of 6%.

The Company offers a matching contribution which is 100% of the first 2% of employee contributions, and 50% of employee contributions greater than 2%, but less than or equal to 6%. The Company may also contribute profit sharing contributions. Participants are eligible to receive a proportionate share of the profit sharing contribution if they meet the eligibility requirements and are employed on the last day of the Plan year. The Company did not make a profit sharing contribution during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures from terminated participants' non-vested accounts and charged with an allocation of administrative expenses and plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocation of forfeitures, if any, will be made based upon a participant's proportionate share of matching contributions paid during the applicable plan year to all participants in the Plan.

Vesting

Participants are immediately vested in their salary deferral contributions and rollover accounts plus actual earnings thereon. Vesting in the Company's matching plus actual earnings thereon is based on years of service, which includes years in which the employee completes more than 1,000 hours of service, according to the following schedule:

Notes Receivable from Participants

The Plan does not allow for notes receivable from participants.

Payment of Benefits

Termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant is also entitled to receive the value of the vested interest in his or her account as a lump sum distribution. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59 and a half, the participant is allowed to withdraw certain funds from the Plan. Retirement age under the Plan is 65 years.

Forfeitures

Forfeitures of non-vested plan sponsor matching contributions are retained in the Plan and may be used to reduce future Company contributions and pay plan expenses. For the year ended December 31, 2024, \$30,384 of forfeitures were used to reduce Company matching contributions. As of December 31, 2024 and 2023, the balances in the forfeitures account were \$5,226 and \$16,113, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that may affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 27, 2025, the date the financial statements were available to be issued, and concluded that there were no events that require recording or disclosure in the financial statements as of December 31, 2024.

**NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIANS**

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC (2024) and Ascensus Trust Company (2023), the asset custodians of the Plan. The asset custodian transitioned in January 2024, and as such income in the amount of \$46,157 was earned prior to the transition, and is not covered by the current custodian's certification. This amount has been excluded from the investment income noted below.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The investment is classified within Level 1 of the valuation hierarchy.

*Money market funds:* Fair value is based upon the carrying value based upon the short term nature. The investment is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Investments were managed by ADP Retirement Trust Services, LLC, the custodian for the Plan, and therefore, these transactions are considered to be exempt party-in-interest transactions. The Plan paid certain administrative fees in 2024. The Company paid certain administrative expenses of the Plan. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, affected participants will become 100% vested in their accounts.

**NOTE 7 - TAX STATUS**

Effective January 1, 2024, the Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan (the NSPA Plan) sponsored by ADP Retirement Trust Services, LLC. The Internal Revenue Service has determined and informed the Trustee by a favorable opinion letter dated June 30, 2020, that the NSPA Plan is designed in accordance with the applicable sections of the Code. The NSPA Plan's opinion letter is being relied on by the Plan. The Plan has been amended since receiving the opinion letter. However, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - PROHIBITED TRANSACTIONS**

It was discovered that for certain participants who received distribution during the year 2023 Plan year, the participants vesting percentages were not properly assigned. The errors resulted in both over and under payment of benefits to participants. The Plan has elected to implement the contribution correction method to credit participants whose account balance was improperly forfeited in an amount equal to the improper forfeiture plus lost earnings.

During the Plan year 2023, it was discovered that participant deferrals and related employer matching contributions were missed for one participant's termination check. The Company determined the amount of corrective contribution for the error, including lost earnings, to be \$190 and made the corrective contribution during the 2024 Plan year.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
