Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Patriot Machine Inc. 401(k) Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements were prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Our opinion is not modified with respect to that matter.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

December 31, 2024

1. Description of the Plan

The following brief description of the Patriot Machine Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective November 1, 1995, and most recently restated effective June 1, 2022. The Plan sponsor is Patriot Machine Inc. (the Company). The Plan covers all full-time and part-time employees of the Plan sponsor who have met certain age, hour and service requirements. Employee participation in the Plan is voluntary.

Contributions

Participants may contribute up to the lesser of 90 percent of their eligible compensation or the amount permitted by Internal Revenue Service (IRS) regulations, which was \$23,000 in 2024. Employees who meet certain age requirements are also permitted to make catch-up contributions. The Plan also permits Roth and rollover contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at three percent (3%) of eligible compensation.

The Company may elect to make nonelective contributions as outlined by the Plan agreement and as determined on an annual basis by the Plan sponsor. For the 2023 plan year, the Company elected to allocate a nonelective contribution totaling \$1,280,000 to participant accounts. This was comprised of \$1,200,000 of employer contributions, received in May 2024, and \$80,000 of forfeited accounts. All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

Participant Accounts

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual fund investment options and a collective trust fund as offered by the Plan. Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions and Plan earnings or losses and Plan expenses.

Patriot Machine Inc. 401(k) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions plus actual earnings thereon. Employer contributions vest at 20 percent each year beginning after their second year of service, with full vesting after six years of service as defined by the plan document.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1-5 years, or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's vested account and bear interest at a rate of prime plus 1 percent. Principal and interest is paid ratably through weekly payroll deductions.

Forfeitures

The non-vested portion of a participant's account balance may be used to reduce employer contributions. As of December 31, 2024 and 2023, the balance of the forfeiture account was \$54,725 and \$63,827, respectively. During the year ended December 31, 2024, \$80,000 of forfeited non-vested accounts were applied to the total employer contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as either a lump sum or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service withdrawals under certain conditions. For terminated participant account balances of less than \$5,000, the Plan has the option to make an automatic lump-sum distribution to the participant.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Administrative Expenses

Certain costs of administering the Plan are paid by the Company. Other costs are paid by participants and are included in the Plan's financial statements. Certain expenses are paid for by revenue sharing amounts earned by the plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would be immediately vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the modified cash basis of accounting, a comprehensive basis of accounting other than generally accepted accounting principles. Contributions are recorded when received by the trustee, and distributions and expenses are recorded when paid by the trustee. Investments are recorded at their current market value.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest from investments is recorded on the accrual basis.

Capital gains received and reinvested are included in investment income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (continued)

Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Other than expenses paid by revenue sharing and forfeitures, all expenses are allocated to plan participants. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. During the year ended December 31, 2024, the Plan received revenue sharing income of \$38,026, which was used to pay plan expenses. Such amount was netted against expenses in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Investment Information Certified by Trustee

All investment information disclosed in the accompanying financial statements and schedule, including investments held and participant notes receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest from participant notes receivable for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee. All investments are participant directed.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

Mutual funds are valued at the quoted market prices which represent the net asset value of shares held by the Plan at year end. There are no restrictions on the redemption of these investments.

The Plan invests in the Federated Capital Preservation Fund. The investment uses the net asset value (NAV) reported by the issuer as a practical expedient to establish the value. The primary investment objective of the stable value fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. There are no redemption restrictions for participant directed investments and there are no unfunded commitments. Participant transactions may occur daily.

5. Income Tax Status

The Plan, which is a prototype plan document, has not been submitted to the Internal Revenue Services for individual determination; however, the non-standardized 401(k) plan is covered under a determination letter issued to ADP, Inc., the prototype plan recordkeeper, by the Internal Revenue Service dated October 6, 2020, stating that the non-standardized 401(k) plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The modified cash basis of accounting requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Reconciliation to Form 5500

Certain amounts related to the reclassification of pre-tax amounts to Roth were classified differently in the 5500 than on the financial statements. These classifications did not have any impact on the total net assets or changes in net assets available for benefits.

6. Administration of Plan Assets

The Plan's assets are held by the trustee of the Plan. Employee contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Plan's recordkeeping is performed by an outside recordkeeper. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

7. Related Party Transactions

As noted in Notes 1 and 6, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

8. Subsequent Events

Management has evaluated all subsequent events through August 25, 2025, which represents the date the financial statements were available to be issued.
