## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Fitness Formula Employee 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Fitness Formula Employee 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF PLAN

The following description of the Fitness Formula 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Fitness Formula, Ltd. (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan uses the services of ADP Retirement Services (with the trustee being Reliance Trust Company). All employees that work more than 1,000 hours during the plan year are eligible to join the Plan. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of various investment options. Effective January 1, 2024, the Plan was amended to change the 1,000 service requirement to six months of service to be eligible for elective deferrals. Effective April 1, 2025, the Plan was amended to require individuals to be at least 21 years of age to enter the Plan.

Contributions - Each year, participants may contribute up to 90% of annual compensation (salary deferral contributions), on a pretax or post tax basis, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). After one year of service, participants are eligible to receive a Company discretionary match. For the years ended December 31, 2024 and 2023, the match is equal to 30% and 20%, respectively, of the first 5% of the participant's compensation that a participant contributes to the Plan. Matching contributions are made each payroll period. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's salary deferral contributions, rollover contributions, Company contributions, and plan earnings or losses (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balance, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts - As of December 31, 2024 and 2023, the Plan had \$4,426 and \$82, respectively, included as forfeitures. Forfeited balances can be used to reduce future Company contributions or pay for plan expenses. During the years ended December

31, 2024 and 2023, \$8,868 and \$3,683, respectively, from forfeited nonvested accounts were used to reduce Company contributions.

Notes Receivable from Participants – Participants may borrow from their accounts up to a maximum amount equal to 50% of their vested account balance or \$50,000, whichever is less and are limited to one outstanding loan. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate, plus 1 percent. Principal and interest is paid ratably through payroll deductions.

Administrative Expenses – The Company pays all administrative expenses of the Plan, except for certain contract administrative and trustee fees. Such charges not paid by the Company and not covered by forfeitures are allocated directly to the accounts of the participants (generally based on account balance) and are classified as administrative expenses in the statement of changes in net assets available for benefits. Certain investment advisory fees are paid by the Plan and included in net depreciation in fair value of investments of the related fund as they are paid through a revenue sharing agreement, rather than a direct payment. Administrative expenses paid by the Company are not included in the financial statements of the Plan.

Vesting – Participants are immediately vested in their salary deferrals and rollover contributions, plus earnings thereon. Company matching contributions and earnings thereon vest in accordance with provisions of the plan document as follows:

Participants that leave the Plan because of death, normal retirement, or total and permanent disability, as defined in the Plan, are considered 100% vested. For vesting purposes, a year of service will be credited upon attaining 1,000 hours of service.

Benefit Recording – Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. In-service distributions are allowed if

the participant has reached age 59-1/2. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America U.S. GAAP requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Payment of Benefits – Benefits are recorded when paid. There are no amounts owed to participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition – The Plan's investments are valued at fair value using quoted market prices. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. The mutual funds held by the Plan are deemed to be actively traded.

Individual participant accounts invested in the collective trust funds are maintained on a unit value basis. Participants do not have a beneficial ownership in specific underlying securities or other assets in the fund, but have an interest therein represented by units valued as of the last business day of the period. The funds earn dividends and interest which are automatically reinvested in additional units. The Plan does not have any collective trust fund investments with unfunded commitments or with any redemption restrictions.

Notes Receivable from Participants – The Company has classified participant loans as notes receivable from participants. These notes are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income from notes receivable from participants is recognized when accrued based on individual agreements.

### 3. PARTIES-IN-INTEREST

The Plan holds notes receivable from participants. Certain fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These transactions are exempt from being classified as prohibited transactions under ERISA.

### 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 5. FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP applicable to fair value measurements and disclosure. U.S. GAAP defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

U.S GAAP related to fair value disclosure also establish a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - quoted prices in active markets for identical assets or liabilities;

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The plan sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

6. INVESTMENTS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

7. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken or expected to be taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

### 9. SUBSEQUENT EVENTS

The Company has evaluated subsequent events occurring through August 25, 2025, the date that the financial statements were available to be issued, for events requiring recording or notes disclosure in the Plan's financial statements. As disclosed in Note 1, the Plan was amended to require participants to be 21 years of age to be eligible to enter the Plan.
