

**NOTE 1 DESCRIPTION OF THE PLAN**

**Plan Description**

ITS, Inc. 401(k) Retirement Plan and Trust (the Plan), established July 1, 1993, is a defined contribution plan covering all full-time and part-time employees of ITS, Inc. (the Company and Plan Sponsor) who are age eighteen or older. The Plan is subject to the provisions of ERISA. Security National Bank of Sioux City, Iowa serves as Trustee of the Plan. The Trustee chooses the investment options for the Plan's assets. Participants direct their accounts to the available investment options.

**Contributions**

The Company has agreed to make basic contributions on behalf of each participant who has elected to reduce his or her compensation under a compensation reduction agreement. The basic contribution as pre-tax 401(k) or Roth contribution made on behalf of the participant is equal to the amount specified in that agreement, provided that the contribution does not exceed certain established overall limitations. The maximum employer contribution allowed, for participants who entered the plan prior to July 1, 2016, is equal to 40% of the participant's elective deferrals up to a maximum of 5%, and, for participants who have entered the plan on or after July 1, 2016, is equal to 50% of the participant's elective deferrals up to a maximum of 8% of the participant's compensation as defined by the Plan. This election percentage of a participant may be changed on a monthly basis. All employees who are eligible to participate in the Plan but are not deferring shall be automatically enrolled in the Plan with elective deferrals withheld in the amount of 4% of compensation or may exercise their right to opt out. In conjunction with this feature, the Plan has incorporated an annual automatic employee contribution increase of 1% for any participant deferring less than 10% unless the employee elects to opt out of this automatic increase. Effective February 1, 2024, the annual automatic employee contribution increase of 1% is in effect for any participant deferring less than 15% unless the employee elects to opt out of this automatic increase. Any participant may make rollover contributions, transferring funds either directly or indirectly to the Plan from another qualified plan.

Participants direct their contributions and the Company match into the investment options of their choice. Each participant may contribute up to the annual indexed limitation in whole percentages of total pay each month under a salary reduction agreement. The participant amount contributed was limited to \$23,000 per participant in 2024 and \$22,500 per participant in 2023. The Plan allows catch-up contributions as indexed by the Internal Revenue Service (IRS) for individuals 50 years of age or older, which will be matched based on the Plan formula.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings. Allocations are based on the participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeitures**

Participants are vested immediately in their contributions plus actual earnings thereon. Company contributions vest 20% per year and are fully vested after five years of vesting service. Forfeitures are applied to reduce employer-matching contributions. The forfeited amount used to offset contributions was \$91,406 and \$60,358 during 2024 and 2023, respectively. Forfeitures for nonvested account balances available for future years as of December 31, 2024 and 2023 were \$7,387 and \$619, respectively.

**Payments of Benefits**

Upon normal retirement age at 65, death, total and permanent disability, or termination of employment, participants (or the beneficiary) are entitled to: (a) a lump-sum distribution; (b) payment in monthly, quarterly, or annual installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant or the joint life and last survivor expectancy of the participant and beneficiary; or (c) automatic rollovers on vested balances between \$1 and \$5,000. The amount payable shall be equal to the value of the participant's vested basic contribution sub-account, rollover contribution sub-account, and matching contribution on the next valuation date which follows the retirement, death, disability, or termination of employment.

**Notes Receivable from Participants**

Any active participant may apply for a loan from the Plan, provided the loan amount does not exceed the lesser of \$50,000 or 50% of the participant's nonforfeitable (i.e., vested) account balances, as reflected by the books and records of the Plan. Furthermore, a participant may not request a loan for less than \$1,000 and may request a loan only once in any six-month period, and have only one loan with an outstanding balance at a time. Interest charged is fixed at the national prime rate at the date of the loan. The Plan's loan policy allows participant loans for any purpose. Loan terms call for repayment within five years, or, if a qualifying home loan, 15 years. Principal and interest is paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Plan is sponsored by the Company. The Plan year ends on December 31. Significant accounting policies followed by the Plan are presented below.

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates in Preparing Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans determined by the Plan administrator to be in default are reclassified as distributions based upon the terms of the Plan document.

**Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses include quarterly fees charged by the Trustee and are absorbed by the Plan. Certain administrative expenses are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

**NOTE 3 SUMMARY OF INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of the investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Security National Bank (SNB), the Trustee of the Plan.

**NOTE 4 TRANSACTIONS WITH PARTIES-IN-INTEREST**

Plan investments are held by the Trustee, who is a party-in-interest. Fees paid for the administrative services rendered by the Trustee totaled \$228,559 and \$188,899 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market:* Valued at cost, which approximates fair value.

**NOTE 6 TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan, indicating the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under current income tax law. The Plan has not applied for its own determination letter. The Plan administrator believes that the Plan is designed, and currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in employer contributions.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.
