## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of Spinoso Real Estate Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Spinoso Real Estate Group, LLC (the Company), who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees are eligible to begin salary deferrals as of the first day of the Plan quarter following the date they attain the age of twenty-one (21) and have completed three months of service. Employees are eligible for safe harbor non-elective contributions the first day of the quarter after attaining the age of twenty-one (21) and completing one year of service in which the employee worked 1,000 hours. In addition to the above safe harbor non-elective requirements, the discretionary matching and discretionary profit-sharing features of the Plan require employees to be employed with the Company as of the last day of the Plan year.

#### **Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to certain limits established by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to contribute additional catch-up contributions. In addition, participants have the option to elect to have roth contributions made to the Plan. Roth contributions are included in a participant's taxable gross income for the year in which the contribution is made. Participants may also contribute amounts representing distributions from other tax-qualified retirement plans.

Discretionary matching or profit-sharing contributions may be made at the option of the Company's management. No discretionary contributions were made for the years ended December 31, 2024 or 2023.

Additionally, the Company will make safe harbor non-elective contributions to the Plan in an amount not less than 3% of participant's compensation. For the years ended December 31, 2024 and 2023, a 3% safe harbor non-elective contribution was made for all eligible employees.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of (a) the Company contributions, (b) actual earnings/losses thereon, and (c) forfeitures of non-vested balances from participant distributions. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions, Company safe harbor non-elective contributions, and actual earnings/losses thereon.

Company discretionary contributions plus earnings thereon become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or partial payments.

Participants with a balance of less than \$1,000 will receive a lump sum payment of their account balance in cash, while participants with a balance of \$5,000 or less will be rolled into an individual retirement plan designated by the Plan administrator, unless the participant directs otherwise.

In-service withdrawals are permitted for participants that are age 59 ½ or older.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their contributions, not including earnings. All hardship withdrawals must comply with rules relating to hardships, which are uniformly applicable to all participants.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan agreement. The loan and interest thereon shall be repaid over a period not to exceed five years (except for certain residential loans which can extend up to fifteen years). The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest payments are paid ratably through payroll deductions.

### **Investment Options**

Investments are held within various investment funds offered and maintained by Voya Retirement Insurance and Annuity Company. Contributions to the Plan are invested, at the discretion of the participant, in one or a combination of available investment options.

### **Forfeited Accounts**

Forfeiture amounts can be used to reduce certain plan administrative expenses or Company contributions. The forfeiture balance as of December 31, 2024 and 2023 totaled \$2,965 and \$2,042, respectively. No forfeitures were used to pay for plan administrative expenses or reduce Company contributions for the years ended December 31, 2024 or 2023.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles general accepted in the United States of America.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Fair Value Measurement - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board (FASB) *Accounting Standard Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- *Level 1*: Valuations based on quoted prices for in active markets for identical assets or liabilities that the Plan has the ability to access.
- *Level 2*: Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- *Level 3*: Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 3.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

The Company absorbs reasonable expenses incurred in the administration of the Plan. Expenses relating to certain participant transactions, such as fees related to distributions and notes receivable from participants, are deducted from the participant's account as the transactions occur.

### Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

## 3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets and liabilities for which fair values are estimated using the net asset value (NAV) practical expedient:

- *Pooled separate accounts*: valued at net asset value of units held by the Plan, based on the accumulated values of the underlying investments. Unit values are determined daily based on the net asset value of the quoted market prices of the underlying investment, the fund's dividends and the contracts separate account changes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments using NAV per share practical expedient amounted to \$5,956,462 and \$3,919,580 as of December 31, 2024 and 2023, respectively.

#### Pooled Separate Accounts

Lifecycle index funds seek to provide capital appreciation and current income by investing in mutual funds according to an asset allocation strategy targeted at a specific retirement date.

Large cap funds seek capital appreciation and current income by investing in equity securities of corporations that regularly pay dividends and by tracking the performance of the S&P 500 Index.

Small/mid cap funds seek to provide long-term growth of capital by investing in equity securities of mid and small capitalization companies.

International funds seek to provide long-term growth of capital by allocating their assets among stocks in markets around the globe.

Bond funds seek maximum total return through income and capital appreciation consistent prudent investment management by investing in a portfolio of corporate, government, and mortgage bonds.

Balanced funds seek conservation of capital, current income, and long-term growth of capital and income by investing in a broad range of securities including common stocks and investment-grade bonds.

Money market funds seek to provide a high level of current income consistent with preservation of capital and liquidity by investing in government securities or cash.

### 4. INVESTMENTS

The Plan administrator has received certifications from Voya Retirement Insurance and Annuity Company, the custodian of the Plan, that states that the following information is complete and accurate as of December 31, 2024 and 2023 and for the years then ended.

## **5. GUARANTEED INCOME FUND WITH INSURANCE COMPANY**

The Plan is invested in a fully benefit-responsive income contract with Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed income fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value to any fund that is not classified as a competing fund. Transfers from the guaranteed income fund may not be made within ninety days to a competing fund.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the contract at December 31, 2024 and 2023 was \$187,080 and \$154,519, respectively. The crediting interest rate is based on a contractually guaranteed interest rate that may not be less than one percent. Such interest rates are reviewed on a semi-annual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. The group investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, who acts as the Plan's custodian. Benefit Plans Administrative Services, LLC is the Plan's administrator. Transactions with these companies qualify as party-in-interest transactions.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. Therefore, these related transactions qualify as party-in-interest transactions.

## **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## **8. INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed by letter for the prototype plan adopted by the Plan, dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

## **9. SUBSEQUENT EVENTS**

Effective June 1, 2025, the Plan changed from using Voya Retirement Insurance and Annuity Company as the Plan custodian to using ADP, Inc. as the Plan recordkeeper and ADP Retirement Trust Services, LLC as the Plan trustee.

Plan management has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.
