In 2022, the SemaSys, Inc. OKC Division 401 Profit Sharing Plan was merged into another 401k Plan that is sponsored by the parent company. The Form 5500-SF was filed for the 2022 Plan Year showing the asset transfer under Uni-Sun Inc. Employees Profit Sharing Plan. The old Plan administrator, John Hancock Financial Services, was apparently supposed to prepare and file a Final Form 5500 for the 2022 plan year. This Final Return was not prepared by either John Hancock Financial Services or by ADP, the new administrator.
