We have performed an audit of the financial statements of South College of Tennessee 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### ***Opinion***

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the South College of Tennessee 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. South College of Tennessee, Inc. (the College) is the Plan Administrator.

General

The Plan, which was established on January 1, 1997, is a defined contribution plan covering all employees age 18 and over of South College of Tennessee, LLC (the "College"). Employees of the College are eligible to become participants in the Plan immediately upon employment. Employees may elect to defer salary on the first day of each month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation not to exceed statutory limitations established annually by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, self-directed brokerage account options, and contract with insurance company as an investment option for participants. Eligible employees, who do not elect otherwise, are automatically enrolled in the Plan with a deferral of 6%. The College may elect to contribute to the Plan amounts in the form of discretionary matching contributions. Contributions are subject to certain limitations. Employees become eligible for the employer discretionary matching contributions on the date the requirement of age 18 is met. There were employer matching contributions in the amount of \$2,072,525 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, the participants' investment earnings and is charged with an allocation of the Plan's investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Prior to January 1, 2019, participants could borrow from their participant account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested interest in the Plan. The loans were secured by the balance in the participant's account and bear reasonable interest rates, currently at 5.00%. Loan terms currently range from 1 to 5 years. Principal and interest are paid ratably through semi-monthly payroll deductions. Effective January 1, 2019 participants may no longer borrow from their accounts.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the College's discretionary matching contributions is based on years of service in accordance with the following schedule:

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account, in a single lump-sum distribution.

Allocation Provisions

Earnings from investments are allocated to a participant's account based on the percentage of the participant's respective ownership of the investments.

Forfeited Accounts

Forfeitures are used to pay administrative expenses and to reduce employer contributions in the Plan. At December 31, 2024 and 2023, there were forfeitures held in the amount of \$234,294 and \$97,124, respectively. The forfeited accounts will be allocated or used to pay administrative expenses or fund future employer contributions as soon as administratively feasible.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that could affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. See Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses and all investment management expenses and commissions are paid by the Plan. Certain administrative expenses are paid by the College.

Subsequent Events

Subsequent events have been evaluated for potential recognition and/or disclosure through REPORT\_DATE. This represents the date the financial statements were available to be issued.

**NOTE 3. CERTIFICATION OF ASSETS**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, collectively referred to as "Empower", the custodian of the Plan, for the years ended December 31, 2024 and 2023, respectively, as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

**NOTE 4. CONTRACT WITH INSURANCE COMPANY**

The Plan has a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for the credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$1,802,825 and \$1,538,715, respectively, at December 31, 2024 and 2023, contract value approximated fair value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) partial or complete Plan termination; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. Such interest rates are reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The interest rate for the guaranteed investment contract as of December 31, 2024 and 2023 were 1.41% and 1.23% respectively.

**NOTE 5. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage accounts:* Valued at closing price reported on the active market on which the individual securities are traded. Self-directed brokerage accounts held by the Plan consist of mutual funds. These funds are required to publish their daily NAV and transact at that price.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. There were no transfers or changes in fair value levels for years ending December 31, 2024 and 2023.

**NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's assets at December 31, 2024 and 2023, are held by and recordkeeping services are provided by Empower Retirement. Therefore, at December 31, 2024 and 2023 any transactions with Empower, including administrative fees paid, would be considered qualified party-in-interest transactions.

Direct compensation paid to Empower or its affiliates amounted to \$100,957 for the years ended December 31, 2024. During the year ended December 31, 2024 Empower also received indirect compensation as stated per service agreements.

Notes receivable from participants, totaled \$0 and \$68 at December 31, 2024 and 2023, respectively, and qualify as party-in-interest transactions.

**NOTE 7. PLAN TERMINATION**

The Plan Administrator anticipate and believe that the Plan will continue without interruption but has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances and the Plan assets would be distributed to participants on the basis of their prorated values at the termination date.

**NOTE 8. TAX STATUS**

The Plan has adopted a non-standardized form of a pre-approved profit sharing / money purchase / CODA plan sponsored by Tennessee Pension Administrators LLC. The Plan received a favorable letter of determination dated June 30, 2020, stating that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC as of the Plan's year-end.

FASB requires the Plan Administrator to annually evaluate the Plan's tax positions, including accounting and measurement of uncertain tax positions. For the year ending December 31, 2024, the Plan Administrator concluded that no uncertain tax positions had been taken that would require adjustment to or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the federal, state, or local tax authorities for years before 2021.

**NOTE 9. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
