## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the Race Forward 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). **1. Description of the Plan**

The following brief description of the Race Forward 403(b) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

The Plan is a defined contribution pension plan covering all employees of Race Forward, Inc. (the “Company”). The Plan was originally established on March 7, 2012, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In 2017, Race Forward merged with the Center for Social Inclusion (“CSI”) and in November 2022 the CSI pension plan combined with Race Forward 403(b) Plan. The Plan was adopted under the provisions of Internal Revenue Code (“IRC”) Section 403(b). The Matrix Trust Company is the recordkeeper and one of the custodians of the Plan.

Company employees who work more than 20 hours per week or who work less than 20 hours per week, but with more than one year’s service are eligible to participate in the Plan. Employees who work less than 20 hours and have not completed one-year of service with 1,000 hours are excluded from participation in the Plan.

Contributions

The Plan allows for two types of elective employee contribution deferrals: Pre-Tax Deferrals and Roth Deferrals. The Plan Document defines the following deferrals as:

Pre-Tax Deferrals – Taxable income is reduced by the deferral contributions, so the participant pays less in federal income taxes. Later, when the Plan distributes the deferrals and earnings, the participant will pay the taxes on those deferrals and the earnings. Therefore, the federal income taxes on elective deferral contributions and on the earnings are only postponed. Eventually, the participant will have to pay taxes on these amounts.

Roth Deferrals – The elective deferrals are subject to federal income taxes in the year of elective deferral. However, the elective deferrals and, in certain cases, the earnings on the elective deferrals are not subject to federal income taxes when distributed to the participant. For the earnings to be tax free, the participant must meet certain conditions.

Each year, participants may contribute up to 100% of eligible salary on a pre-tax basis, with a maximum contribution for 2024 and 2023 of \$23,000 and \$22,500, respectively. However, participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions, as defined in the Plan. The maximum catch-up contribution is \$7,500 for 2024 and 2023.

Contributions, continued

The Company may contribute a discretionary nonelective contribution to the Plan each year. The amount is allocated by group among the participants based on years of service. Groups consist of: Employees with 1-2 years of service, 3 years of service, 4 years of service, and 5 plus years of service. The Company's discretionary nonelective contribution for the Plan years ended December 31, 2024 and 2023, totaled \$242,059 and \$219,054, respectively. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the allocations of the Company's nonelective contribution and Plan investment earnings. Allocations are based on participant earnings on account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest equal to the Wall Street Journal's published prime interest rate plus 2%, which is established by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Participants are 100% vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's nonelective contribution portion of participants' accounts plus earnings thereon is based on years of continuous service. A participant is vested 33.33% after one year of service, 66.66% after two years of service, and 100% after three years of service.

Forfeitures

Forfeitures are amounts that could not be paid to terminating participants because they were not 100% vested. The forfeited nonvested portion of the participant's account remains as a Plan asset (either in the participant's account or in a suspense account). The employer

may decide, in its discretion, how to treat forfeitures in the Plan. During 2024 and 2023, forfeited amounts used were \$1,654 and \$150, respectively, to reduce nonelective contributions. Forfeited unvested accounts in the suspense account at December 31, 2024 and 2023 totaled \$0.

Payment of Benefits

After a participant leaves the Company due to any reason (death, disability, termination, or retirement), the participant may elect to receive his or her vested benefit in a single lump sum or have the payment paid as a "direct rollover" to an individual retirement account ("IRA") or to another employer's tax qualified plan.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Accounting Pronouncement

In June 2016, the Financial Accounting Standards Board ("FASB"), issued Accounting Standards Update (ASU) 2016-13, *Financial Instruments—Credit Losses (Topic 326)*. ASU 2016-13 requires a financial asset (or a group of financial assets) measured at

amortized cost basis to be presented at the net amount expected to be collected. The ASU introduces a new credit loss methodology, Current Expected Credit Losses (CECL), which requires earlier recognition of credit losses, while also providing additional transparency about credit risk. Since its original issuance in 2016, the FASB has issued several updates to the original ASU. The allowance for credit losses is a valuation account that is deducted from the amortized cost basis of the financial asset(s) to present the net carrying value at the amount expected to be collected on the financial asset. The effective date for all other entities (except certain public business entities for which it is already effective) is for periods beginning on or after December 15, 2022 (2023 calendar year-ends), including all interim periods within that fiscal year. The adoption of this ASU did not have any impact on the Plan's financial statements.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – observable, represents assets with unadjusted quoted market prices in active markets for identical assets.
- Level 2 – other observable, quoted market prices for similar assets using industry standard models and based on prices other than quoted prices within Level 1. There are no level two investments.
- Level 3 – unobservable, reflects assets based on the reporting entity's own assumptions and internally developed models or methodologies based on the best information available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Of the total \$6,404,125 and \$5,379,907 of the Plan's participant-directed investments at December 31, 2024 and 2023, \$6,395,202 and \$5,374,170 were Level 1 assets and \$8,923 and \$5,737 were Level 3 assets, respectively.

The following is a description of the valuation methodology used for assets at fair value. There have been no changes in the methodologies used in the valuation of the Plan assets as of December 31, 2024 and 2023.

*Registered Investment Companies*

The fair values are based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Investment with Insurance Contract*

The fair values are based on an insurance contract with interest and principal guaranteed by the insurance company and backed by the general account assets of the insurance company. There are no separate account assets specifically tied to this contract, so there are no unrealized gains or losses reported.

The Company's Level 3 investments relate to funds within the CMFG Stable Value account. The account is funded by a specific pool of investments in a segregated account, which includes types of investments such as bonds, money market funds, or insurance company Guaranteed Investment Contracts. Because the general assets of CMFG Life Insurance Company back the Stable Value account, there are no "marking-to-market" or "market-to-book ratio measurements" that apply because there is no underlying portfolio created just for the Stable Value account. The value of the CMFG Stable Value account is the invested principal plus any credited interest. It is not invested in a portfolio that is subject to market fluctuation.

The Stable Value Account is a Deposit Administration Group Annuity Contract. The contract is a fixed, deferred group annuity available to qualified retirement plans. It provides guaranteed protection of principal with a set rate of return. The fund seeks a high level of current income consistent with preservation of capital by investing primarily in corporate bonds, mortgage-backed securities, collateralized mortgage obligations, high quality commercial mortgage loans, municipal bonds and other high-grade fixed income securities.

**4. Related-Party Transactions**

The Plan invests in shares of registered investment companies managed by the associated custodian. Investment income is derived from these investments. Fees paid by the Plan to the custodian for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan. The various funds' operating expense ratios ranged from 0.02% to 0.79%, for the year ended December 31, 2024. Administrative expenses related to the administration of the Plan were paid by the Plan to the custodian. These transactions qualify as party-in-interest transactions.

**5. Termination of Plan**

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**6. Tax Status**

The Plan has not obtained an Internal Revenue Service (“IRS”) determination letter and based on current regulations, none is required. The Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**7. Information Certified by Custodians - Unaudited**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024. Accordingly, the Matrix Trust Company, a custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activities reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024, Note 3 - Fair Value Measurements, and the supplemental schedule, except for the funds held with an insurance company.

The CMFG Life Insurance Company, a custodian of the Plan, has certified to the completeness and accuracy of investments held with an insurance company reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activities reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024, Note 3 - Fair Value Measurements, and the supplemental schedule.
