Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Team Hardinger Transportation 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



1. Description of Plan

The following description of the Team Hardinger Transportation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

Effective October 1, 2024, Hardinger Transfer Company, Inc. d/b/a Team Hardinger Transportation & Warehousing and Subsidiary (the former Plan Sponsor) implemented a plan of reorganization by transferring all assets, liabilities, equity and operations of the former Plan Sponsor to Hardinger Holding Company, Inc. (the Plan Sponsor), at which time the Plan was amended to name Hardinger Holding Company, Inc. the Plan Sponsor. Additionally, as a part of the reorganization plan additional subsidiaries to the Plan Sponsor were created and these subsidiaries became participating employers of the Plan. These included Hardinger Integrated Logistics LLC (d/b/a Hardinger), Hardinger Transfer Co., Inc. (d/b/a Hardinger Trucking), Hardinger Brokerage, LLC (d/b/a Hardinger TMS), Hardinger Warehousing LLC, and EQPT Services LLC. On a consolidated basis, the operations of the Plan Sponsor continue to be consistent in scope with the former Plan Sponsor.

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering substantially all full-time employees of the Plan Sponsor who have completed sixty consecutive days of service and are not casual workers or owner operators.

Contributions

Participants are permitted to make pre-tax as well as Roth elective deferrals to the Plan through payroll deductions, and such elective deferrals are subject to the federal tax laws governing the limits on elective deferrals. The Plan Sponsor may make discretionary matching or profit-sharing contributions to each participant's account. Discretionary matching contributions are made as a uniform percentage of the participant's elective deferrals. For the years ended December 31, 2024 and 2023, the Plan Sponsor matched 50% of participant elective deferrals up to 4% of eligible compensation. Profit-sharing contributions are allocated to participant accounts based on the participants' elective deferrals or as a flat dollar amount for each participant. Participants must have completed 1,000 hours of service during the Plan year and be employed by the Plan Sponsor on the last day of the Plan year to be considered eligible for the discretionary profit-sharing contribution. Participants also receive profit-sharing contributions in the year of their death, disability, or retirement regardless of their hours of service. There were no discretionary profit-sharing contributions during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's elective deferral contribution, the Plan Sponsor's matching contribution, and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant may direct the investment of their funds within the investments offered by the Plan.

Notes Receivable from Participants

Individuals participating in the Plan have the option of taking loans against their account balances. Repayment terms are not to exceed five years, except for the purchase of a principal residence, for which the maximum term is thirty years. The loan must be a minimum of \$1,000, not to exceed the lesser of one-half of the vested participant account balance, or \$50,000. A participant's account balance is utilized as collateral for any given loan. Principal and interest at the prime rate plus one percentage point are paid ratably through payroll deductions. Individuals may not have more than two outstanding loans at any time.

Team Hardinger Transportation 401(k) Retirement Plan Notes to Financial Statements (continued)

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary matching contributions is based on years of continuous service, with a year of service defined as completion of 1,000 hours of service within one Plan year.

Vesting in the Plan Sponsor's discretionary matching contributions plus earnings thereon is at 20% after the first two years and 20% each year thereafter, until fully vested after six years. In the event of death, disability, attainment of normal retirement age, or termination of the Plan, the full balance of the participant's account becomes immediately vested.

Payment of Benefits

Participants may withdraw the balance in their vested individual account upon termination of employment with the Plan Sponsor, becoming disabled or attaining retirement age but continuing to work for the Plan Sponsor. Participants may take distributions from the Plan as rollovers to individual retirement accounts, as rollovers to another employer plan, or as distributions paid to them in a single lump sum. Upon the death of a participant, their beneficiary will receive the total value of the participant's account. Vested account balances of former employees between \$1,000 and \$5,000 will be rolled over to an IRA established for the former employee. Vested account balances of former employees of \$1,000 or less are paid as a lump-sum. Benefits are recorded when paid.

Administrative Expenses

Substantially all investment and administrative expenses are paid by the Plan. Certain expenses, which are not material, are paid by the Plan Sponsor.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These forfeited amounts are first used to reduce administrative expenses. Remaining forfeitures may then be used to reduce the Plan Sponsor's discretionary contributions. At December 31, 2024 and 2023, the unallocated forfeiture balance totaled \$5 and \$470, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts regardless of whether their vesting years of service are sufficient to make them 100% vested under the Plan's vesting schedule. The value of each participant's account will be paid as directed by the Plan Sponsor.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments in registered investment companies are recorded at estimated fair value in accordance with the *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) (see Note 4).

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

3. Investments

For the years ended December 31, 2024 and 2023, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Alerus Financial, N.A., the custodian.

4. Fair Value Measurements

Investments are recorded at estimated fair value, in accordance with the FASB ASC *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC *Fair Value Measurements and Disclosures* topic are described as follows:

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Mutual funds – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024 and 2023:

5. Guaranteed Investment Contract

The Standard Stable Asset Fund II is designed to provide Plan participants with a guaranteed return of principal and is considered a fully benefit responsive investment contract. The fund is valued at contract value, which represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the fund become part of Standard Insurance Company's general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment and there are no wrap contracts supporting the liquidity of the fund, thus it is considered a traditional investment contract. Net deposits and interest credited become liabilities against Standard Insurance Company on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Standard Insurance Company.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The Plan Sponsor does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

6. Income Tax Status

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the form of the non-standardized plan used by the Plan is acceptable under applicable requirements of the Internal Revenue Code (IRC). Therefore, the related trust is exempt from taxation for the years ended December 31, 2024 and 2023. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

During the year ended December 31, 2023, the Plan Sponsor did not timely enroll an employee into the Plan. The total missed contributions owed to this employee totaled \$643. In addition, there were lost earnings calculated on the missed contributions totaling \$57. These funds were remitted to the Plan by the Plan Sponsor during 2024. This matter was "self-corrected" under the IRS Self-Correction Program (SCP); therefore, no formal corrective notification to the Internal Revenue Service or the DOL was required.

The FASB issued guidance on accounting for uncertainty in income taxes. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. However, as a result of an untimely enrollment of an employee, the Plan Sponsor "self-corrected" an issue under the SCP during 2024. The corrective amount was remitted by the Plan Sponsor and credited to the participants' accounts as soon as administratively possible. The Plan Administrator believes the Plan is operating in compliance with the IRC and has taken the necessary steps to maintain the Plan's qualified status. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions

During 2024 and 2023, substantially all administrative costs incurred by the Plan, totaling \$55,970 and \$46,008, respectively, were paid from Plan assets. Fees paid by the Plan are not prohibited; payments are for reasonable compensation for the operation of the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
