## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Saint John's Communities, Inc. Pension Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a noncontributory defined contribution plan sponsored by Saint John's Communities, Inc. (the "Sponsor"). The Plan is covered under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Lincoln Financial Group Trust Company ("Lincoln") is the custodian of the Plan's investments at December 31, 2024 and 2023.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility and Participation

All employees of the Sponsor, other than contract and pool employees, chaplains who are Episcopal clergy or Episcopal lay, who participate in an alternative retirement plan and who receive a contribution from the Sponsor to that retirement plan, and certain highly compensated employees, are eligible to participate in the Plan beginning January 1 or July 1 upon completing 1,000 hours of service within a consecutive 12-month period and are age 21 or older.

#### Contributions

Participants may contribute amounts representing distributions from other qualified benefit plans ("rollovers"). Participants are not permitted to make other contributions to the Plan. The Sponsor's contribution is discretionary and is subject to certain limitations. A contribution of 5% of eligible wages was approved for 2024 and 2023. Participants direct all contributions into one or a combination of investment choices which have a wide range of objectives and risks.

#### Participant Accounts

Each participant's account is credited with participant's rollover contributions and an allocation of the Sponsor's contributions, and plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are immediately vested in any rollover contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's contributions plus actual earnings (losses) thereon is based on the number of years of continuous service as shown by the following:

Less than 3 years	0 %
3 years	100 %

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or the benefit in installments if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in the account as a lump-sum distribution. The Plan also allows for in-service distributions upon attaining normal retirement age.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate before becoming 100% vested in the Sponsor's contributions. Forfeitures of non-vested contributions are used to reduce the Sponsor's contributions or are reallocated to plan participants. No forfeitures were reallocated to plan participants in 2024 or 2023. Unapplied forfeitures as of December 31, 2024 and 2023 were \$7,224 and \$13,882, respectively. Forfeitures of \$13,942 were used to offset Sponsor contributions during the year ended December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except the stable value fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Investment advisory and record keeping fees are allocated proportionately to plan participants based on their respective account balances. The Sponsor pays professional fees and certain other expenses which are excluded from these financial statements.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 27, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled unitized funds:* Fair value is estimated using the net asset value ("NAV") per unit provided by the investment issuer. Fair value is based on the fair value of underlying investments held by the pooled unitized funds. The pooled unitized funds invest in a mix of mutual funds and/or other investments that correspond to a specific risk profile and investment time horizon that includes the year (target date) in which the participant expects to retire. These funds have no unfunded commitments and have no redemption restrictions as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **Note 4: Fully Benefit-Responsive Investment Contracts**

The Plan maintains a fully benefit responsive investment contract ("FBRIC") in the form of a stable value fund with Lincoln. Lincoln maintains the contributions in a general account. The account is credited with earnings on investments and charged for participant withdrawals and administrative expenses. The fund is stated at contract value, which approximates fair value. As such, no adjustment from fair value to contract value is presented on the Statements of Net Assets Available for Benefits for the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 5: Information Prepared and Certified by Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by Lincoln, the custodian of the Plan. This information includes investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the plan document to discontinue contributions and to terminate or partially terminate the Plan at any time subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balance.

### **Note 7: Income Tax Status**

The Plan adopted a pre-approved plan offered by Lincoln Financial Group. The pre-approved plan received an Internal Revenue Service ("IRS") Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Party-in-Interest Transactions**

During 2024 and 2023, plan investments were managed by Lincoln; therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.
