Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Belleair Country Club 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) **Description of Plan**

The following description of the Belleair Country Club 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

(a) **General**

The Plan was established on January 1, 1998 as a defined contribution plan covering all employees meeting eligibility requirements of the Belleview Biltmore Country Club Corporation (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective January 1, 2022.

Empower Retirement (“Empower”) serves as the custodian and administers the Plan’s assets for the benefit of participants. Empower Trust Company, LLC certifies the trust assets and related investment activity. Empower Life & Annuity Insurance Company of New York certifies the guaranteed interest account and related investment activity.

(b) **Contributions**

All employees of the Employer who have completed at least one year of employment, 1,000 hours of service, and have attained the age of twenty-one are eligible to participate. The Plan provides for entry dates on the first day of the quarter coinciding with the satisfaction of the entry requirements.

Participants may make pre-tax and Roth salary contributions to the Plan, subject to limitations of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Employer, at its discretion, may make matching contributions or profit-sharing contributions to the Plan. The Employer elected to match 65% up to 9% of the participants’ eligible wages for all contributing participants for the year ended December 31, 2024. The Employer did not elect to make a discretionary profit-sharing contribution for the year ended December 31, 2024.

(c) **Participant Investment Account Options**

The Plan currently offers common collective trusts and pooled separate accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Notes to Financial Statements - Continued

(1) Description of Plan - Continued

(d) Participant Accounts

Each participant's account is credited with the participant's contributions, and an allocation of the Employer's discretionary matching and profit-sharing contributions, if applicable, and plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

(e) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in their employer matching and profit-sharing contributions based on years of service as defined by the Plan. Upon death or total and permanent disability, participants will become 100% vested in the employer contributions.

A participant is vested in employer matching and profit-sharing contributions as follows:

(f) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect in the month the loan is effective, plus one percentage point. Principal and interest are paid ratably through payroll deductions. The interest rates on all outstanding loans ranged from 4.25% to 9.50% at December 31, 2024.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, the loan balance is reduced, and a benefit payment is recorded.

(g) Payment of Benefits

On termination of service due to death, disability or retirement, a participant shall be 100% vested in their accounts under the Plan. Normal retirement age under the Plan is 65. The Plan provides for benefit distributions by lump-sum payment. The Plan also allows for in-service withdrawals for those 59 ½ or older. Benefits are recorded when paid.

(g) Payment of Benefits - Continued

The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(h) Forfeitures

Pursuant to the plan document, forfeiture balances are to be used to reduce the employer matching or profit-sharing contributions or to pay for administrative expenses of the Plan. Approximately \$1,100 of forfeited non-vested accounts were used to offset employer matching contributions during 2024. The Plan had approximately \$0 and \$358 available to reduce future employer matching or profit-sharing contributions, or to pay administrative expenses of the Plan at December 31, 2024 and 2023, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the Plan are presented on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

(d) Investment Valuation and Income Recognition

Investments in the pooled separate account are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guaranteed interest account is a fully benefit-responsive investment contract and is valued at contract value. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the administrative services provider of the Plan, as agent for the custodian.

(d) Investment Valuation and Income Recognition - Continued

See Note 7 for discussions of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(e) Notes Receivable from Participants

The Plan's notes receivable from participants are stated in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 962, *Plan Accounting - Defined Contribution Pension Plans* ("ASC 962"), which requires participant loans to be measured at their unpaid principal balance plus any accrued but unpaid interest and to be classified as notes receivable from participants. Interest income related to the notes receivable from participants has been separately presented as interest income - notes receivable from participants.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, the loan balance is reduced, and a benefit payment is recorded.

(f) Administrative Expenses

Plan administrative expenses and professional fees of approximately \$2,760 were paid by the Plan during the year ended December 31, 2024. The Employer has historically paid a substantial portion of plan expenses.

(g) Risks and Uncertainties

The Plan invests in various investment securities. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(h) Benefit Payments

Benefit payments are recorded when paid.

(2) Summary of Significant Accounting Policies - Continued

(i) Unit Values

Individual participant accounts for the pooled separate account are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

(3) Certification of Plan Investments

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC, the trustee, and Empower Life & Annuity Insurance Company of New York, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Pooled separate account at fair value, guaranteed interest account at contract value, and notes receivable from participants as shown in the statements of net assets available for benefits;
- Net appreciation in fair value of investments, dividends, interest income - guaranteed interest account, and interest income - notes receivable from participants and related investment activity as shown in the statement of changes in net assets available for benefits;
- Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts and not subject to forfeiture.

(5) Income Tax Status

The Plan adopted the pre-approved plan document of Florida Retirement Consultants, which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

(5) Income Tax Status - Continued

The pre-approved plan document has been amended since receiving the opinion letter; however, the plan administrator and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

(6) Party-in-Interest

Certain plan investments may be managed and held by Empower. Additionally, notes receivable from participants are managed by Empower. Empower is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. During 2024, the Plan paid Empower approximately \$2,760 for services performed for the Plan. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

(7) Fair Value Measurements

ASC Topic 820, *Fair Value Measurement* ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

(7) Fair Value Measurements - Continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Account

This investment is a public investment vehicle valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding.

The NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active, however, the unit price is based on the valuation of the underlying investments which are traded on an active market.

(8) Fully Benefit-Responsive Investment Contract

Investments in the guaranteed investment contract ("GIC"), which are fully benefit responsive, are valued at contract value. Investments in the GIC are held in a general account product offered through a group annuity contract issued by Talcott Resolution Life Insurance Company. Empower Life & Annuity Insurance Company of New York became the administrator of the contract during 2021. Participant principal and interest are fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America.

(8) **Fully Benefit-Responsive Investment Contract - Continued**

The general account assets are primarily high-quality, fixed income bonds. The GIC is credited with declared rates of interest based on the earnings of the underlying assets in the portfolio compared to the minimum interest crediting rate, as stated in the contract with Talcott Resolution Life Insurance Company. The GIC is reported at contract value which is the basis for participant-initiated transactions.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan.); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants.

(9) **Subsequent Events**

In accordance with ASC Topic 855, *Subsequent Events*, the Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.
