Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the National Fire Protection Association 403(b) DC Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The following description of the National Fire Protection Association 403(b) DC Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

General

The Plan is a 403(b) retirement plan which was established on January 1, 2018 and is intended to comply with the requirements of the Treasury Regulations under Internal Revenue Code Section 403(b) effective January 1, 2009. The Plan covers all employees of National Fire Protection Association (the “Employer”) except non-resident aliens and any employee covered under a collective bargaining agreement. Newly eligible participants may enter the Plan on the first day of the following payroll period after meeting the eligibility requirements. Fidelity Management Trust Company (“Fidelity”) provides recordkeeping services for the Plan, and also serves as custodian for the Plan’s investments. The Employer is the Plan’s administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All investments are participant directed.

Plan Transfer

The Pension Committee has authorized the transfer of participant accounts from the Non-ERISA NFPA 403(b) Retirement Plans into the Plan. For the Plan years ended December 31, 2024 and 2023, there was \$81,646 and \$1,333,893 of assets transferred into the Plan, respectively.

Participant Deferral Contributions

Participants may elect to defer a portion of their annual compensation to the Plan, subject to dollar limits set by Federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”). Eligible employees are automatically enrolled in the Plan to defer 2% of eligible compensation unless they affirmatively elect not to participate in the Plan.

Employer Contributions

Participants who elected to maintain accrued benefits under the National Fire Protection Association Employees’ Retirement Plan, as well as co-op and seasonal employees, interns and employees regularly scheduled to work less than 20 hours per week are not eligible for Employer contributions in this Plan.

Matching Contributions

The Employer matching contribution is 100% of participant deferrals up to 2% of their eligible compensation, as defined. In order to be eligible for an Employer matching contribution, a participant must complete three months of service. For the Plan years ended December 31, 2024 and 2023, the Employer matching contribution amounted to \$322,477 and \$280,230, respectively.

Note 1 - Description of the Plan (Continued)

Employer Contributions (Continued)

Nonelective Contributions

The Employer nonelective contribution is 6% of the participant's eligible compensation for the Plan year. In order to be eligible for an Employer nonelective contribution, a participant must complete a year of service, as defined and be an active employee at December 31. For the Plan years ended December 31, 2024 and 2023, the Employer nonelective contribution amounted to \$1,035,740 and \$897,108, respectively, net of forfeitures of \$15,022 and \$9,510, respectively.

Participant Accounts

Participants direct the investment of all contributions into various investment options offered by the Plan, which consists of shares in mutual funds. Each participant's account is credited with the participant's contributions and all Employer contributions, and Plan earnings (losses). Participant accounts are charged with a portion of administrative expenses that are paid by the Plan. Participants' accounts are charged a fixed, per participant fee that is pro-rata based on account balance size. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their deferral, rollover contributions, Employer matching contributions, and earnings (losses) thereon. Participants start vesting in nonelective Employer contributions based on years of service and become fully vested after three years of service or upon death, disability or by reaching normal retirement age, as defined by the Plan.

Payment of Benefits

In-service withdrawals from a participant's account are permitted only due to financial hardship, disability, or upon reaching 59½. Hardship withdrawals may be taken from a participant's elective deferral account without respect to earnings. The amount of hardship distribution cannot exceed the amount needed to meet the immediate financial hardship. Upon termination, if a participant's vested account is less than \$5,000 and the participant does not elect to take the distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). A participant may have only one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through direct payment to Fidelity by participants. There was \$212,439 and \$220,916 of notes receivable from participants outstanding at December 31, 2024 and 2023, respectively.

Plan Expenses

Individual participant accounts are charged directly for plan loan recordkeeping, participant fees, expedited shipping and benefit disbursement processing fees, if applicable. All other operating expenses incurred in the administration of the Plan are paid by the Employer, except as described earlier.

Plan Administration

The Employer is the Plan administrator and has the authority to appoint a person(s) or entities to carry out the operation of the Plan. Fidelity is the custodian of the Plan.

Forfeitures

A participant who leaves the employment of the Employer forfeits any non-vested balance at the earlier of the end of five consecutive one-year breaks in service or if the participant receives a complete distribution of their vested accounts. Forfeitures can only be used to reduce future Employer nonelective contributions. Forfeitures outstanding at December 31, 2024 and 2023 were \$15,022 and \$9,196, respectively. Subsequent to year end, \$15,022 was used to offset a portion of the Employer contributions for the 2024 Plan year funded in 2025. During 2024, \$9,357 was used to offset a portion of the Employer nonelective matching contributions for the 2023 Plan year funded in 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Benefits Paid

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Subsequent Events

The Plan's management has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

Note 3 - Information Certified by Custodian

Plan investments are held by the Plan's custodian, Fidelity Management Trust Company ("Fidelity"). The fair value of all investments as of December 31, 2024 and 2023 and all investment transactions for the years then ended, including interest and dividends, and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by Fidelity. Information included in the supplemental schedule of assets (held at end of year) and notes receivable from participants have also been derived from information certified by Fidelity. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. The assets are invested in mutual funds through Fidelity. Plan participants have the option to invest their account balances among different Fidelity and non-Fidelity funds designated by Plan governance.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related Parties and Party-in-Interest Transactions

Plan investments are managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. For the years ended December 31, 2024 and 2023, fees paid directly to Fidelity amounted to \$31,319 and \$29,527, respectively. Notes receivable from Participants also qualify as party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 8 - Tax Status

The IRS has determined and informed the Plan sponsor by a letter dated August 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 8 - Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
