The significant accounting policies used by O'Rielly Motor Company & Affiliates Employee Investment/Savings Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. The attached schedule summarizes the material misstatements detected as a result of audit procedures and corrected by management.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

Reportable findings that are also considered internal control deficiencies are described below in the "Internal Control Communications" section.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated August 26, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditors’ opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

INTERNAL CONTROL COMMUNICATIONS

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of O’Rielly Motor Company & Affiliates Employee Investment/Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan’s system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to error or fraud may occur and not be detected by such controls. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. A reportable finding is an indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties, and that, in the auditors' professional judgment, are of sufficient importance to merit management's attention. We consider the following deficiencies in O'Rielly Motor Company & Affiliates Employee Investment/Savings Plan's internal control to be significant deficiencies and reportable findings:

Correction of Past Delinquent Participant Contributions

During the audit, we noted the Form 5330, Return of Excise Tax, had not been filed for delinquent participant contributions reported in 2021 and 2022. The delinquent participant contributions are not fully corrected until lost earnings are remitted to the Plan and a Form 5330 is filed. It is our understanding that a Form 5330 wasn't filed due to a miscommunication from Principal. Therefore, we recommend working with your tax preparer to obtain assistance with filing the Form 5330. This comment was previously communicated in 2023.

Definition of Compensation

According to the Plan document, compensation is defined as follows: "Wages, within the meaning of Code Section 3401(a), and all other payments of compensation to an Employee by the Employer (in the course of the Employer's trade or business) for which the Employer is required to furnish the Employee a written statement under Code Sections 6041(d), 6051(a)(3), and 6052, excluding reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation and welfare benefits." During our testing of employee deferrals and employer matching contributions, we noted instances where employees that received more than 2 pay checks in a month, such as bonuses, did not have 401(k) deferrals withheld. As these additional checks were included in the employees' eligible wages, according to the Plan's definition, the checks should have had the proper withholdings and employer matching contributions. Additionally, we noted that the employer match was not calculated based on the correct definition of compensation according to the Plan document. We recommend that the Sponsor review the definition of compensation for any adjustments deemed necessary, or

implement the necessary controls to achieve the desired withholdings and proper employer match contributions. We also recommend working with Principal and ERISA counsel to determine what corrections need to be made.

Missed Deferral Correction

During our testing of employee deferrals, we noted one employee who received a corrective contribution during year received the wrong corrective contribution. This was due to the correction being calculated based on current deferral elections, instead of the deferral election in effect at the time the error occurred. We recommend working with Principal to determine what corrections need to be made.

During our audit, we also became aware of deficiencies in internal control other than significant deficiencies or material weaknesses, and the following other matters that are opportunities for strengthening internal controls and operating efficiency:

Minutes and Fiduciary Oversight

With the complexity of investment alternatives and the tax laws covering the qualifications of the Plan and fiduciary responsibilities of the trustee, it is important that the plan sponsor adequately document the due diligence exercised over the operations of the Plan. The meeting minutes provided to us did not sufficiently document the Plan's oversight. We recommend plan management hold at least quarterly meetings and document the items discussed and summary of actions taken in formal minutes. The meetings should include consideration of items such as:

- Review of Plan's investment performance
- Selection of investment options
- Evaluation of service providers
- Review of Plan Trust Reports
- Employee complaints or concerns, if known
- Reports from the Plan's investment advisor, if applicable
- Consideration and approval of plan amendments
- Compliance with ERISA regulations

We will review the status of these comments during our next audit engagement. We have already discussed many of these comments and suggestions with various Plan personnel, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study of these matters, or to assist you in implementing the recommendations.
