### Opinion

We have audited the financial statements of UMA Enterprises Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of UMA Enterprises Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UMA Enterprises Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of UMA Enterprises Employee Stock Ownership Plan amended the plan document on December 16, 2023 to terminate the plan and management determined liquidation is imminent. As a result, UMA Enterprises Employee Stock Ownership Plan used the liquidation basis of accounting in presenting the December 31, 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ## **Note 1 - Description of Plan**

The following brief description of the UMA Enterprises Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Board of Directors have chosen to terminate the Plan effective December 16, 2023 (Termination Date). Participants became 100% vested as of this date.

### **General**

UMA Enterprises Group Holdings, Inc. (the Company) established the Plan effective as of June 6, 2014. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (the ERISA). The Plan is administered by the ESOP committee of the Company. The Plan's trustee is an institutional trustee. Effective December 16, 2023, UMA Enterprises Group Holdings, Inc. was replaced by UMA Enterprises, Inc. in the Trust Agreement.

There is one unallocated share remaining in the Plan as provided in the Plan's termination.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Leased employees, union members, independent contractors and non-resident aliens are not eligible to participate in the Plan. Effective the Termination Date, no employees were eligible to participate in the Plan following this date.

### **Entry Date**

Employees may enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Contributions to the Plan are made by the Company at the discretion of the Company. Effective as of the Termination Date, no further contributions will be made to the Plan for any Plan year beginning on or after the Termination Date.

### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

## **Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

## **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Prior to the Termination Date, each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

## **Vesting**

Effective December 16, 2023, all participants are fully vested due to the plan termination.

## **Payment of Benefits**

Participants may elect to receive an amount equal to the value of their vested interest as defined in the plan document upon retirement, termination of employment, death or disability. If a participant's service is for a death, disability or retirement, distribution of the participant's balance shall be made approximately 180 days following the plan year end in which the participant ended employment. If a participant's service is for a reason other than death, disability or retirement, distribution of the participant's balance shall be made the earlier of the end of the plan year in which the participant attains age 65 or the fifth plan year following the Plan year in which the participant's employment is terminated. However, if the participant's vested balance includes shares of company stock acquired with the proceeds of a loan, no distribution will be made to the participant until 180 days after the plan year in which the loan is paid in full. Participants with vested account balances between \$1,000 and \$5,000 will be directly rolled over to an individual account. Participants with vested account balances less than \$1,000 may be paid out as soon as administratively feasible following the date the participant terminated employment.

### **Plan Termination**

On December 16, 2023, the Board of Directors adopted a provision to terminate the Plan effective December 16, 2023. The Plan filed for a Determination Letter to terminate, and thus the assets will remain in the Plan until receipt of the determination letter, with the exception of payment of benefits, stock buyback and remaining share in the Plan in accordance with the Plan document.

The Plan entered into a stock redemption agreement to buy back all allocated shares and acquire all but 1 share of unallocated shares. The Company also terminated the existing loan with the Plan.

Effective March 19, 2024, UMA Enterprises Group Holdings, Inc. has been dissolved.

### **Note 2 - Significant Accounting Policies and Use of Estimates**

#### **Basis of Accounting**

The Board of Directors voted to terminate the Plan effective December 16, 2023. The Plan therefore uses the liquidation basis, in presenting the December 31, 2024 and 2023 financial statements, in accordance with generally accepted accounting principles.

#### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Allocations**

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released.

#### **Investment Valuation and Income Recognition**

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Benefits payments to participants are recorded when paid.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

In December 2023, the Plan sold 24,115 shares of common stock for \$55,000.

As a result of the termination of the ESOP by the Company, 77,884 unallocated shares were surrendered to the Company in repayment of the note payable, except for one share which will be held through the dissolution.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock - The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities, including discounts.

Money Market Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated February 27, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and the related trust continues to be tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-In-Interest Transactions**

The Plan invests in Company common stock with the Company. These are related party and party-in-interest transactions.

As described in Note 2, the Plan paid certain administrative expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

**Note 7 - Risks and Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 8 - Subsequent Events**

The Plan's board of directors resigned and appointed a wind down director as of June 11, 2025.

The Plan sponsor has evaluated subsequent events through September 4, 2025, the date which the financial statements were available to be issued.
