## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Olympus Group, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Olympus Group, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Olympus Group, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through May 12, 2025, which is the date the financial statements were available to be issued.

**Key parties of the plan** - Olympus Group, Inc. is the plan sponsor, employer and plan administrator. Empower Trust Company, LLC is the trustee that holds custody of the plan's investment assets. Empower Retirement, LLC is the third party administrator that maintains investment and participant records and tax counsel that performs various compliance tests. The two Empower entities discussed above are collectively referred to as "Empower". Principal Securities Inc. is the plan's investment advisor.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings from investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

*Common/collective trust* - The plan invests in the Putnam Stable Value Fund which invests in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions. The fund also invests up to 75% of its assets in security-backed investment contracts, including separate account products of insurance companies. The fund generally maintains at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds with investment policies and other provisions similar to those of the fund. The fund is a direct filing entity valued at NAV based on the underlying unit value as reported by the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

## 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**General** - The plan was established on January 1, 1975 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees that have reached 19 years of age are eligible to make elective deferral contributions and receive employer matching contributions. An employee will be allowed to enter the plan on the first day of the month immediately following the employee meeting the eligibility requirements. Effective January 1, 2025, the age requirement changed from 19 years of age to 18 years of age.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also allows for Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 3% of their compensation withheld as deferral contributions. Effective January 1, 2025, these participant deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease, or stop the deferral contributions at any time by completing the necessary documentation.
- b. Participants may make rollover contributions to the plan from other qualified plans.
- c. Employer matching contributions may be made at the discretion of the employer's board of directors equal to a percentage of the employee's compensation contributed to the plan as deferral contributions. Employer matching contributions, funded coinciding with each payroll, were made equal to 25% of the first 8% of compensation that a participant contributed to the plan in 2024 and 2023.
- d. Employer nonelective contributions may be made at the discretion of the employer's board of directors. No such contributions were made in 2024 or 2023.

**Participant accounts** - Earnings, including fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's deferral and rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options and change their deferral percentage at any time.

**Vesting** - Participants are always 100% vested in their deferral and rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two years of service at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or attaining qualified retirement (defined at 59½) while still employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Distributions can be made in the form of a single lump sum payment or installments. In-service withdrawals can commence upon reaching age 59½. Hardship withdrawals are also permitted under certain circumstances.

**Forfeitures** - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to reduce employer matching contributions were \$3,000 in 2024 and \$8,000 in 2023. Unapplied forfeitures were \$15,000 as of December 31, 2024. Unapplied forfeitures were insignificant as of December 31, 2023.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distribution and loan fees and non-participant directed charges for service, administrative and advisory fees. Non-participant directed charges and positive asset fees received (see Note 5) are allocated to participants on an account value basis.

**Notes receivable from participants** - Participants may obtain loans from their accounts with approval of the plan administrator. Each participant may have up to three loans outstanding at any time. Effective October 18, 2024, participants may only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the loans cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. Loans must generally be paid back over a period not to exceed five years, unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through March 2028 with interest rates ranging from 8.50% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions and related earnings.

### 4. INCOME TAX STATUS

The plan is operating under an Empower Retirement LLC non-standardized pre-approved profit sharing/money purchase/CODA plan that received a favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### 5. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor and Empower qualify as party-in-interest transaction. The plan entered into an administrative service agreement with Empower in which Empower provides certain administrative services to the plan. Direct fees paid by the plan to Empower, recorded as a component of administrative expenses were \$38,000 in 2024 and \$31,000 in 2023. The plan also receives positive monthly asset fees from mutual fund providers pursuant to the administrative service agreement. Positive asset fees are recorded as a reduction of administrative expenses. Positive asset fees totaled \$13,000 in 2024 and \$14,000 in 2023. Empower also receives revenue, in the form of indirect compensation, from mutual fund service providers for services Empower provides to the funds. Under the administrative service agreement, this revenue is used to reduce fees that would otherwise be owed by the plan to Empower for its administrative services.

Notes receivable from participant transactions also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
