Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cushman & Wakefield 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cushman & Wakefield 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cushman & Wakefield 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cushman & Wakefield 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Cushman & Wakefield 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of participating employers of Cushman & Wakefield U.S., Inc. (the Company) become eligible following attainment of age 18. Employees covered by a collective bargaining agreement, leased employees, and residents of Puerto Rico are not eligible to participate in the Plan.

Participating Employers of Cushman & Wakefield U.S., Inc.:

Contributions

All eligible participants can contribute from 1% to 75% of eligible compensation to the Plan, subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution for eligible employees at a rate of 100% of the first 3% and 50% of the next 2% of the eligible compensation contributed to the Plan, subject to certain limitations for employees of a certain participating employer.

The Company may also make discretionary matching contributions. No discretionary matching contributions were made for the Plan year ended December 31, 2024.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and plan earnings, and is charged with an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company. These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Participants are vested in safe harbor matching contributions plus actual earnings thereon depending on the participating employer. Vesting schedules of the participating employers range from immediate to six years of service.

Forfeitures

Forfeitures are first used to reinstate prior forfeitures for re-employed employees, applied to administrative expenses of the Plan not paid by the Company, or used to reduce Company contributions. Approximately \$57,000 of forfeitures were used in 2024. The Plan held approximately \$4,699,000 and \$2,885,000 of unused forfeitures at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of such loans is five years except for loans related to the purchase of a primary residence. The loans are secured by the balances in the participants' accounts and bear interest at rates, which are commensurate with local prevailing rates at the time of issuance, as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions.

Benefit Payments

Upon termination of service, a participant may elect to receive a lump-sum payment equivalent to his or her vested balance. In-service withdrawals are permitted upon attainment of age 59½, for hardships (as defined by the Plan), and for qualified reservist distributions. Participants may elect to defer distributions subject to certain limitations, as defined by the Plan.

Participants who terminate service and have a vested balance of less than \$5,000 but more than \$1,000 will receive a rollover distribution to an IRA, and those with a vested balance less than \$1,000 will receive a lump-sum payment.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The change in the fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefits

Benefits are recorded when paid to participants.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no 2024 excess contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Administrative expenses associated with asset custody and recordkeeping based on the number of participants are charged to participants. Loan and other transaction fees are charged to participants. The annual audit is paid by the Plan. Other expenses such as mailings, postage and amendments are paid by the Company. The Company also provides certain accounting and administrative services to the Plan at no charge.

Risk and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in investment values could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through August 12, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedules as of December 31, 2024 and 2023, and for the year ended December 31, 2024, for investments, notes receivable from participants, and investment income including interest income on notes receivable from participants was derived from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 -- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -- Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 -- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Collective Trusts – The collective trusts are composed primarily of investments in equity and debt securities and fixed income securities. They are valued at the net asset value (NAV) of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Fidelity Investments Institutional Operations Company, Inc., an affiliate of Fidelity Management Trust Company, provided recordkeeping and various other services during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

NOTE 6 PROHIBITED TRANSACTIONS

During 2024, the Company failed to remit certain employee contributions and loan repayments totaling \$139,143 within the period prescribed by the Department of Labor regulations. The delay in remitting contributions were due to system and third-party administrative errors, and the Company made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.

NOTE 7 INCOME TAX STATUS

The Plan obtained an opinion letter in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan, as amended, is qualified and the related trust is tax exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

In a letter dated April 20, 2021, the Employee Benefits Security Administration of the U.S. Department of Labor informed Plan management the Plan was under review beginning with calendar year 2018. As of December 31, 2024, the Department of Labor has finished their review and did not take any actions against the Plan.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cushman & Wakefield 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cushman & Wakefield 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Cushman & Wakefield 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of participating employers of Cushman & Wakefield U.S., Inc. (the Company) become eligible following attainment of age 18. Employees covered by a collective bargaining agreement, leased employees, and residents of Puerto Rico are not eligible to participate in the Plan.

Contributions

All eligible participants can contribute from 1% to 75% of eligible compensation to the Plan, subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution for eligible employees at a rate of 100% of the first 3% and 50% of the next 2% of the eligible compensation contributed to the Plan, subject to certain limitations for employees of a certain participating employer.

The Company may also make discretionary matching contributions. No discretionary matching contributions were made for the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and plan earnings, and is charged with an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company. These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Participants are vested in safe harbor matching contributions plus actual earnings thereon depending on the participating employer. Vesting schedules of the participating employers range from immediate to six years of service.

Forfeitures

Forfeitures are first used to reinstate prior forfeitures for re-employed employees, applied to administrative expenses of the Plan not paid by the Company, or used to reduce Company contributions. Approximately \$57,000 of forfeitures were used in 2024. The Plan held approximately \$4,699,000 and \$2,885,000 of unused forfeitures at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of such loans is five years except for loans related to the purchase of a primary residence. The loans are secured by the balances in the participants' accounts and bear interest at rates, which are commensurate with local prevailing rates at the time of issuance, as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions.

Benefit Payments

Upon termination of service, a participant may elect to receive a lump-sum payment equivalent to his or her vested balance. In-service withdrawals are permitted upon attainment of age 59½, for hardships (as defined by the Plan), and for qualified reservist distributions. Participants may elect to defer distributions subject to certain limitations, as defined by the Plan.

Participants who terminate service and have a vested balance of less than \$5,000 but more than \$1,000 will receive a rollover distribution to an IRA, and those with a vested balance less than \$1,000 will receive a lump-sum payment.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by the Plan's trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The change in the fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefits

Benefits are recorded when paid to participants.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no 2024 excess contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Administrative expenses associated with asset custody and recordkeeping based on the number of participants are charged to participants. Loan and other transaction fees are charged to participants. The annual audit is paid by the Plan. Other expenses such as mailings, postage and amendments are paid by the Company. The Company also provides certain accounting and administrative services to the Plan at no charge.

Risk and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in investment values could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through August 12, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedules as of December 31, 2024 and 2023, and for the year ended December 31, 2024, for investments, notes receivable from participants, and investment income including interest income on notes receivable from participants was derived from information certified to be complete and accurate by Fidelity Management Trust Company, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 -- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -- Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 -- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Collective Trusts – The collective trusts are composed primarily of investments in equity and debt securities and fixed income securities. They are valued at the net asset value (NAV) of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in collective trusts provide for daily liquidity and have no unfunded commitments, no redemption features, or other restrictions.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Fidelity Investments Institutional Operations Company, Inc., an affiliate of Fidelity Management Trust Company, provided recordkeeping and various other services during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

NOTE 6 PROHIBITED TRANSACTIONS

During 2024, the Company failed to remit certain employee contributions and loan repayments totaling \$139,143 within the period prescribed by the Department of Labor regulations. The delay in remitting contributions were due to system and third-party administrative errors, and the Company made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.

NOTE 7 INCOME TAX STATUS

The Plan obtained an opinion letter in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan, as amended, is qualified and the related trust is tax exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

In a letter dated April 20, 2021, the Employee Benefits Security Administration of the U.S. Department of Labor informed Plan management the Plan was under review beginning with calendar year 2018. As of December 31, 2024, the Department of Labor has finished their review and did not take any actions against the Plan.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
