Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Communication Federal Credit Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) PLAN DESCRIPTION

The following description of the Communication Federal Credit Union 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. Fidelity Management Trust Company (“Fidelity”) is the active trustee of the Plan.

General and Eligibility

The Plan is a defined contribution plan covering substantially all employees of Communication Federal Credit Union (the “Company”) , except for nonresident aliens and employees covered under collective bargaining agreements. Effective January 25, 2021, the Plan was restated to incorporate legislative, regulatory, and administrative updates. Employees are eligible to participate after completing 3 months of service, as defined in the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan allows participants the option of making pre-tax or Roth after-tax 401(k) contributions. The total pre-tax and Roth after-tax contributions may not exceed statutory limits on 401(k) contributions.

Contributions

Upon eligibility, employees are automatically enrolled into the Plan with a 4% deferral percentage, unless the employee signs a waiver to decline enrollment before eligibility is reached. The deferral percentage increases by 1% the following year to reach a maximum of 5% of compensation, unless the employee elects otherwise.

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, not to exceed the maximum amounts established by the Internal Revenue Code of 1986 (the “Code”). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches 200% of up to 5% of a participant’s eligible compensation. The maximum annual Company contribution is 10% of participant compensation. Contributions are subject to certain statutory limitations.

(1) **PLAN DESCRIPTION, CONTINUED**

Participant Accounts/Investment Options

Each participant's account is credited with the participant's contribution and allocations of the Company's matching contribution, plan earnings, plan expenses, and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions and the Company's contributions among various investment options offered through the Plan's trustee. Participants may change their investment options at any time.

Vesting

Participants become fully vested in their contributed account balances plus actual earnings thereon immediately upon becoming eligible to participate. The participant becomes 20% vested in the employer contributed portion of the account after 2 years of service, as defined, and continues to vest at a rate of 20% for each year of service until 100% vested after 6 years of service.

Notes Receivable from Participants

Participants may borrow against their account balance a minimum of \$1,000 or up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. The loans are secured by the balance in the participant's account and are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid through payroll deduction and credited to the participant's account. Upon termination, retirement, or death, the participant (or beneficiary, as applicable) has the option to pay off the outstanding loan balance. If the participant or beneficiary elects not to pay off the loan, the outstanding loan balance is converted to a distribution.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or beneficiary, as applicable) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a rollover into another qualified retirement plan. Participants who have attained the age of 59½ are eligible to take in-service distributions. Additionally, hardship withdrawals are available to participants, subject to the plan agreement and applicable laws.

As of December 31, 2024 and 2023, there was approximately \$2,577,000 and \$1,941,000, respectively, of deferred vested benefits unpaid to participants who have terminated service with the Company.

As of December 31, 2024 and 2023, there were no significant unpaid vested benefits to participants who had requested withdrawal of his/her account.

Forfeitures

The Plan treats forfeitures as a reduction of the employer contributions otherwise made for the plan year in which the forfeiture occurs. The Advisory Committee also has the option to use the forfeitures to pay plan expenses. In 2024, there was approximately \$201,000 of forfeitures. At December 31, 2024 and 2023, unallocated forfeitures amounted to approximately \$41,000 and \$152,000, respectively.

(1) **PLAN DESCRIPTION, CONTINUED**

Plan Termination

The Company reserves the right to terminate the Plan at any time subject to the Plan's provisions. In the event of termination of the Plan, all employees affected by the termination will become 100% vested in their account balances, unless the Plan is replaced by a comparable plan. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or the participant's beneficiary at the time prescribed by the Plan's terms and the Code. The Company has no intentions of terminating the Plan at this time.

Administration of Plan Assets

The Plan's trustee invests the contributions received, as well as interest and dividend income, and makes distributions to participants.

Administrative Expenses

Certain expenses of the Plan are paid by the Company. The remaining plan expenses are allocated to each participant's account. In addition, fees are assessed on participant-directed transactions within the Plan and are charged to the participant's account.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. See Note 4 for a discussion of fair value measurements.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

Plan participants may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Date of Management's Review of Subsequent Events

Management has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued, and determined that no subsequent events occurred that require adjustment to or disclosure in the financial statements.

(3) **STABLE VALUE FUND**

The Plan invests in the Fidelity Advisor Stable Value Portfolio Fund, which is a collective investment trust fund sponsored by Fidelity. The fund's primary investment objective is to seek the preservation of capital, as well as provide a competitive level of income over time consistent with the preservation of capital. The fund invests primarily in investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds. Contract value is generally equal to the principal amounts invested in the underlying investments, plus interest accrued at a crediting rate established under the contract, less any adjustment for withdrawals. The stable value fund is expected to have a constant contract value of \$1, although there is no assurance that it will remain constant at \$1.

(3) **STABLE VALUE FUND, CONTINUED**

Participants may ordinarily direct an in-service withdrawal or a withdrawal following termination of employment of their investment at contract value on any business day. Withdrawals made in order to accommodate a participant-directed exchange to another investment option within the Plan may be made on any business day, provided that the exchange is not directed into a competing fund. The fund's trust agreement provides that withdrawals for events other than normal benefit payments or plan permitted investment option transfers are subject to a market value adjustment or to a contract charge or penalty. These events may include, but are not limited to, the following: sale of a division of the Company, a corporate layoff or early retirement program, change(s) in the investment options of the Plan, or termination or partial termination of the Plan. Withdrawals directed by the Company must be preceded by 12 months' written notice to Fidelity. At December 31, 2024, the Company believes the occurrence of an event that would limit the ability of the stable value fund to transact at contract value with the participants in the fund is not probable.

(4) **FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In estimating fair value, the Plan utilizes valuation techniques that are consistent with the market approach, the income approach, and/or the cost approach. Such valuation techniques are consistently applied. Inputs to valuation techniques include the assumptions that market participants would use in pricing an asset or liability. Fair values may not represent actual values of assets and liabilities that could have been realized on the measurement date or that will be realized in the future. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

Accounting Standards Codification (ASC) Topic 820, "Fair Value Measurement," establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset and liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

(4) FAIR VALUE MEASUREMENTS, CONTINUED

The Plan uses appropriate valuation methods based on the available inputs to measure the fair value of its assets and liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits, as well as the general classification of such assets pursuant to the valuation hierarchy.

Registered Investment Companies

The fair values of registered investment companies are based on quoted prices for identical assets in active markets.

Stable Value Fund

Reported at fair value using net asset value (NAV) as a practical expedient. The stable value fund calculates NAV per share in a manner consistent with the measurement principles in ASC Topic 946, "Financial Services—Investment Companies." Those measurement principles indicate that, in the determination of a stable value fund's NAV, the relevant measurement is net assets, which include the fully benefit-responsive investment contracts held by the fund at contract value. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(6) TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain officers and employees of the Company provide administrative services to the Plan. No officers or employees received any compensation from the Plan.

Certain plan investments are managed by the Plan's trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations, except participant loan related fees which are paid by participants' accounts.

(7) TAX STATUS

The Plan is a pre-approved plan offered by Fidelity, the trustee of the Plan. The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the date of the financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

We have audited the financial statements of the Communication Federal Credit Union 401(k) Plan (the “Plan”) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] as of and for the year ended December 31, 2024, and have issued our report thereon dated July 10, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the plan by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States. Accordingly, the objective of an ERISA Section 103(a)(3)(c) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects in accordance with accounting principles generally accepted in the United States. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated March 3, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of other existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Significant Audit Matters, Continued

Qualitative Aspects of Accounting Practices, Continued

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements were the fair values of the investments, which were provided and certified by the Plan's trustee.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We identified no such misstatements.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated July 10, 2025.

Significant Audit Matters, Continued

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditors’ opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the Information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Required Communications

We as independent auditors are required to:

- a. Communicate significant deficiencies and material weaknesses in internal control to the audit committee or its equivalent.
- b. Report directly to the audit committee (or equivalent) any fraud that causes a material misstatement of the financial statements and any fraud involving senior management. Fraud perpetrated by lower-level employees is also to be reported if it resulted in an individually significant misstatement.
- c. Report illegal acts and noncompliance with laws and regulations that come to our attention (except those that are clearly inconsequential).
