Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Technical Chemical Company 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Technical Chemical Company 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan whereby eligible employees of Technical Chemical Company (the Company or Employer or Plan Sponsor) are permitted to make pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on May 1, 1997.

Eligibility: Effective on January 1, 2022, all employees of the Company are eligible to participate in the Plan on the entry date (first day of the fiscal quarter) coincident with or following the date of hire. Employees are eligible to participate in the Plan upon meeting age requirement of 18 years of age and may enter the Plan on the entry date.

Contributions and investment options: Each year, participants may contribute between 1% and 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to the maximum limitation imposed by the IRC. The Plan allows for discretionary matching contributions equal to a discretionary percentage, to be determined by the Company on a periodic basis. For the year ended December 31, 2024, the employer elected to make a discretionary match of 100% of the participant's contribution up to a limit of 6% of compensation. Additionally, profit sharing contributions may be contributed at the option of the Company on a discretionary basis on behalf of all eligible employees whether or not they made elective contributions for the Plan year. For the year ended December 31, 2024, no profit sharing contributions were made to the Plan.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts and a stable value investment contract as investment options for participants.

Participant accounts: Each participant's account is credited with the participant's contribution, rollover contributions and allocation of (a) the Company's discretionary matching contributions and Company's discretionary profit-sharing contributions, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary profit-sharing contributions is based on years of continuous service. A participant is 20% vested after two years of credited service, 20% for each additional year, and is fully vested after six years. A participant is 100% vested regardless of years of service, upon disability, death or attaining normal retirement age.

Payment of benefits: On termination of service due to death, disability, termination of employment or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or as various types of annuities as specified in the Plan. If the participant's vested balance is less than \$5,000, benefits shall be distributed to the participant through a lump-sum distribution.

Note 1. Description of the Plan (Continued)

Forfeited accounts: Forfeitures are retained in the Plan and used to reduce future Company contributions under the Plan or to pay for plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,148 and \$1,020, respectively. During 2024, amounts of employer nonvested contributions forfeited was \$58,823 and \$57,777 was used to reduce Company contributions.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 and a maximum of \$50,000, up to 50% of the participant's vested account balance. Each note bears interest at a commercially reasonable rate of interest as determined by the Plan Administrator. Interest rates on outstanding notes receivable ranged from 4.25% to 9.50% at December 31, 2024. Note terms generally range from one to five years except for notes to purchase a principal residence, which can exceed five years, but not exceed 15 years. Principal and interest are paid ratably through payroll deductions, and notes receivable outstanding at December 31, 2024, are due in various amounts through December 2029. A participant can only have two new notes per plan year and may only have two notes outstanding at any time.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Administrative expenses are paid by the Company or the Plan. Certain administrative functions are performed by employees of the Company. However, such employees receive no compensation from the Plan.

Note 3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures (ASC 820), establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are discussed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of an input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued at net asset value (NAV), as a practical expedient, which is based on the market value of the underlying investments held by the pooled separate account.

Investment contract: The investment contract is made up of a stable value fund that is composed primarily of indirect fully benefit-responsive contracts. The investment contract is valued at contract value and is based on its beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement which approximates fair value, and is classified as a Level 2 investment in the fair value hierarchy.

Note 7. Income Tax Status

The Technical Chemical Company 401(k) Retirement Plan is a volume submitter plan of Transamerica Life Insurance Company. The Internal Revenue Service has determined and informed the custodian by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 8. Risks and Uncertainties

The Plan may invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Plan Termination

While there is no intention to do so, the Company reserves the right to terminate the Plan. In the event of termination of the Plan, the participants become fully vested in their employer contribution balances, and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.
