NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Coupa Software, Inc. Retirement Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established in 2009 by Coupa Software, Inc. (the "Company") to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Administration and Expenses

An Administrative Committee (the "Committee") manages the operation and administration of the Plan. The Committee designated Fidelity Management Trust Company ("Fidelity") to serve as trustee and to provide record keeping and administrative services.

Investment fund management fees and operating expenses are charged directly to the fund and are thereby factored into each fund as a reduction in investment return. Certain transaction fees including withdrawal and participant loan administration fees are charged directly to participants. Other costs of operating the Plan are paid by the Company.

C. Eligibility

Substantially all regular employees of the Company age 18 or older are eligible to participate in the Plan on the first day of the month following employment.

D. Contributions

Participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the maximum amount permitted under provisions of the Code. Participants age 50 or older may elect to make additional catch-up contributions subject to applicable Code limits. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation.

Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, will be auto-enrolled at a pre-tax contribution rate of 5% of eligible compensation, thirty days after the employee's date of hire.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are invested in accordance with participant directions and Plan provisions.

The Company may make a discretionary matching employer contribution on behalf of eligible participants. For 2024, the Company made discretionary matching employer contributions to eligible participants equal to 100% of the first 5% of eligible compensation, up to a maximum contribution of \$5,000 per participant. The discretionary matching employer contribution maximum contribution was increased to \$7,500 per participant in 2025.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions and an allocation of the participant's share of Plan earnings or losses and expenses. Plan assets are invested based on participant directions. Participants may select investments from a diversified menu of mutual funds. The contributions of participants who decline to make an investment election are invested T. Rowe Price Retirement Fund appropriate for the individual's age and projected date of retirement.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their entire account balance.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account, bears a fixed rate of interest based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50% with various maturities through September 2034.

Notes are measured at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability attainment of age 59 ½ or retirement, a participant may maintain his or her account in the Plan or elect to receive benefits in a lump sum. Effective May 15, 2024, the Plan allowed participants to elect installment payment distributions or partial withdrawals subject to provisions of the Plan. Hardship distributions are available under limited circumstances, as defined in the Plan, subject to the approval of the plan administrator. If a participant's vested account is greater than \$1,000 but less than \$5,000, and if the participant does not elect to have a rollover into a specific retirement account or to receive a distribution directly, such account will be rolled over to an Individual Retirement Account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The plan administrator believes the Plan is currently designed and operated in accordance with the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by affiliates of the trustee. Purchases and sales of these funds and payments of direct and indirect administrative and investment management fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.
