### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Community First Bank of Indiana 401(k)/Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Note 1. Description of the Plan**

### ***General***

The following description of Community First Bank of Indiana 401(k)/Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Community First Bank of Indiana (Company) for the benefit of its eligible employees who, prior to October 1, 2023, have at least six months of service and are age 21 or older. After October 1, 2023, employees must have at least 90 days of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Life Insurance Company and Principal Trust Company serve as Plan custodians.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective October 1, 2023, the service requirement for Plan participation was amended to 90 days. The Plan was also amended to implement an auto-enrollment feature whereby newly eligible participants are automatically enrolled at 1%. An auto-escalation feature was implemented through which all participants will have elective deferrals increased 1% annually, up to a cap of 6%.

The Company makes matching contributions of 100% percent of employees' salary deferral amounts on the first 6% percent of employees' compensation. Company qualified non-elective contributions are 3% of eligible compensation for the Plan year. The Company may elect to make discretionary profit sharing contributions; no such contributions were made for 2024 or 2023. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants are immediately vested in the Company's safe-harbor contributions. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Participants are allowed up to five loans outstanding. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service, participants may elect to receive or defer a lump-sum amount equal to the value of their account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,906 and \$21,557, respectively. These accounts will be used to reduce future employer contributions. During 2024 and 2023, forfeitures of \$23,566 and \$24,190, respectively, were used to reduce employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. The valuation of Company common stock held by the Plan is particularly subject to change in the near term.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Investments in the Company's common stock are valued at estimated fair value as determined by an annual independent valuation of the stock.

The Plan's interest in the common collective trust fund is valued at NAV utilizing the practical expedient. The collective investment fund invests in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The funds may invest in securities, guaranteed investment contracts, a combination of other collective funds, or swap and option contracts. The net asset value of the fund is determined by utilizing the values of the underlying assets. The fund can be redeemed daily.

Pooled separate accounts are valued at estimated fair value as provided by Principal Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Plan Tax Status***

The Plan operates under a volume submitter profit-sharing agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document has received a favorable opinion letter from the IRS. The Plan has been amended since the prototype document has received its opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023, excluding investments in the Company's common stock.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, excluding investment income on the Company's common stock.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024, excluding investments in the Company's common stock.

The Plan's independent auditors did perform auditing procedures with respect to the Company's common stock held by the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The administrative fees of \$46,801 and \$69,563 were paid during the Plan years 2024 and 2023, respectively, to the Plan custodian. The Plan paid \$23,012 of investment management fees during 2024.

Certain participants hold Company common stock in their accounts in the Plan. Contributions are not directed to Company common stock and transfers of Company common stock in and out of the Plan are not permitted. Participants may buy or sell shares of Company common stock during open transfer periods as determined at the Company's discretion. During 2024, the Company held an open transfer window, during which 6,900 shares were purchased and 4,200 shares were sold by participants. All shares were transacted at fair value as of December 31, 2023, as described in Note 5. 1,500 and 1,250 shares held by a terminated participant were included in benefits paid to participants during 2024 and 2023, respectively. The Plan held 27,951 and 26,751 shares of Company common stock as of December 31, 2024 and 2023, respectively. There were no dividends on Company common stock during 2024 and 2023. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See below for inputs and valuation techniques used for Level 3 securities.

Investments in Company common stock are valued by an annual independent valuation. The fair value per share was \$39.00 at December 31, 2024 and \$32.75 at December 31, 2023. The Plan Administrator hires the firm that completes the valuation. The Plan Administrator also reviews and evaluates the valuation firm's qualifications, methodology and assumptions, which involves discussions with the valuation firm, verification of the financial information used in the valuation, and approval for the use of the assigned value in the Plan's financial accounting. The fair value is derived using a combination of historical financial information and projected earnings and cash flow information for the Company and comparisons to other comparable businesses, as well as other input factors. The valuation includes a discount for lack of marketability as the Company is not publicly traded. The Company management provides the valuation firm with all necessary information to perform the valuation including historical and projected financial information of the Company.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Note 8. Risks and Uncertainties**

***Investments***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Reconciliation of Financial Statements to Form 5500**

The difference between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service (IRS) and the accompanying financial statements are primarily attributable to the difference in recording the fair value of Company stock, which is disclosed a year in arrears on the Form 5500 based on timing of receiving the independent valuation.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through June 4, 2025, which is the date the financial statements were available to be issued.
