## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of the  
Versabar 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Versabar 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2a of these financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that manner.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

**NOTES TO FINANCIAL STATEMENTS**  
**(MODIFIED CASH BASIS)**

**Versabar 401(k) Profit Sharing Plan**

December 31, 2024 and 2023

**Note 1 - PLAN DESCRIPTION**

The following description of the Versabar 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**a. General**

The Plan is a defined contribution plan covering all employees of Versabar, Inc., Versatruss, Versatech Automation Services, LLC, and Versamarine, (the “Employers”) who have six months of service and are age twenty-one or older, other than (a) employees covered by a collective bargaining agreement, (b) non-resident aliens and (c) interns and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**b. Contributions**

Participants may contribute, by salary reduction pursuant to Section 401(k) of the Internal Revenue Code (the “Code”), up to 100% of their pretax annual compensation, as defined in the Plan, not to exceed statutory limits. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

The Employers match 100% of each participant’s elective deferral up to 4% of the participant’s eligible compensation. For the year ended December 31, 2024, the Employers contributed \$774,036.

In any year, the Employers may also make discretionary non-elective contributions and/or qualified non-elective contributions. The Employers made no discretionary non-elective contributions or qualified non-elective contributions for the year ended December 31, 2024.

**Note 1 - PLAN DESCRIPTION (Continued)**

**c. Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Employers' contributions and plan earnings. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations of Employers' contributions are based on participant compensation or salary deferrals, as defined in the plan document, and allocations of plan earnings or losses and expenses are based on account balances or transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d. Vesting**

Participants are immediately vested in their 401(k) deferral contributions, rollover contributions, and Employers' contributions plus actual earnings thereon.

**e. Investment Options**

The Plan provides a participant-directed investment program, whereby participants select the investments for their accounts. The Plan currently offers several mutual funds and a money market fund as investment options to the participants. These investment options represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

**f. Notes Receivable from Participants**

The Plan does not allow participants to borrow from their accounts.

**g. Payment of Benefits**

Benefits are paid in the form of a lump sum. Upon termination of service, a participant whose vested account balance is greater than \$1,000 but less than \$7,000 (previously \$5,000) will be distributed to an Individual Retirement Account or Annuity. Participants with vested account balances of \$1,000 or less will receive an involuntary distribution of their account balances. Additionally, a participant may request an in-service withdrawal of all or part of his or her account balance upon reaching age 59½ or part of the elective deferral portion or safe harbor match of his or her account may be withdrawn as a hardship distribution, as defined in the plan document.

**Note 1 - PLAN DESCRIPTION (Continued)**

**h. Forfeitures**

Forfeited accounts are applied to pay administrative expenses or to reduce the contributions of the Employer. During 2024, forfeitures were not used to reduce Employer contributions. The Plan had no nonvested account forfeitures as of December 31, 2023.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**a. Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Contributions are recognized when received. Expenses are recorded when paid.

**b. Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**c. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value based on information provided by Fidelity Management Trust Company. Fair value is the price that would be required to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**d. Payment of Benefits**

Benefits are recorded when paid.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**e. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**f. SECURE 2.0 Act of 2022**

On December 29, 2022, the SECURE 2.0 Act was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates.

Significant provisions were as follows:

- The RMD age was increased from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- The excise tax for failure to take RMDs was reduced from 50 percent to 25 percent of the RMD amount that was not taken, beginning January 1, 2023; and
- All catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) are required to be designated as Roth 401(k) contributions beginning after December 31, 2023. However, in August 2023, the Internal Revenue Service (IRS) announced an administrative transition period that delays this requirement until taxable years beginning after December 31, 2025.

The Plan will incorporate changes in its plan document and administration to the extent required by the “SECURE 2.0 Act”.

**g. Subsequent Events**

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained and derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

**Note 4 - FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Money market and mutual funds:* Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price (Level 1). The money market and mutual funds held by the Plan were deemed to be actively traded.

**Note 5 - RISK AND UNCERTAINTIES**

The Plan provides for various investments in certain mutual funds and a money market fund. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6 - PLAN TERMINATION**

Although they have not expressed any intent to do so, the Employers have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participant accounts will be paid to the participant in accordance with the plan document.

**Note 7 - TAX STATUS**

Effective August 30, 2021, the Plan was restated by the adoption of a non-standardized pre-approved profit-sharing plan. The document sponsor received a favorable opinion letter from the IRS dated June 30, 2020, which states that the non-standardized pre-approved plan is acceptable under the Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the letter, the Plan administrator and legal counsel believe the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds and a money market fund managed by affiliates of Fidelity Management Trust Company. Additionally, an affiliate of Fidelity Management Trust Company provides recordkeeping services. Fidelity Management Trust Company acts as the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment services are included in net depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of the  
Versabar 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Versabar 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2a of these financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that manner.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS**  
**(MODIFIED CASH BASIS)**

**Versabar 401(k) Profit Sharing Plan**

December 31, 2024 and 2023

**Note 1 - PLAN DESCRIPTION**

The following description of the Versabar 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

**a. General**

The Plan is a defined contribution plan covering all employees of Versabar, Inc., Versatruss, Versatech Automation Services, LLC, and Versamarine, (the “Employers”) who have six months of service and are age twenty-one or older, other than (a) employees covered by a collective bargaining agreement, (b) non-resident aliens and (c) interns and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**b. Contributions**

Participants may contribute, by salary reduction pursuant to Section 401(k) of the Internal Revenue Code (the “Code”), up to 100% of their pretax annual compensation, as defined in the Plan, not to exceed statutory limits. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

The Employers match 100% of each participant’s elective deferral up to 4% of the participant’s eligible compensation. For the year ended December 31, 2024, the Employers contributed \$774,036.

In any year, the Employers may also make discretionary non-elective contributions and/or qualified non-elective contributions. The Employers made no discretionary non-elective contributions or qualified non-elective contributions for the year ended December 31, 2024.

**Note 1 - PLAN DESCRIPTION (Continued)**

**c. Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Employers' contributions and plan earnings. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations of Employers' contributions are based on participant compensation or salary deferrals, as defined in the plan document, and allocations of plan earnings or losses and expenses are based on account balances or transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d. Vesting**

Participants are immediately vested in their 401(k) deferral contributions, rollover contributions, and Employers' contributions plus actual earnings thereon.

**e. Investment Options**

The Plan provides a participant-directed investment program, whereby participants select the investments for their accounts. The Plan currently offers several mutual funds and a money market fund as investment options to the participants. These investment options represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

**f. Notes Receivable from Participants**

The Plan does not allow participants to borrow from their accounts.

**g. Payment of Benefits**

Benefits are paid in the form of a lump sum. Upon termination of service, a participant whose vested account balance is greater than \$1,000 but less than \$7,000 (previously \$5,000) will be distributed to an Individual Retirement Account or Annuity. Participants with vested account balances of \$1,000 or less will receive an involuntary distribution of their account balances. Additionally, a participant may request an in-service withdrawal of all or part of his or her account balance upon reaching age 59½ or part of the elective deferral portion or safe harbor match of his or her account may be withdrawn as a hardship distribution, as defined in the plan document.

**Note 1 - PLAN DESCRIPTION (Continued)**

**h. Forfeitures**

Forfeited accounts are applied to pay administrative expenses or to reduce the contributions of the Employer. During 2024, forfeitures were not used to reduce Employer contributions. The Plan had no nonvested account forfeitures as of December 31, 2023.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**a. Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Contributions are recognized when received. Expenses are recorded when paid.

**b. Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**c. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value based on information provided by Fidelity Management Trust Company. Fair value is the price that would be required to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**d. Payment of Benefits**

Benefits are recorded when paid.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**e. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**f. SECURE 2.0 Act of 2022**

On December 29, 2022, the SECURE 2.0 Act was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates.

Significant provisions were as follows:

- The RMD age was increased from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- The excise tax for failure to take RMDs was reduced from 50 percent to 25 percent of the RMD amount that was not taken, beginning January 1, 2023; and
- All catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) are required to be designated as Roth 401(k) contributions beginning after December 31, 2023. However, in August 2023, the Internal Revenue Service (IRS) announced an administrative transition period that delays this requirement until taxable years beginning after December 31, 2025.

The Plan will incorporate changes in its plan document and administration to the extent required by the “SECURE 2.0 Act”.

**g. Subsequent Events**

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained and derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

**Note 4 - FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Money market and mutual funds:* Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price (Level 1). The money market and mutual funds held by the Plan were deemed to be actively traded.

**Note 5 - RISK AND UNCERTAINTIES**

The Plan provides for various investments in certain mutual funds and a money market fund. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6 - PLAN TERMINATION**

Although they have not expressed any intent to do so, the Employers have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participant accounts will be paid to the participant in accordance with the plan document.

**Note 7 - TAX STATUS**

Effective August 30, 2021, the Plan was restated by the adoption of a non-standardized pre-approved profit-sharing plan. The document sponsor received a favorable opinion letter from the IRS dated June 30, 2020, which states that the non-standardized pre-approved plan is acceptable under the Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the letter, the Plan administrator and legal counsel believe the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds and a money market fund managed by affiliates of Fidelity Management Trust Company. Additionally, an affiliate of Fidelity Management Trust Company provides recordkeeping services. Fidelity Management Trust Company acts as the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment services are included in net depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.
