NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Pete King 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established for participation on January 1, 2023 and It is a defined contribution plan covering all eligible employees at Pete King Construction Company, Pete King Corp, and Nally Construction Company (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Under the provisions of the Plan effective January 1, 2023, each employee shall be eligible to participate in the Plan upon completing one year of service. The entry date will be the first day of the plan year quarter coinciding with or next following the date that eligibility requirements are met. Eligible employees do not include individuals classified as a nonresident alien who received no U.S. income and members of a collective bargaining unit.

Contributions

Each year, participants may elect to contribute to the Plan through tax-deferred salary deferrals subject to certain statutory limits as determined by the Internal Revenue Service ("IRS"). During 2024 and 2023 the limits were \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. During 2024 and 2023, the catch-up contribution limit was \$7,500. Participants direct the investments of all contributions into various investment options offered by the Plan.

The Plan has an auto-enrollment feature which begins at 3%. Participants have the option elect an alternative deferral amount or to elect not to defer under the Plan.

For the years ended December 31, 2024 and 2023, employee contributions receivable were \$7,037 and \$18,882, respectively. No allowance for credit losses on the employee contributions receivable was deemed necessary by the Plan as the receivable is considered fully collectible by the Plan due to the nature of these contributions.

Company Matching Contributions

Each year, the Company will make a basic safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. For the year ended December 31, 2024, the safe harbor matching contribution totaled \$1,088,003.

Company Matching Contributions - Continued

For the years ended December 31, 2024 and 2023, employer contributions receivable were \$5,694 and \$18,964, respectively. No allowance for credit losses on the employer contributions receivable was deemed necessary by the Plan as the receivable is considered fully collectible by the Plan due to the nature of these contributions.

Vesting

Participants are immediately vested in their contributions and the Company's employer safe harbor matching contributions plus actual earnings thereon.

Hardship Withdrawal

The Plan does not offer hardship withdrawals.

Notes Receivable from Participants

Notes receivable from participants are not permitted by the Plan.

Participant Accounts

All investment options are participant directed. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings, and reduced for any Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or partial payments, in accordance with the provisions of the Plan. In the event that a participant dies before retirement, their beneficiary will receive the value of the participant's account balance in a lump-sum or partial distribution.

Forfeitures

Forfeitures of Company contributions may be used to first reduce any administrative expenses and then to reduce the Company's contributions. At December 31, 2024 and 2023, there were no forfeited non-vested accounts. In 2024 no administrative expenses and employer contributions were reduced from forfeited non-vested accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to the administration of participants' activities are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Concentration of Credit Risk and Financial Instruments

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of deposits and securities held by a broker.

Subsequent Events

Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted net asset values of the shares as reported by the fund. The registered investment companies held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The registered investment companies held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

Money market funds are valued at amortized cost, which approximates fair value. The amortized cost of the instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity. Securities held by the money market funds are generally high quality and liquid; however, they are reflected as Level 2 because the inputs used to determine fair value are not quoted prices in an active market.

NOTE 5. TAX STATUS OF THE PLAN

The IRS has determined and informed the Company in a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator and Sponsor's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and is tax-exempt.

The Plan follows the provisions of ASC 740, *Income Taxes* of the FASB Accounting Standards Codification. The Plan believes it has no uncertain tax positions that qualify for either recognition or disclosure. As of December 31, 2024, the Plan is subject to examination of all its forms 5500 by the IRS.

NOTE 6. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA.

NOTE 7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risk.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan investments consist of registered investment companies held by Charles Schwab Trust Bank ("Schwab"). Schwab is the Custodian and Tri-Ad Actuarial, Inc. ("Tri-Ad") is the Recordkeeper, as defined by the Plan and, therefore these transactions qualify as party-in-interest. Total fees paid by the Plan to Schwab and Tri-Ad during the year ended December 31, 2024 were \$26,120. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9. SEPARATED PARTICIPANTS

At December 31, 2024, there were two participants who had elected to withdraw an aggregate of \$10,013 of from the Plan but had not yet been paid, however, the participants were paid in January 2025. At December 31, 2023, there were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but have not yet been paid.
