NOTE A -- Description of plan and significant accounting policies

The following brief description of the WDI, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. WDI, LLC ("the company," also referred to as "the employer") adopted the Associated Trust Company, N.A. Pre-Approved Defined Contribution Plan originally effective on January 14, 2000. The plan has been subsequently amended and restated with the most recent restatement effective January 1, 2022.

General

The Plan is a defined contribution plan covering all employees (with the exception of collectively bargained and leased employees) of the company who have completed one year of service (1,000 hours) and have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance, and report to the company's owners.

Effective March 10, 2023, the plan was amended to include Wisconsin Distributors Appleton, LLC as participating employer.

The Plan's federal identification number is 20-4213074 and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The company may make a discretionary matching contribution equal to uniform percentage and dollar amount of participant elective deferrals. The company made a discretionary matching contribution of 100% of the participant elective deferrals up to a 3% participant contribution for the year ended December 31, 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Participant accounts and "rollovers"

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's discretionary matching contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of company contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

NOTE A -- Description of plan and significant accounting policies (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested ratably after three years of credited service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 2% over the prime rate (7.50% at December 31, 2024). Principal and interest is paid ratably through payroll deductions.

Benefits

On termination of service due to death, disability, or retirement (age 65), a participant may elect to receive a lump-sum amount equal to the entire or partial value of the participant's vested interest in his or her account, annual installments over a set number of years or roll over the distribution to another qualified plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59 ½ or any age or at normal retirement age. A participant with an account valued at less than \$5,000 shall receive a lump sum distribution. For accounts exceeding \$5,000 the participant may elect a lump sum distribution, annual installments over a set number of year or the participant may elect to roll over the distribution to another qualified plan.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. It is at the discretion of the company to determine the use of forfeitures each year. In 2024, company contributions were reduced by \$6,812 from forfeited nonvested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(K) Committee determine the Plan's valuation policies utilizing information provided by the investment advisers and asset custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The plan sponsor and employer pays most of the administrative expenses of the Plan, which are excluded from these financial statements. The major administrative expenses are recordkeeping fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Subsequent events

These financial statements have not been updated for subsequent events occurring after August 4, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after that date.

NOTE B -- Information certified by the trustee and asset custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and dividends, net appreciation and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Associated Trust Company, N.A. (Associated), the trustee and asset custodian of the Plan.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust funds. Composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE D -- Party-in-interest transactions

Certain Plan investments are managed by Associated and Associated is the trustee and asset custodian for the Plan, and therefore, these transactions qualify as party in interest transactions.

Associated provides certain administrative services to the Plan pursuant to a Retirement Plan Service Agreement with the company. Associated receives revenue from mutual fund service providers for services Associated provides to the funds. This revenue is used to offset certain amounts owed to Associated for its administrative services to the Plan.

If the revenue received by Associated from such mutual fund service providers exceeds the amount owed, Associated remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Associated for administrative expenses not covered by revenue sharing.

Fees were also paid by the Plan during the year for accounting services rendered by SVA Certified Public Accountants, S.C. These transactions also qualify as party-in-interest transactions.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their allocated company contributions.

NOTE F -- Tax status

The Associated Trust Company, N.A. Pre-Approved Defined Contribution Plan that the Plan has adopted effective January 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
