Note 1: Description of Plan

The following description of the Larkin, Hoffman, Daly & Lindgren, Ltd. Profit Sharing Plan and Trust ("the Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Larkin, Hoffman, Daly & Lindgren, Ltd. and effective April 1, 2024 Larkin Hoffman Public Affairs, Inc. (collectively the "Employer"). An employee is eligible to participate in the Plan upon completion of one hour of service and attaining age 21. Employees are eligible to begin participating in the Plan the first day of the quarter after the eligibility requirements are met. To be eligible to receive employer discretionary matching contributions and profit sharing contributions, participants need to have met the eligibility requirements noted above, have worked at least 1,000 hours during the 12-month period, and be employed as of the last day of the plan year or have terminated after reaching normal retirement age, died or became disabled during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer's contribution to the Plan each year is at the discretion of the Employer's Board of Directors. Discretionary profit sharing contributions amounted to \$1,279,708 and \$1,255,410 for the years ending March 31, 2025 and 2024, respectively, and discretionary matching contributions, net of forfeitures, amounted to \$201,614 and \$219,463 for the years ending March 31, 2025 and 2024, respectively.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contributions, Employer discretionary matching contributions, and an allocation of (a) the Employer's discretionary profit sharing contributions, (b) plan earnings, and (c) forfeitures of the non-vested portion of terminated participants' accounts (if applicable), and reduced by withdrawals and charged with an allocation of administrative expenses. Allocations are based on each participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from each participant's vested account.

Vesting

Participants are immediately vested in their rollover and salary deferral contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon, is based on years of service.

Employer contributions vest according to the following schedule, or having reached normal retirement age, death, or disability:

Investment Elections

Each participant may direct their contributions to be invested in one or more mutual funds and common/collective trust funds. They may also establish a segregated fund and self-manage the portfolio. Allocations must be in increments of 1% of each contribution. A participant may change such allocation at any time and may transfer all or a portion of the value of the account daily.

Participant Notes Receivable

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the Plan, with a minimum loan of \$1,000. Loan terms range up to 59 months for loans not related to a primary residence, or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% over the prime rate as of the date of the loan application. Principal and interest are paid ratably through monthly payroll deductions and interest income is recorded on the accrual basis. Interest rates range from 4.25% to 9.50% at March 31, 2025.

Plan Expenses

Certain administrative expenses and participant expenses are paid by the Plan. Other expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances are included in total investment income.

Payment of Benefits

On termination of service, participants will receive their vested benefits in either a lump-sum distribution or in installments. In the case of termination due to death, the beneficiary of the participant may receive the vested benefits as a lump-sum distribution or in a series of payments. Participants are allowed to receive in-service lump-sum distributions if they satisfy one of the following conditions (a) have attained age 59-1/2, (b) have incurred financial hardship as defined by the Plan, (c) have incurred disability as defined by the Plan, or (d) funds have been in the Plan for at least two years and are rolled over into a Roth IRA account. There were no amounts allocated to withdrawing participants for benefit payments that had been requested, but not yet paid, at March 31, 2025 or 2024.

Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Employer's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the plan document. At March 31, 2025 and 2024, forfeited nonvested accounts approximated \$117,392 and \$32,697, respectively. Forfeited amounts allocated to plan participants or used to reduce employer contributions were \$(32,697) and \$27,270 during the years ended March 31, 2025 and 2024, respectively.

SECURE 2.0 Act

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective January 1, 2023. Plan management evaluated the impact of the adoption and implementation of this legislation on the Plan and there was no material impact to the Plan for the years ended March 31, 2025 and 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a settlement date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of March 31, 2025 or 2024. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Subsequent Events

The Plan has evaluated subsequent events through August 22, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025 and 2024.

Self-directed accounts - Common stocks and mutual funds: Primarily valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Registered investment funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment funds are deemed to be actively traded.

Common/collective trust funds: Common collective trust funds that are comprised of primarily fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner. There were no unfunded commitments.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

Note 5: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company, d/b/a, Principal Trust Company as of March 31, 2025 and 2024 and for the years then ended. Delaware Charter Guarantee and Trust Company, d/b/a, Principal Trust Company is the Trustee of the Plan.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved document with an IRS notification letter, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

Certain administrative costs associated with the administration of the Plan are paid for by the Employer and are excluded from these financial statements.

The Plan invests in accounts managed by Delaware Charter Guarantee and Trust Company, d/b/a, Principal Trust Company, who serves as the Trustee for the investments in the Plan, and therefore, these transactions qualify as party-in-interest transactions. Principal Life Insurance Company is the record-keeper and Advanced Capital Group is the investment advisor, as defined by the plan and also qualifies as a party-in-interest which is exempt from the prohibited transaction rules. Fees incurred and paid by the Plan for the investment management, administrative services, and recordkeeping services were \$118,484 and \$115,830 for the years ending March 31, 2025 and 2024, respectively.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
