### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Air Tractor, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ## **Notes to Financial Statements**

### **Note 1. Description of the Plan**

The following description of the Air Tractor, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, which is available from Plan management, for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established on March 28, 1997 for the exclusive benefit of eligible employees of Air Tractor, Inc. (the Company). The following employees are not eligible to participate in the Plan: (a) collective bargaining employees, (b) nonresident aliens who do not receive any earned income from the Company which constitutes United States source income, and (c) leased employees. All other employees shall initially be eligible to participate in the Plan on the first day of the month coinciding with or following the date in which he or she has attained the age of 21 and completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan.

#### **Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, subject to Internal Revenue Service (IRS) regulations, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also designate some of their contributions as after-tax contributions to a Roth 401(k) option. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees without an existing salary reduction agreement are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund. The Plan also includes provisions for an auto-escalation feature whereby automatically enrolled participants will have their deferral rate increased by 1 percent each Plan year until the deferral rate reaches 10 percent or until changed by the participant. Effective January 1, 2024 the Company contributes 100 percent of the first 3 percent of eligible compensation and 50 percent of the remaining eligible compensation over 3 percent up to a maximum of 5 percent of eligible compensation that a participant contributes to the Plan. This contribution is intended to satisfy a safe harbor contribution formula permitted by Internal Revenue Service (IRS) regulations. By making the safe harbor matching contribution, the Plan will automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made by the Plan. The safe harbor matching contribution replaced the previous discretionary match, which was 100 percent of eligible compensation up to \$2,000. Additional discretionary amounts may be contributed at the option of the Company's board of directors and are invested as directed by the participant. For the years ended December 31, 2024 and 2023, the Company made discretionary contributions in the amount of \$447,000 and \$423,956, respectively. These were in addition to the safe harbor matching contributions made in 2024. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, as well as allocations of Plan earnings. Participant accounts are adjusted daily for interest and dividends and gains and losses. Allocation of investment income to participants' accounts is determined based on each participant's proportionate interest in the investment. Discretionary employer contributions and forfeitures are allocated in the same ratio that each participant's compensation for the Plan year bears to the total participants for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Effective January 1, 2024, plan participants are now vested 100 percent immediately in the Company's safe harbor qualified matching contributions. An employee with more than three years of service (1,000 or more hours in a year) is 100 percent vested in the Company's discretionary contribution portion of their accounts. Employees with fewer than three years of service are not vested in any portion of in the Company's discretionary contribution portion of their accounts.

### **Payment of Benefits**

Upon separation of service due to retirement at age 65 or death or disability, if earlier, or termination of employment in the case of vested benefits, the balances in the employee's separate accounts are paid to the participant or his beneficiaries after the participant's separation from service.

### **Forfeited Accounts**

In the event a participant leaves the Plan and there are unvested amounts in his account due to employer contributions, those amounts are held as forfeitures and included as net assets available for benefits. If the participant becomes eligible to rejoin the Plan, he has the right to reclaim those amounts, subject to certain criteria in the Plan documents.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$605, respectively. These accounts will be allocated to participants as a Company contribution. During 2024 and 2023, \$25,327 and \$39,884, respectively, from forfeited nonvested accounts were allocated to participants as a Company contribution.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to increase the deferral rate for automatically enrolled participants from 3 percent to 5 percent of eligible compensation and increase the limit of the auto-escalation feature from 10 percent to 15 percent of eligible compensation.

### Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal), the trustee of the Plan.

During 2024 and 2023, the Plan held an interest in the Galliard Stable Return Fund PN, which has invested all of its assets in Galliard Stable Return Fund Core, a collective trust sponsored by SEI Trust Company. The Galliard Stable Return Fund Core invests in investment contracts and security backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security backed contract has similar characteristics to a traditional investment contract and is comprised of two parts: the first part is a fixed-income security or portfolio of fixed income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity.

There are several risks specific to investment contracts. One of the primary risks involved is credit risk of the contract issuer. Credit risk for security backed contracts includes risks arising from the potential inability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed income securities. Secondly, liquidity is limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk is also present because rates may be fixed with these products.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Investments held in participant self-directed accounts are securities that are traded in active markets. As such, the fair value will be the price of the security's last trade registered on the security's market of record on the reporting date, which follows the market approach.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

#### Note 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds, common collective trust funds and deposit accounts held by Principal. Principal is the record keeper and trustee for the Plan during this period, and therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

### **Note 7. Tax Status**

Effective July 31, 2022, the Plan adopted a non-standardized prototype defined contribution profit sharing plan with Internal Revenue Code (IRC) Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the IRS dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
