Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following description of the New Enterprise Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by New Enterprise Associates, Inc. (the Company) effective January 1, 1982. The Plan covers substantially all employees of the Company, as defined by the Plan. Employees can enter the Plan on the first day of the month that coincides with or follows the employee's date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was amended and restated effective January 1, 2021 to comply with tax law changes.

Participant Contributions

Participants may contribute up to 75% of their annual pre-tax compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants are permitted to make Roth elective contributions to the Plan. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for each of the years ended December 31, 2024 and 2023. Participants are permitted to make rollover contributions into the Plan.

Company Contributions

The Company makes a non-elective safe harbor contribution equal to 3% of a participant's eligible compensation, as defined by the Plan. The Company may make a discretionary contribution determined each year by the Company. In order to be eligible for the Company discretionary contribution, participants must be actively employed on the last day of the Plan year and complete at least 500 hours of service, unless their termination during the Plan year was due to retirement, disability or death. The Company made discretionary contributions equal to 10.33% and 10.182% of a participant's eligible compensation during the years ended December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Company's safe harbor matching contributions totaled \$1,040,754 and \$1,056,109, respectively. During the years ended December 31, 2024 and 2023, the Company's discretionary contributions totaled \$3,410,130 and \$3,285,215, respectively.

1. DESCRIPTION OF THE PLAN – cont'd.

Participant Accounts

Each participant's account is participant-directed and credited with the participant's contributions and distributions, and allocations of Company contributions. Any earnings, gains/losses, and administrative expenses are allocated to participants' accounts based upon the proportion of each participant's account balance to the total of all account balances within the respective fund. Upon enrollment, a participant may direct contributions to any of the Plan's fund options.

Notes Receivable from Participants

Participants may borrow up to 50% of their account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000. Participants may have up to two notes outstanding at any given time, one for personal use and one for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account. Note repayments are to be made through payroll deductions and bear interest at the prime rate as published in the Wall Street Journal at the time of note issuance. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence may be repaid over a ten-year period.

Payment of Benefits

Upon termination of service, death, disability, retirement or attainment of age 59 ½, a participant or their beneficiary, in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's account or periodic installments, as defined by the Plan. If the balance is less than \$5,000, a participant may only receive the value in his or her account as a lump sum distribution. Effective January 1, 2024, the Company adopted the SECURE Act provision to increase the amount to \$7,000 and is currently in the process of formally amending the Plan for this provision. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

Vesting

Participants are immediately vested in their contributions and Company contributions, plus earnings thereon.

Plan Expenses

All administrative expenses are required to be paid with the assets of the Plan, unless paid by the Company, at its discretion. During the years ended December 31, 2024 and 2023, the Company paid a portion of the direct expenses related to the Plan. Expenses that are paid directly by the Company are excluded from the Plan's financial statements.

Plan Expenses – cont'd.

The Plan utilizes the services of Mesirow Financial Investment Management, Inc. (Mesirow) as the Plan's external fiduciary. Fees for services are to be paid by T. Rowe Price at 5 basis points per year for assets up to \$50 million and 4 basis points per year for assets exceeding \$50 million. The Plan also has a Fee Extraction and Payment of Plan Expenses Procedure Agreement with T. Rowe Price and Mesirow, in which T. Rowe Price will extract a quarterly fiduciary service fee after quarter-end. T. Rowe Price will apply the specified basis points to the average month end plan assets (excluding loans) for the applicable quarter. Additionally, T. Rowe Price will extract the fiduciary service fee pro rata across all participant, beneficiary, alternate payee, and plan-level accounts with a balance.

Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Fair Value Measurement – cont’d.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest in common/collective trust (CCT): Valued using the net asset value (NAV) practical expedient of the CCT as provided by the CCT manager. The NAV practical expedient is based on the value of the underlying assets owned by the fund, less its liabilities, and divided by the number of units outstanding.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- (a) Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have been removed from the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts in the statements of net assets available for benefits.

The Plan’s NAV fund is a CCT, which is measured daily and may be redeemed daily with no restrictions related to the redemption notice period and it has no unfunded commitments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through July 25, 2025, the date the financial statements were available to be issued, and determined there were no material subsequent events that warrant disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years then ended was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, T. Rowe Price Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe Price. T. Rowe Price acts as Custodian for the Plan and is a related entity to the Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Mesirow provides the Plan with consulting, administrative, and investment management services.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. INCOME TAX STATUS

The Plan has adopted a non-standardized prototype plan, which received a favorable opinion letter on August 19, 2020 from the Internal Revenue Service. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the Internal Revenue Service and the Department of Labor; however, there are currently no audits for any periods in progress.
