**Note 1. Description of the Plan**

The following description of Siddons Martin Emergency Group 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 2005 sponsored by Siddons Martin Emergency Group, LLC and its wholly owned affiliates (collectively, Company or Employer) for the benefit of their employees who have at least 90 days of service and are age 21 or older and who are not members of a collective bargaining unit or a nonresident alien are eligible to participate in the Plan. Leased employees, independent contractors, seasonal, and temporary employees are not eligible to participate in the Plan. An eligible participant may begin contributing to the Plan on the first day of the month immediately following the eligibility requirements being met. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

An expansion of *Setting Every Community Up for Retirement Enhancement Act of 2019* (SECURE 2.0) was signed into law on December 29, 2022 as part of the *Consolidated Appropriations Act of 2023*. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first plan year beginning on or after January 1, 2025 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

**Plan Administration**

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Principal Trust Company (Principal) serves as the asset custodian and is responsible for the custody and management of the Plan's assets. Principal Life Insurance Company, an affiliate of the Custodian, has been retained to provide recordkeeping services for the Plan and is responsible for maintaining participant accounts and transactions related to participant-initiated activity.

**Contributions**

The Plan permits eligible employees through a pretax or Roth salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company contributes a safe harbor company matching contribution of 100% of each participant's elective deferrals up to 3% of the participant's eligible compensation, plus 50% of each participant's elective deferrals between 3% and 5% of the participant's eligible compensation. The Plan also allows for nonelective discretionary company contributions; however, no discretionary company contributions were made in 2024 or 2023.

**Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing 1% of eligible compensation unless the participant made affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 1% in the percentage deferred and is ultimately capped at 5%.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, and allocations of the Company's contributions and plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account

balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants may direct their account balances into any of the investment options offered by the Plan.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Loans bear interest at a reasonable rate as determined by the plan administrator. The maximum note term is five years unless the note qualifies as a home loan, in which case the term of the note is not to exceed 15 years. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

***Vesting***

Participants are immediately vested in rollover contributions, elective deferrals, and safe-harbor matching company contributions plus any actual earnings thereon. Vesting in the Company's nonelective discretionary company contributions plus any earnings thereon is based on years of continuous service.

Vesting in Company nonelective discretionary contributions, if any, is based on years of continuous service as follows:

***Forfeited Accounts***

The Plan provides that non-vested account balances of terminated employees can be used to pay plan expenses or to offset Employer contributions. There were no forfeitures available as of December 31, 2024 or 2023, and no forfeitures were used during the year ended December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment held by a defined contribution plan is required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits and changes therein.

***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value represents the contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts are valued at estimated fair value as provided by Principal. The Plan's interest in the common/collective trust funds is valued based on information reported by the investment advisor using the audited financial statements of the common/collective trusts at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments includes realized gain and losses on the investments bought and sold during the year, as well as investments held at the end of the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Contributions and Receivables***

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Company, which is the pay date. Company contributions are recorded in the year they are earned and to coincide with the year in which the Company records the contribution in its general ledger. The Plan records receivables for contributions based upon the contributions recognized less amounts received by the Plan as of the last day of the plan year. Rollover contributions from participants are recorded based on the date the rollover contributions have been received by the Custodian.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosure About Fair Value of Plans Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Mutual Funds***

Mutual fund investments are valued at the daily closing price as reported by the fund. Registered investment companies are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are classified within Level 1 of the valuation hierarchy.

***Pooled Separate Accounts***

Pooled separate accounts are valued at the NAV as a practical expedient to fair value and as determined by the fund issuer, based on the market value of underlying investments. While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted. Investments valued at NAV practical expedient are not disclosed within the fair value hierarchy but are disclosed as a reconciling amount to the Plan's investment fair value leveling table. There are no unfunded commitments or redemption restrictions.

***Collective Trusts***

Collective trust funds are valued at the NAV of units of the collective trust as a practical expedient to fair value, using independent pricing services approved by the Custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value as reported by the issuer. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Investments valued at NAV practical expedient are not disclosed within the fair value hierarchy but are disclosed as a reconciling amount to the Plan's investment fair value leveling table. There are no unfunded commitments or redemption restrictions.

***Recurring Measurements***

**Note 5. Investment Contract With Insurance Company**

The Plan maintains a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with contributions and with interest and charged for participant withdrawals and administrative expenses. The account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account does not permit the issuer to terminate the agreement prior to the scheduled maturity date. The guaranteed minimum interest rate must be greater than 1% and less than 3%. The crediting interest rate is reset semi-annually.

The Contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported in the Plan's financial statements at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit value for credit risk of the contract issuers or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity was provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. No events are probable of occurring that might limit the ability of the

Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**Note 6. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

**Note 8. Related-Party and Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Some fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Company. The Plan is not required to repay expenses paid by the Company on its behalf.

Certain fund-level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services and sub-transfer agency fees are paid through fund-level revenue-sharing agreements. These fees reduce the fund earnings, thereby impacting the investment return applied to the participants' accounts. Any excess amounts above the record keeping fees are credited back to the participants invested in the specific funds.

The Custodian utilizes omnibus accounts at unaffiliated banks to facilitate transactions for the plans it services and commingles funds in transit to or from the Plan. The unaffiliated banks charge fees for this service and the Custodian retains, as compensation for services provided to the Plan, any excess interest over the fees charged on amounts earned while certain transactions are pending (float). If the bank fees exceed the earnings, the Custodian will pay the excess fees. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain plan investments are owned and managed by the custodian; therefore, these transactions qualify as party-in-interest transactions.
