INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the MDVA Local 463 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of the MDVA Local 463 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 Financial Statements").

Plan management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. Description of Plan

The following description of the MDVA Local 463 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”) serves as trustee of the Plan.

General

The Plan is a defined contribution plan sponsored by Maryland & Virginia Milk Producers Cooperative Association, Inc. (the “Association”). The Plan covers hourly employees of the Association who are members of the Food Driver Salesmen, Dairy and Ice Cream Workers Local No. 463 at the Penn Maid Location. The Plan excludes non-bargaining employees, nonresident aliens, leased employees, and reclassified employees from participation. The Plan was established on May 1, 2023. The Association first employed members of Local No. 463 in March 2024.

During 2024, assets of \$75,733 were transferred from the Plan to the Maryland and Virginia Milk Producers Cooperative Association, Inc. 401(k) Retirement Plan. Transfers reflect account balances movements of employees who transfer between union and non-union employment at the Association.

Contributions

Each year, participants may make salary reduction contributions of a portion of pretax annual compensation instead of receiving that amount. Participants may also designate contributions as Roth contributions. Contributions are permitted by participants up to the maximum allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation with annual 1% increases up to 10% and their contributions are invested in a designated balanced fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary matching contributions of 50% of contribution up to 10% of the participant’s eligible compensation subject to a maximum matching contribution of \$5,000 during the Plan year.

The Plan provides for additional contributions by the Association subject to the terms of the labor agreement with the Penn Maid Location of Local 463. Additional contributions are scheduled to end on December 31, 2025 and are available to those active participants that were active members under the Dairy Industry Pension Fund as a member of Teamsters Local 463 as of December 31, 2020. Total additional contributions for the year ended December 31, 2024 totaled \$464,589.

The Association may make discretionary contribution subject to the terms of the Plan document. No discretionary contributions were declared by the Association for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Association’s discretionary matching contributions, the Association’s additional contributions, as well as allocations of the Association’s discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions and all employer contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$20,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate charged is based on the rates available for similar loans from commercial lending institutions. As of December 31, 2024, interest rates ranged from 9.50% to 10.50%. Principal and interest is paid ratably through regular payroll deductions. Loan terms shall not extend beyond five years from the date of the loan. A participant may only have one loan outstanding at any given time.

Payment of Benefits

Upon termination of service due to death, retirement, or otherwise a participant may receive a lump-sum amount equal to the value of the participant's vested interest. Annuities and installment payments are also available. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) upon termination, the Plan administrator may authorize the benefit payment without the participant's consent. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In circumstances when a terminated participant has a vested account balance greater than \$1,000 but less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. Under the terms of the Plan, participants are eligible for in-service benefit payments upon reaching age 59.5. Hardship distributions are also permitted from participant accounts, based on the terms of the Plan document.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Human Resource Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from Plan participants and discretionary matching contributions, if any, from the Association are recorded in the year in which the employee contributions are withheld from compensation. Additional contributions are recorded in the year earned. Additional discretionary contributions, if any, from the Association are recorded in the year in which the related compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Association. Expenses of maintaining the Plan that are paid directly by the Association are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment activity, including net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for the mutual funds (registered investment companies) and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan became effective May 1, 2023, however, no activity occurred until 2024, therefore, there were no fair value measurements as of December 31, 2023.

5. Related Party and Party-In-Interest Transactions

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company provides trustee and recordkeeper services to the Plan. Certain Plan expenses may be paid to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company or its affiliates. Therefore, transactions with these parties qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

6. Plan Termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in any employer contributions for which they were not already vested.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

Effective May 1, 2023, through the adoption of a Principal Financial Group Pre-Approved Document for Savings Plans, the Plan was established. The Internal Revenue Service ("IRS") issued an opinion letter, dated June 30, 2020, stating that the prototype non-standardized profit sharing plan document was designed in accordance with applicable IRC requirements as of that date.

Although the Association has not applied for a determination letter for the Plan, and the Plan has subsequently been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. As the Plan became effective during 2023, all years remain subject to income tax examination as of December 31, 2024.
