Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Plan Description

The following brief description of the Village Associates, Inc. 401(k) Plan and Trust (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution pension plan covering substantially all employees of Village Associates, Inc. (Company) who have three months of eligible service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions

Participants may defer 100% of their compensation as a pre-tax or Roth contribution each year not to exceed the thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan is a Safe Harbor Plan with the Company contributing 100% of the first 3% and 50% of the next 2% of each participant's elective deferral percentage to the Plan as a matching contribution. The Company's matching contributions were \$765,388 and \$804,235 for the years ended December 31, 2024 and 2023, respectively. Additional amounts may be contributed at the option of the Company's board of directors. No additional amounts were contributed during 2024 and 2023.

Participant Accounts and Rollovers

Each participant's account is credited with the participant's contribution, an allocation of the Company's matching and profit sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's discretionary matching contributions plus actual earnings thereon. Vesting in the Company's non-elective contributions and earnings thereon vest under a graded vesting schedule becoming 20% vested after two years of employment until 100% vested after six years of service. A participant also becomes 100% vested upon death or becoming disabled.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant (or beneficiary in the case of death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount. If the value of the vested benefit is less than \$5,000, however, a lump-sum distribution will be made regardless of whether or not consent has been obtained from the participant. The Plan permits hardship distributions if certain criteria are met. The Plan permits in-service distributions at age 59 ½.

Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service from the Company before becoming 100% vested in the Company's non-elective contributions and related earnings. These forfeitures may be used to reduce Company nonelective contributions and matching contributions, or for plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,218 and \$2,340, respectively. For the years ended December 31, 2024 and 2023, no forfeitures were used.

Note 2 - Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or be paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement. The plan administrator determines the Plan's valuation utilizing information provided by the Plan's trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

Note 3 - Income Taxes

The Plan adopted the Capital Group Retirement Plan Services Defined Contribution Prototype Plan. The prototype plan received its latest favorable determination letter from the Internal Revenue Service dated June 30, 2020. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. Although the prototype plan has been amended since June 30, 2020, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (level 1 inputs).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related Party Transactions

Certain Plan investments are shares of funds managed by American Funds, a related entity of Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan. Edward Jones is the investment advisor of the Plan. Transactions with Capital Bank and Trust Company and Edward Jones qualify as party-in-interest transactions. Fees paid by the Plan to these parties-in-interest for the investment management and recordkeeping services to American Funds, and investment advisory services to Edward Jones, amounted to \$55,461 and \$62,441 for the years ended December 31, 2024 and 2023, respectively. Certain employees and officers of the Plan Sponsor, who are also participants in the Plan, perform administrative services to the plan at no cost to the Plan. Additional investment fees paid to the fund managers are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

American Funds provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and American Funds. American Funds receives revenue from mutual fund service providers for services American Funds provides to the funds. This revenue is used to offset certain amounts owed to American Funds for its administrative services to the Plan.

If the revenue received by American Funds from such mutual fund service providers exceeds the amount owed under the MSA, American Funds remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to American Funds for administrative expenses not covered by revenue sharing.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100 percent vested in their employer contributions.

Note 7 - Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan).

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities through mutual funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.
